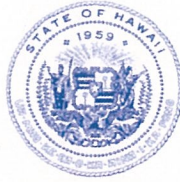

REQUEST:

Issuance of a Revocable Permit for Aircraft Parking (Parking Permit) to Dr. Timothy E. Kale situated at Ellison Onizuka Kona International Airport at Keāhole.

RECOMMENDATION:



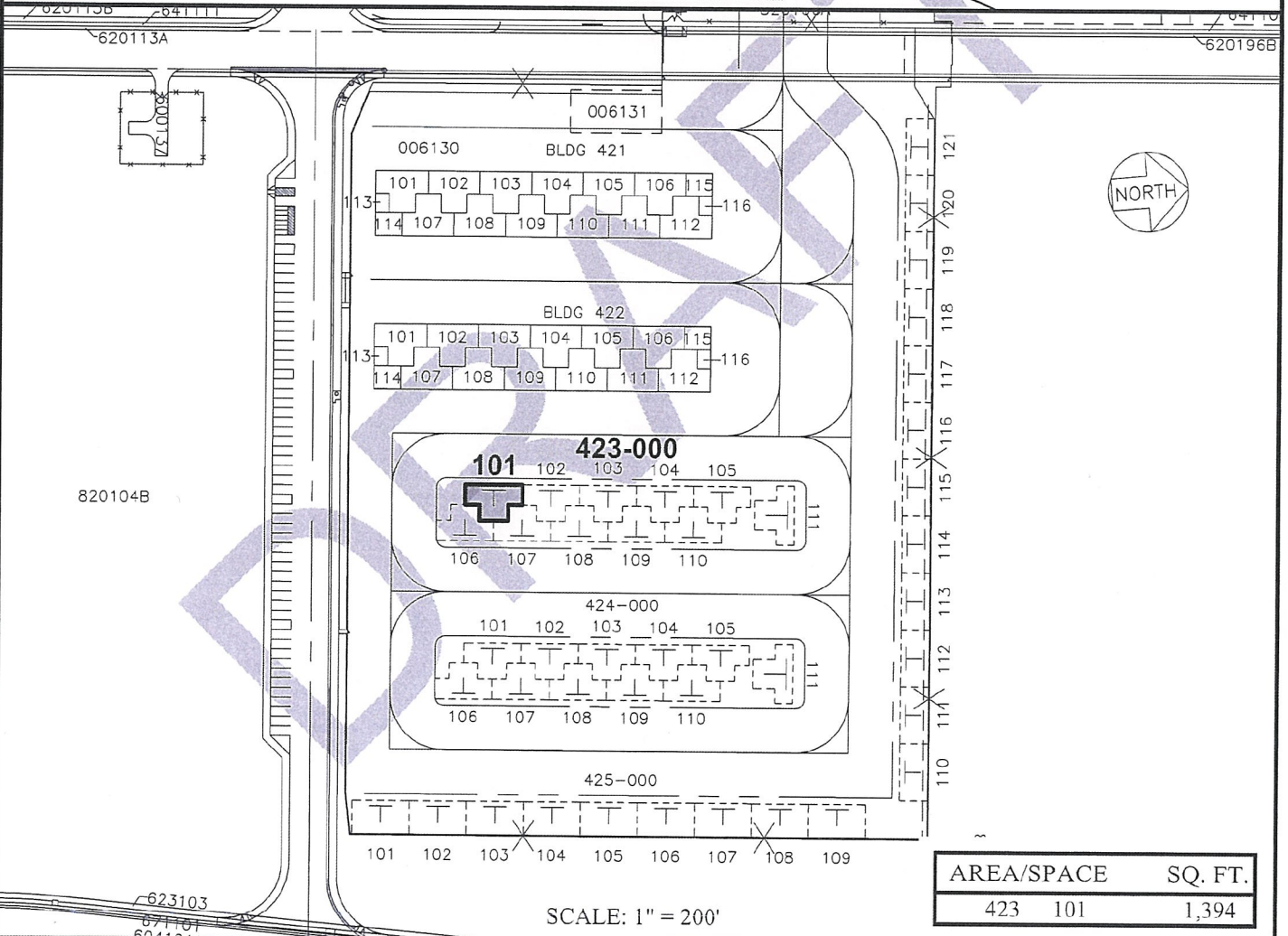
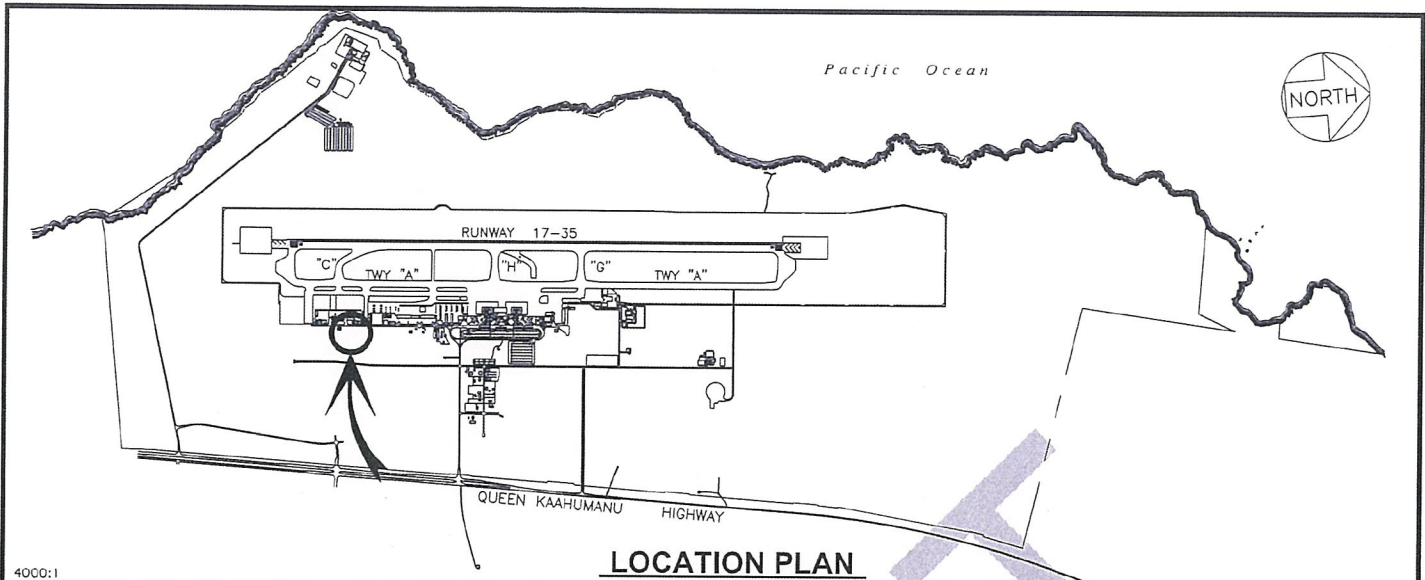
