CURRENT USE STATUS:

Land presently encumbered by Governor's Executive Order No. 3074, setting aside the Airport under the control and management of the Department of Transportation, Airports Division (DOTA), State of Hawai'i, for Airport Purposes.

Joseph Moran will use the space for storage and maintenance of aircraft (1992 Beech 58 N323LM).

Upon execution of the revocable permit.

MONTHLY RENTAL:

CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The State of Hawai'i, Department of Transportation, Airports Division (DOTA), has determined the subject land areas are covered by the Final Environmental Assessment (EA)/Finding of No Significant Impact (FONSI), Airfield, Terminal, and Facility Improvements for the Kona International Airport at Keāhole, published by the Office of Environmental Quality Control (OEQC) in the March 23, 2013, issue of The Environmental Notice. Accordingly, all relevant mitigation from the EA and best management practices will be implemented to address the minimum impacts of this action.

RECOMMENDATION:



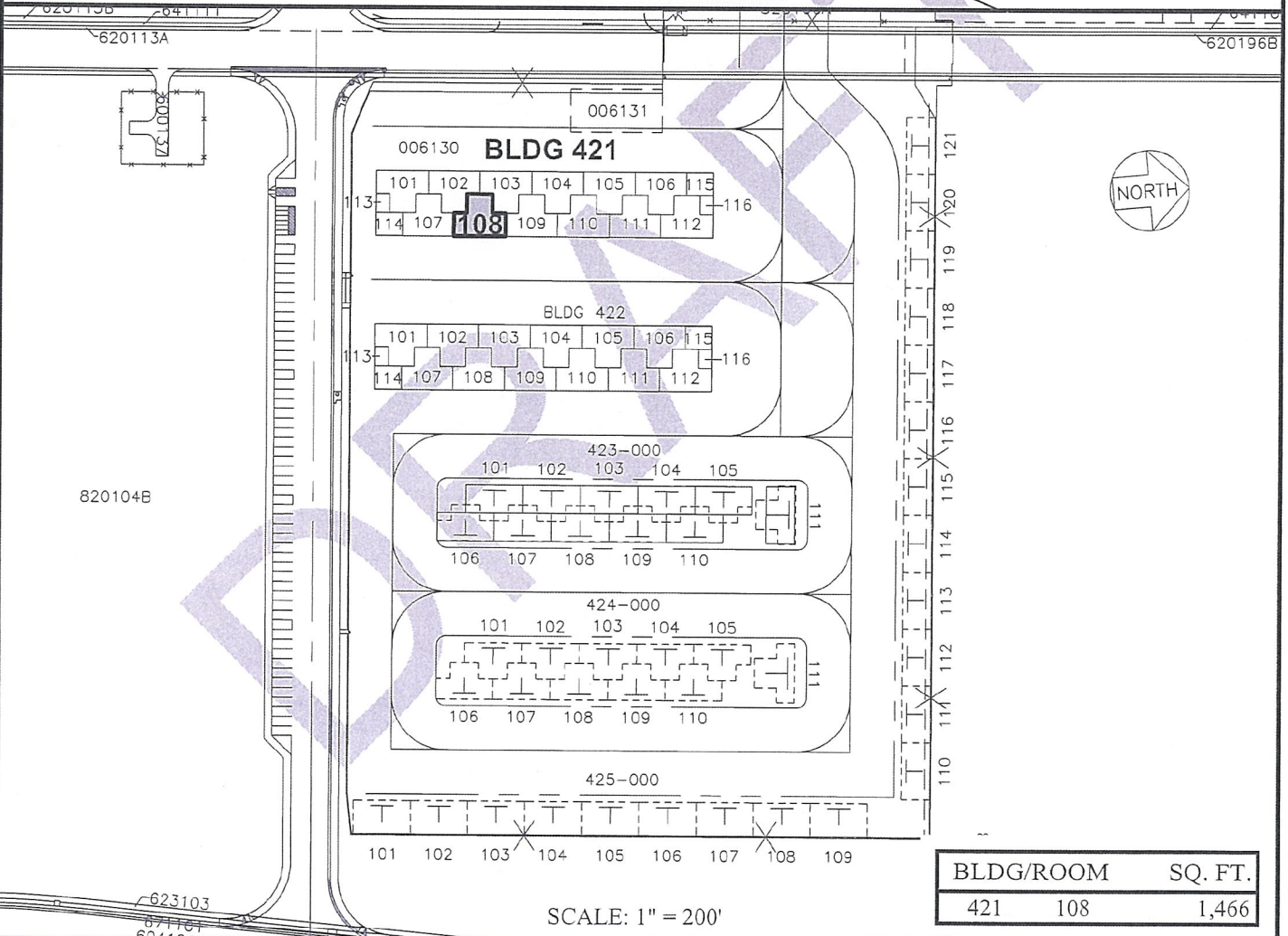
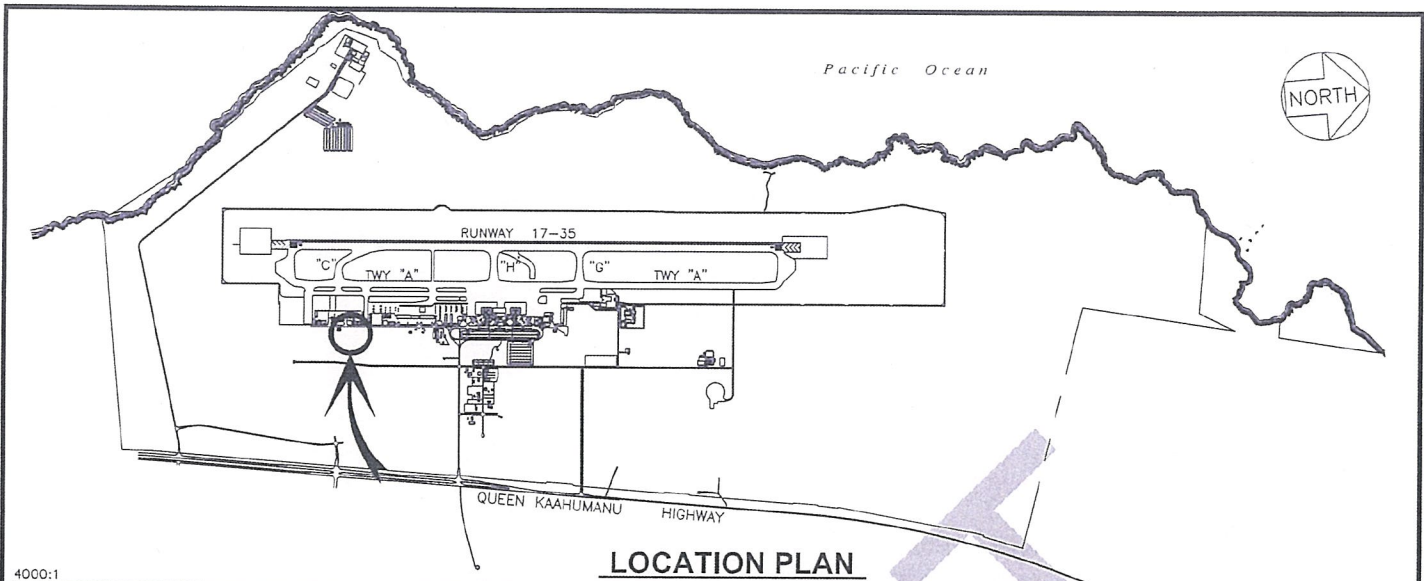
