REQUEST:

Issuance of a Revocable Permit for Aircraft Parking (Parking Permit) to Southern Airways Express, LLC for four (4) aircraft tie-down spaces situated at Ellison Onizuka Kona International Airport at Keāhole.

Southern Airways Express, LLC, whose business address is 101 N. Riverside Drive, Suite 211, Pompano Beach, Florida 33062.

Four (4) aircraft tie-down spaces for various aircraft.

CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The State of Hawai'i, Department of Transportation, Airports Division (DOTA), has determined the subject land areas are covered by the Final Environmental Assessment (EA)/Finding of No Significant Impact (FONSI), Airfield, Terminal, and Facility Improvements for the Kona International Airport at Keāhole, published by the Office of Environmental Quality Control (OEQC) in the March 23, 2013, issue of The Environmental Notice. Accordingly, all relevant mitigation from the EA and best management practices will be implemented to address the minimum impacts of this action.


REMARKS:

RECOMMENDATION:



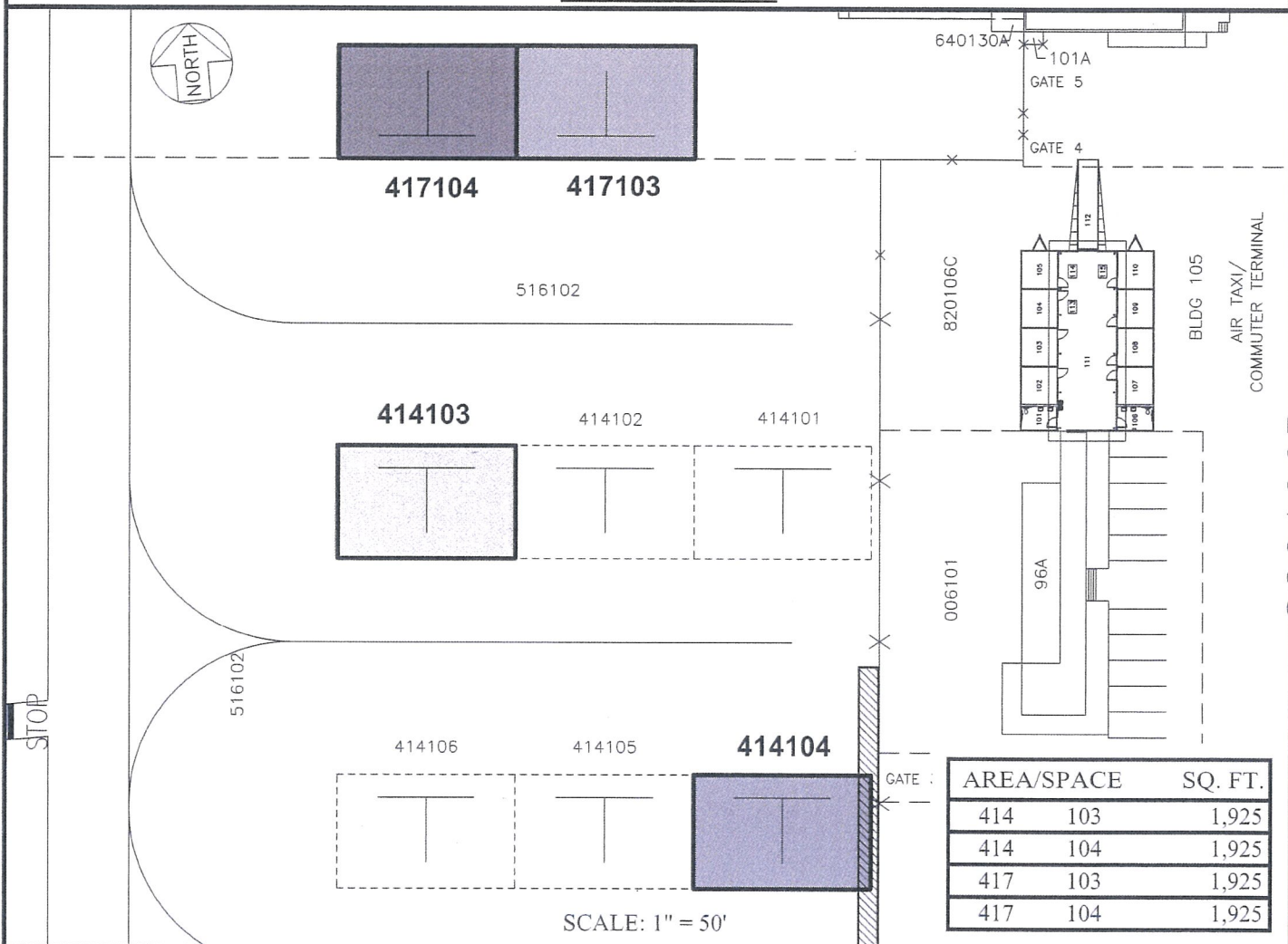
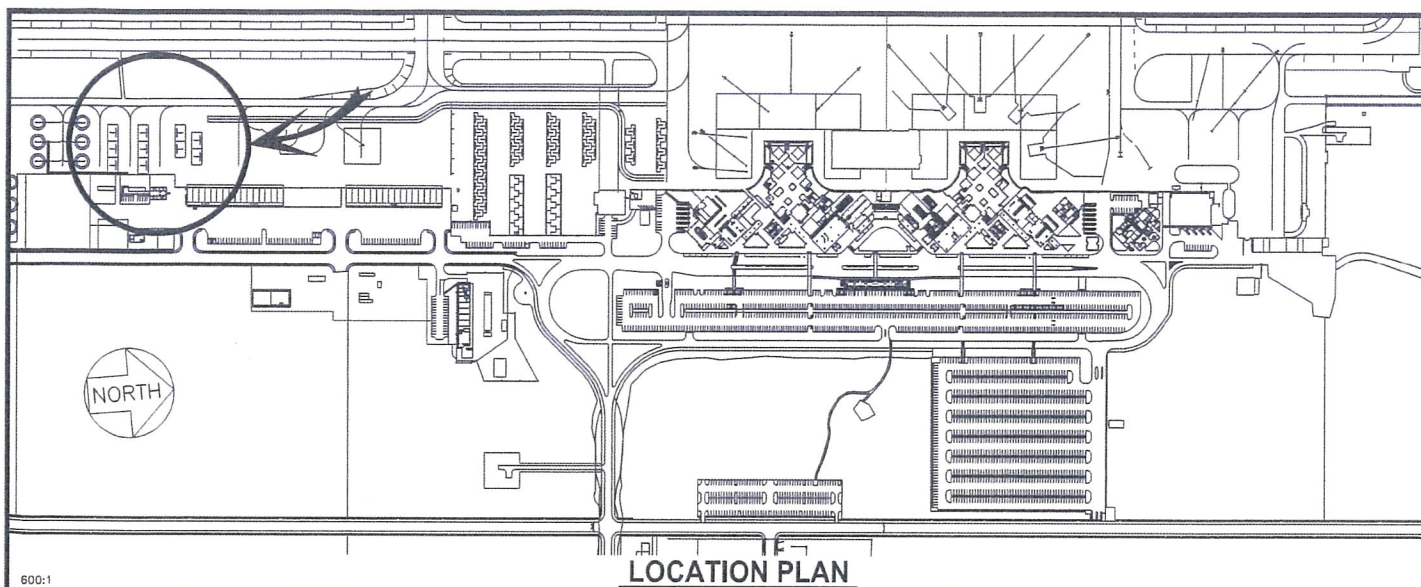
