REQUEST:

Issuance of a Revocable Permit for Aircraft Parking (Parking Permit) to Southern Airways Express, LLC for three (3) aircraft tie-down spaces situated at Kahului Airport.

Three (3) aircraft tie-down spaces for various aircraft.

COMMENCEMENT DATE:

Upon execution of the revocable permit.

MONTHLY RENTAL:

\$428.00 (\$126.00 per tie-down for two (2) small tie-down spaces and \$176.00 for one (1) large tie-down space, as determined from the Department of Transportation, Airports Division schedule of rates and charges established by appraisal of Airports property statewide).

SECURITY DEPOSIT:

\$1,284.00, or three (3) times the monthly rental in effect.

CHAPTER 343. HRS - ENVIRONMENTAL ASSESSMENT:

The State of Hawaii, Department of Transportation, Airports Division, has determined that the environmental impacts for the subject land use is covered by the Kahului Airport Improvements Final Environmental Impact Statement (EIS), published by the Office of Environmental Quality Control (OEQC) in the October 23, 1997, issue of The Environmental Notice. The EIS was accepted by the Governor on February 18, 1998. Accordingly, all relevant mitigation from the EIS and best management practices will be implemented to address the minimum impacts of this action.

REMARKS:

In accordance with Section 171-55, HRS, relating to Permits, the Department of Transportation proposes to issue a month-to-month Parking Permit to Southern Airways Express, LLC for three (3) aircraft parking spaces for their commercial airline carrier operations at OGG.

RECOMMENDATION:



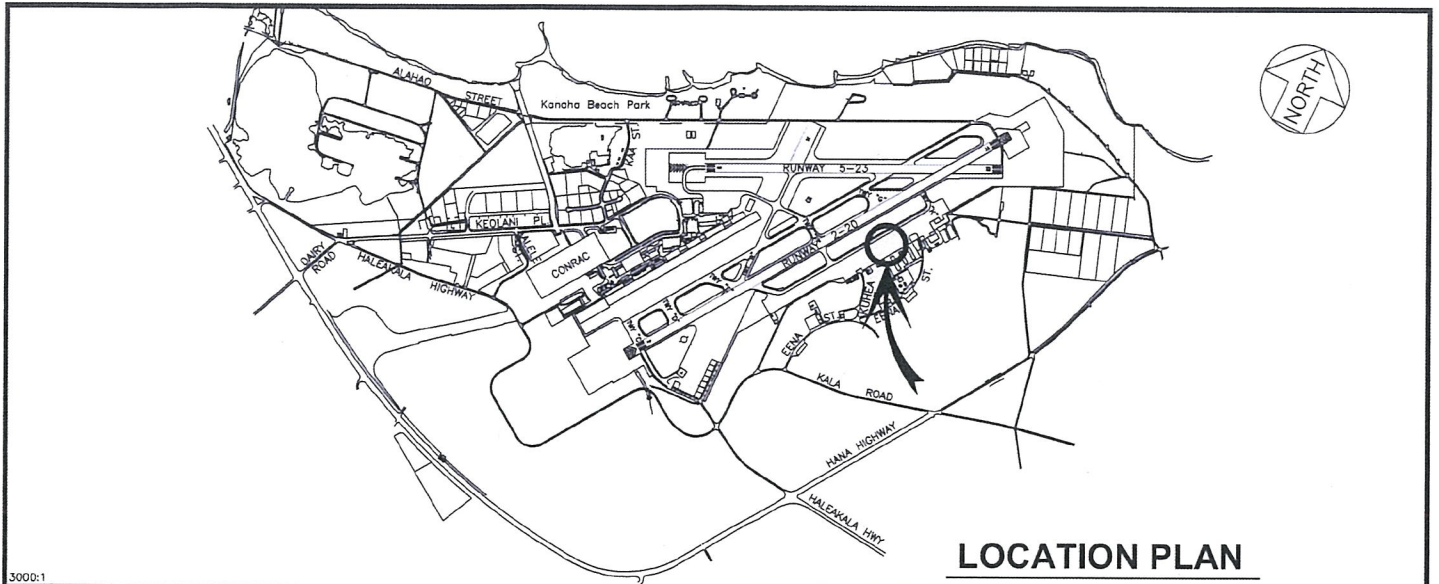

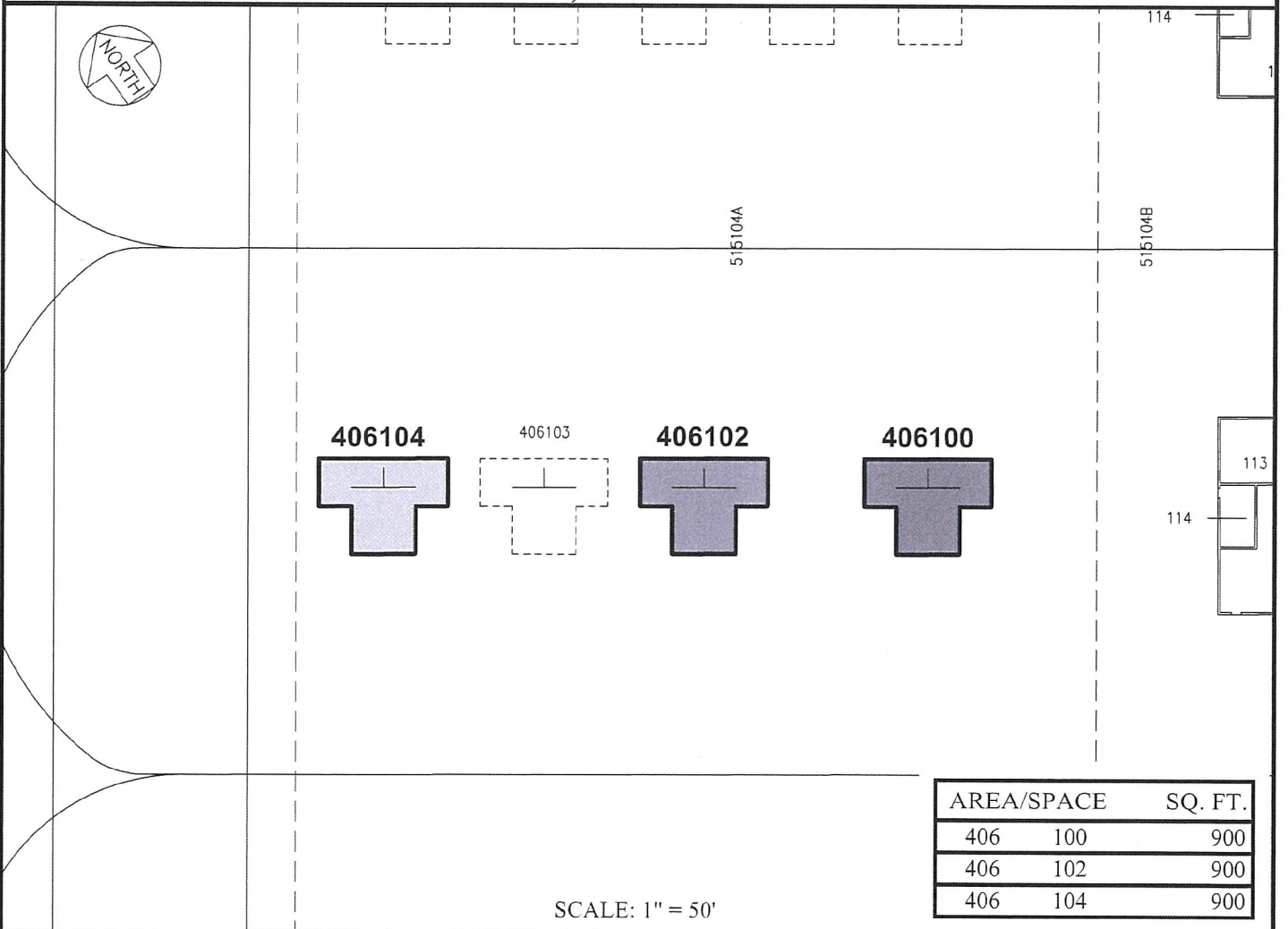
