The West Hawaii Fishery Management Area was developed with significant input from all parties, including the environmental community as well as Native Hawaiians.

The Proposed Action is an overall reduction in take over the Pre-Aquarium Collection Ban alternative. Although I felt the fishery was sustainable in the past, a common critique is that there are no limits. Reducing catches by approving only the seven proposed permits is a practical approach to address this concern. This will ensure the vitality and sustainability of the West Hawaii Fishery while addressing the critics.

Enforcement has always been another talking point of those opposed to any fishery. By issuing seven permits, the fishermen can easily self-police as they know who is permitted to legally fish. The limitation on the number of permits also assists DOCARE/enforcement as they will easily know who is legally allowed to fish by the limited number of boats which are registered.

We have assessed the associated material and make the following conclusions:

This is the result of a highly rigorous study, utilizing a high resolution of data over twenty plus years of monitoring. The preferred alternative is sustainable, only allowing take of species proven stable and increasing in local population sizes.

The total allowable catch set out in the table below represents a relatively low impact on local populations according to the data in the EIS. The use of slot limits for harvesting is welcome, as this protects large fecund individuals in the population (of which there is no market demand for) to preserve high levels of recruitment which is essential to the resilience of fish stocks. The use of this method of size regulation is well documented in other fisheries as a more sustainable alternative of fisheries management (Arlinghaus, Matsumura and Dieckmann, 2010; Gwinn *et al.*, 2015). It is also worth noting that the allowable take is an overall reduction from historic averages to ensure a buffer for climate change. In addition, the provision of nearby no-take-zones will also preserve recruitment and local migration to increase the resilience of the ornamental fishery in Hawaii (Roberts, Hawkins and Gell, 2015).


