#### LOCATION AND TAX MAP KEY:

## **CURRENT USE STATUS:**

Land presently encumbered by Governor's Executive Order No. 2427, dated February 12, 1969, setting aside 1,268.938 acres designated as Kahului Airport to be under the control and management of the State of Hawai'i, Department of Transportation for public purposes.

### CHARACTER OF USE:

KAI will use the spaces for offices and counters to service customers picking up or dropping off cargo shipments, and accepting carriage for Federal Aviation Administration personnel, animal handlers, hazmat handlers and law enforcement officers in the Commuter Terminal, as part of its Air Transportation Operations.

#### **COMMENCEMENT DATE:**

Upon complete execution of the revocable permit.

## MONTHLY RENTAL:

\$2,458.52 (\$2,004.38, as determined from the Department of Transportation, Airports Division schedule of rates and charges established by appraisal of Airports property statewide, plus \$327.99 for utilities and \$126.15 for maintenance).

#### **SECURITY DEPOSIT:**

\$7,375.56, or three (3) times the monthly rental in effect.

#### CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The State of Hawaii, Department of Transportation, Airports Division (HDOT-A), has determined that the subject land area and use is covered by the Kahului Airport Terminal Complex Expansion Negative Declaration, published by the Environmental Quality Commission (EQC) in the September 8, 1981, issue of the EQC Bulletin. Accordingly, all relevant mitigation from the Negative Declaration and best management practices will be implemented to address the minimum impacts of this action.

#### REMARKS:

In accordance with Section 171-55, HRS, relating to <u>Permits</u>, the Department of Transportation proposes to issue a month-to-month revocable permit to KAI for office and counter space to service customers picking up or dropping off cargo shipments, and accepting carriage for Federal Aviation Administration personnel, animal handlers, hazmat handlers and law enforcement officers in the Commuter Terminal, as part of its Air Transportation Operations at OGG.

## **RECOMMENDATION:**

That the Board authorize the Department of Transportation to issue a month-to-month revocable permit to KAI, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.
