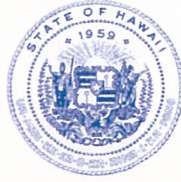

REMARKS:

The Department of Transportation proposes to issue a permit to Rider Levett Bucknall Ltd. for the use of the space for a construction field office, free of rent, as specifically stated under Contract No. 68996, State Project No. AO1037-31, HNL Restroom Improvements - Phase II, Daniel K. Inouye International Airport, Honolulu, Hawai'i. Section 1.11 – Provisions for Field Office/Storage Space: “Pending the availability of space on airport property, the STATE will issue a permit to the CONTRACTOR for the use of the space, at no charge, to be used specifically for a field office and/or storage of materials and equipment....”

RECOMMENDATION:



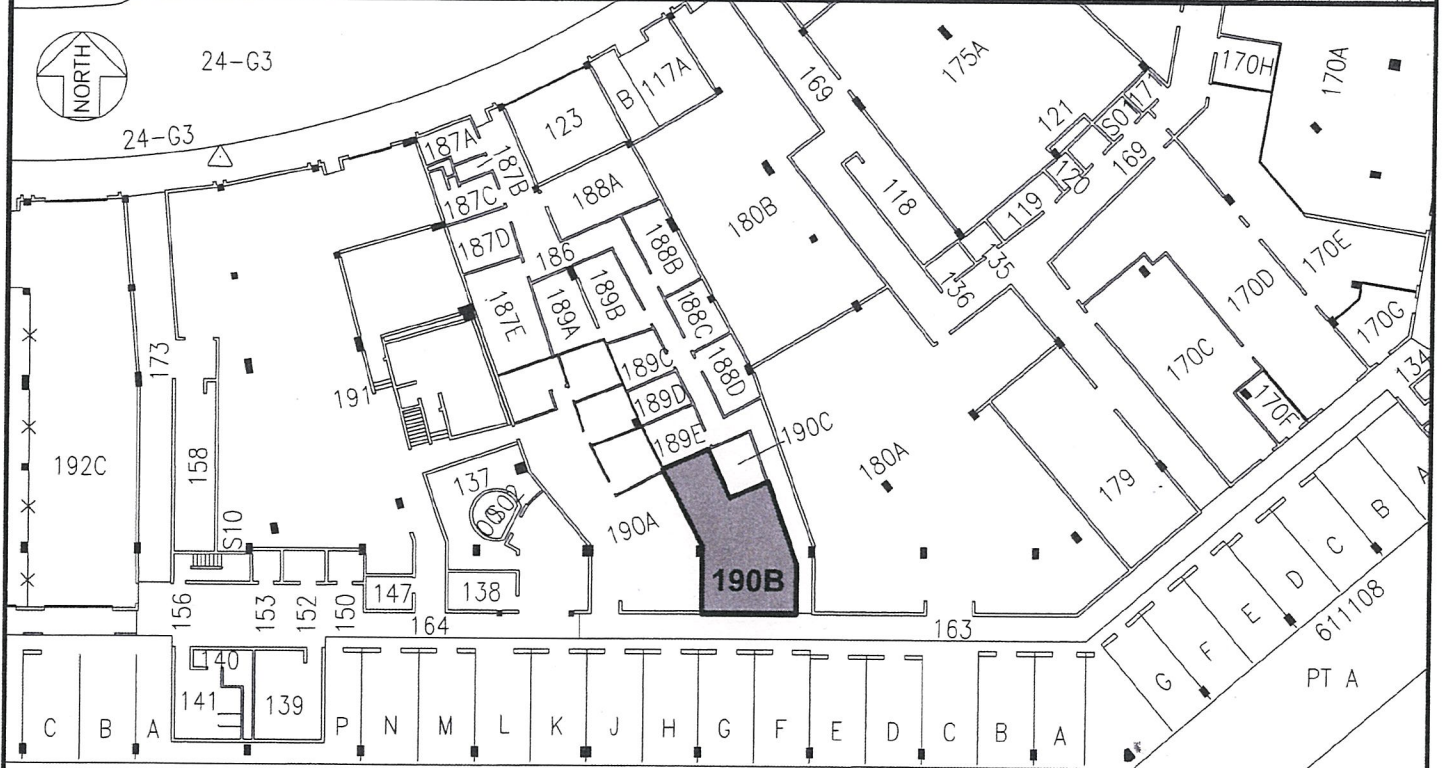
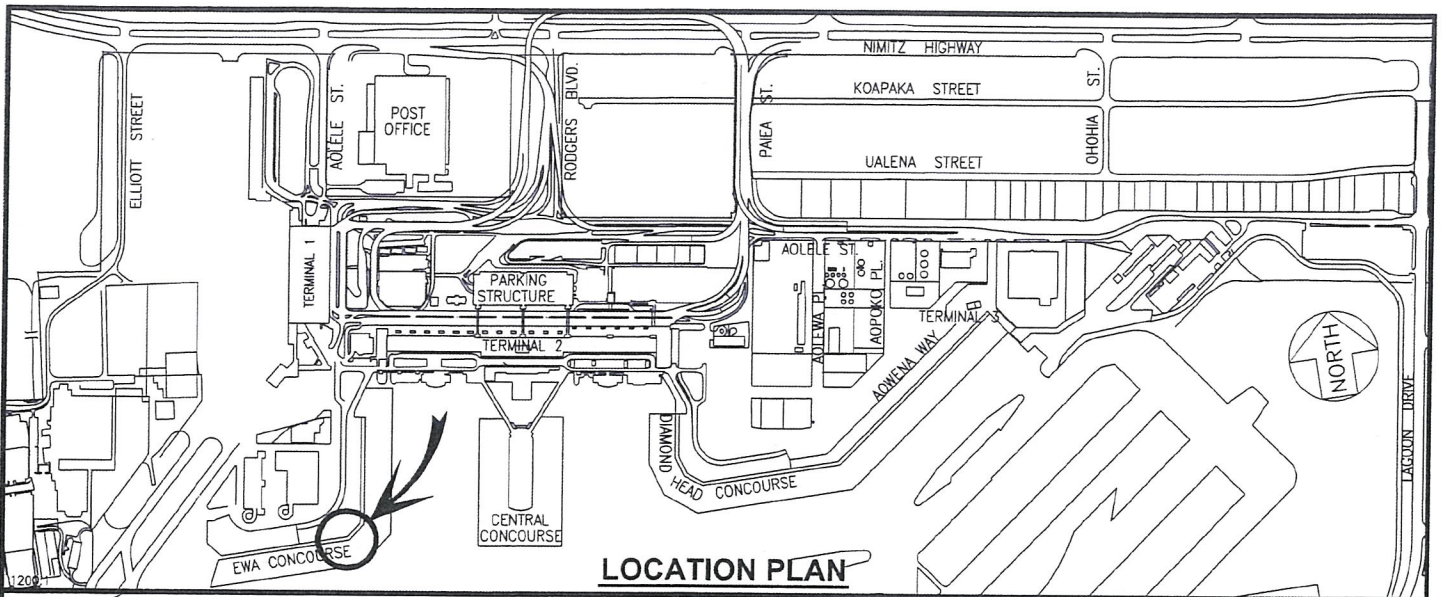
