### REQUEST:

Issuance of a Revocable Permit for Aircraft Parking (Parking Permit) to Flying Mermaid, LLC, situated at Daniel K. Inouye International Airport.

### LEGAL REFERENCE:

Section 171-55, Hawai'i Revised Statutes.

### APPLICANT:

Flying Mermaid, whose mailing address is 98-835 Ainanui Loop, Aiea, Hawai'i 96701.

#### LOCATION:

A portion of Daniel K. Inouye International Airport, identified as South Ramp, identified by Tax Map Key: 1<sup>st</sup> Division, 1-1-76: portion of 23.

#### AREA:

## **CURRENT USE STATUS:**

Land presently encumbered by Governor's Executive Order No. 3201, dated June 8, 1983, setting aside 3,152.177 acres designated as Daniel K. Inouye International Airport under the control and management of the State of Hawai'i, Department of Transportation, Airports Division (DOTA) for Airport Purposes.

### CHARACTER OF USE:

Four (4) aircraft tie-down spaces for various aircraft.

#### **COMMENCEMENT DATE:**

To be determined by the Director of Transportation at a later date.

#### MONTHLY RENTAL:

\$504.00 (as determined from the DOTA schedule of rates and charges established by appraisal of Airports property statewide).

#### **SECURITY DEPOSIT:**

\$1,512.00, or three (3) times the monthly rental in effect

# CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The environmental impacts of the proposed action to the subject land area is covered by the Honolulu International Airport Master Plan Update and Noise Compatibility Program Environmental Assessment (EA), State Project No. AO1011-033. The EA is a joint State and Federal document, dated September 1989 and published in the October 23, 1989 issue of the OEQC Bulletin. Accordingly, relevant mitigation from the EA and DOT-A environmental best management practice will address minimal impacts from this action.

# **REMARKS**:

The issuance of a Parking Permit to Flying Mermaid, LLC for aircraft parking at Daniel K. Inouye International Airport complies with Chapter 343, Exemption Class 1.D.10 as a continuing aeronautical use, and is in accordance with Section 171-55 HRS, relating to Permits.

### **RECOMMENDATION:**

That the Board authorize the Department of Transportation to issue a month-to-month Parking Permit to Flying Mermaid, LLC, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.
