REMARKS:

In accordance with Section 171-55, HRS, relating to <u>Permits</u>, the Department of Transportation proposes to issue a month-to-month revocable permit to Nan for storage of equipment and materials, free of rent, as specifically stated in Contract No. 67549, State Project No. AH2062-15, KOA Federal Inspection Services Building, Kona International Airport at Keāhole, Section 1.04 - <u>Provisions for Field Office/Storage Space</u>: "Pending the availability of space on airport property, the State will issue a permit to the Contractor for the use of the space, at no charge, to be used specifically for a field office and/or storage of materials and equipment...."

RECOMMENDATION:

That the Board authorize the Department of Transportation to issue a month-to-month revocable permit to Nan, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.
