REQUEST:

Issuance of a Revocable Permit for Aircraft Parking (Parking Permit) to K & S Helicopters, Inc., for two (2) aircraft tie-down spaces situated at Hāna Airport.

LEGAL REFERENCE:

Section 171-55, Hawai'i Revised Statutes (HRS).

APPLICANT:

K & S Helicopters, Inc. (K&S), whose mailing address is 73-341 U'u Street, Kailua-Kona, Hawai'i 96740.

LOCATION AND TAX MAP KEYS:

Hāna Airport (HNM), Island of Maui, identified by Tax Map Key: 2nd Division, 1-3-003: portion of 022 and 2nd Division, 1-3-003: portion of 036.

AREAS:

Area/Space No. 515-102, containing an area of approximately 975 square feet, and Area/Space No. 515-104, containing an area of approximately 975 square feet, as shown and delineated on the attached Exhibit A.

CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The Department of Transportation (DOT) has determined that the minimal impacts of this action are exempt, pursuant to Hawai'i Administrative Rules, Section 11-200.1-16 (b); the impacts of leasing space on an existing paved area are de minimis.

REMARKS:

In accordance with Section 171-55, HRS, relating to <u>Permits</u>, the Department of Transportation proposes to issue a month-to-month Parking Permit to K&S for two (2) aircraft parking at HNM.

RECOMMENDATION:

That the Board authorize the Department of Transportation to issue a month-to-month Parking Permit to K&S, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.
