### **CURRENT USE STATUS:**

Land presently encumbered by Governor's Executive Order No. 2427, dated February 12, 1969, setting aside 1,268.938 acres designated as Kahului Airport to be under the control and management of the State of Hawai'i, Department of Transportation for public purposes.

# **CHARACTER OF USE:**

TSA will use the office space for administration purposes.

#### **COMMENCEMENT DATE:**

Upon complete execution of the revocable permit.

#### MONTHLY RENTAL:

\$1,630.56 (\$1,256.10, as determined from the DOTA schedule of rates and charges established by appraisal of Airports property statewide, plus \$118.50 for air conditioning, \$184.86 for utilities and \$71.10 for maintenance).

#### CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The State of Hawaii, Department of Transportation, Airports Division (HDOT-A), has determined that the subject land area and use is covered by the Kahului Airport Terminal Complex Expansion Negative Declaration, published by the Environmental Quality Commission (EQC) in the September 8, 1981, issue of the EQC Bulletin. Accordingly, all relevant mitigation from the Negative Declaration and best management practices will be implemented to address the minimum impacts of this action.
