Position Organization Chart

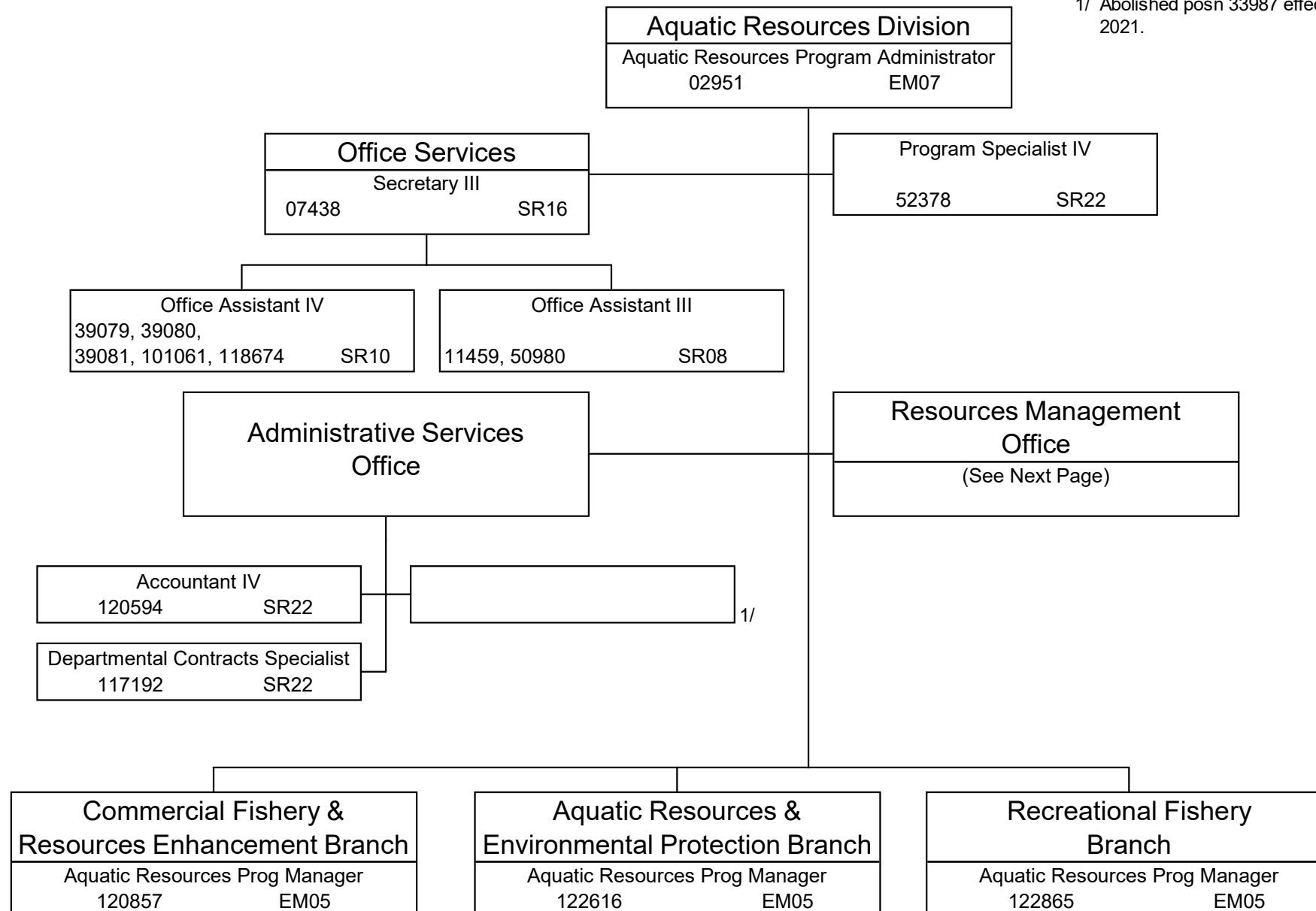
