Aina Based learning environment for at-risk youth population utilizing horticulture approach purposes.

This request is seeking a lease covering the time period up to twenty-five (25) years that will allow PIDF to continue its purpose of providing social services for youth at-risk with opportunities through its Kupa Aina Farms program that develops sustainable food production models and provides cultural aina-based experiential learning and treatment for the participating at-risk youth. The lease will allow PIDF to market the produce and beef of PIDF, Kupa Aina Farms and use the profits to manage and maintain the farm which at will provide stability of PIDF to actively pursue programmatic and capital improvement resources to assure sustainability of Kawailoa Campus programming.

REMARKS:

Governor's Executive Order No. ("EO") 172 was issued in 1924 to the Board of Industrial Schools for Girls Industrial School purposes. In 1937, EO 784 covering the spring reserve and the associated pipeline easement was issued to the same agency, which served as the water supply to the facility under EO 172. Currently, OYS under the Department of Human Services is the agency, pursuant to Chapter 352, HRS, responsible for the administration of the facility.

The Juvenile Justice System in Hawai'i, under jurisdiction of the family court, is moving from an outdated punitive approach towards a variety of evidence-based intervention systems, including trauma-informed care, family engagement, gender-responsive and culturally competent services. This follows a nationwide juvenile justice reform that is finally recognizing the high failure rates of incarceration without proper treatment.

In 2018, the State Legislature passed Act 208 creating the Kawailoa Youth and Family Wellness Center, which was codified into chapter 352D, HRS. Section 352D-7.5(a), HRS, provides, "the office of youth services may create and develop a central youth service center known as the Kawailoa youth and family wellness center at the site of the Hawaii youth correctional facilities"

In addition, section 352D-7.5(d), HRS, describes "The Kawailoa youth and family wellness center services and programs may include but shall not be limited to mental health services and programs, substance abuse treatment programs, crisis shelters for homeless youth, crisis shelters for victims of human and sex trafficking, vocational training, group homes, day treatment programs, aftercare, independent and family counseling services, educational services, and other services and programs that may be required to meet the needs of youth or young adults."

In partnership with OYS, PIDF will utilize ten (10) acres (pasture #2 and #3A) as shown on Exhibit A2 as a pilot for Korean Natural farming to create an `Āina-based learning environment for at-risk youth populations. Mental Health treatment and vocational skills will be conducted as well.

OYS is requesting consent from the Board to issue a direct lease to PIDF, Kupa Aina Farms. This request is to allow PIDF the ability to market the product and beef of Kupa Aina Farms and use the profits to manage and maintain the farm. This would allow for stability of PIDF to actively pursue programmatic and capital improvement resources to assure sustainability of on-campus programming.

RECOMMENDATIONS:

- 1. Declare that, after considering the potential effects of the proposed disposition as provided by chapter 343, HRS, and chapter 11-200, HAR this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
- 2. Consent to the lease between the Department of Human Services, Office of Youth Services and Partners in Development Foundation described above, subject to any applicable conditions cited above which are by this reference incorporated herein and further subject to the following.
 - a. The standard terms and conditions of the most current non-profit lease document form as may be amended, as appropriate;
 - b. Review and approval by the Department of the Attorney General; and
 - c. Such other terms and conditions as may be prescribed by the Director of Human Services to best serve the interests of the State.
