TERM OF RIGHT-OF-ENTRY:

One year from the date of signed right-of-entry agreement.

CONSIDERATION:

Gratis.

CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

In accordance with Hawaii Administrative Rules (HAR)§ 11-200.1-16 (a)(1) and the Exemption List for the Department of Land and Natural Resources reviewed and concurred on by the Environmental Council on November 10, 2020, the subject request is exempt from the preparation of an environmental assessment pursuant to Exemption Class No. 1, which states, "Operations, repairs or maintenance of existing structures, facilities, equipment or topographical features, involving negligible or no expansion or change of use beyond that previously existing." Part 1, Item 44 that states, "Permits, licenses, registrations, and rights-of-entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing." (Exhibit B)

DCCA VERIFICATION:

The applicant is a government entity and therefore not required to register with the DCCA.

APPLICANT REQUIREMENTS:

Applicant shall be required to:

1) Obtain written concurrence from all users of the subject land.

REMARKS:

The County of Hawaii, Department of Public Works (DPW) is requesting a right-of-entry through the subject property for the Waiākea/Wailoa Stream Flood Control Project. The requested duration of the right-of-entry is approximately one year from the date of signed right-of-entry agreement.

The purpose of the Waiākea/Wailoa Stream Flood Control Project is to repair damages sustained from the 2018 Hurricane Lane event. The access will allow the contractor to get equipment to an area of the stream that is otherwise inaccessible with the particular type of equipment needed for the repair work. This project is being funded by the United States Army Corps of Engineers.

The State land is currently encumbered under General Lease No. S-5335 to Hilo Baptist Church for church and related purposes. The Lessee has been notified by the DPW regarding this request and is agreeable to the right-of-entry (Exhibit C).

As this is a government related project designed to restore the flood control stream, staff is recommending the Board waive any fees and provide this right-of-entry gratis.

A request for comments was sent to various State, County and Federal agencies with no objection for the proposed right-of-entry request.

RECOMMENDATION:

That the Board, subject to the Applicant fulfilling the Applicant Requirements above, authorize the issuance of a right-of-entry permit to the County of Hawaii, Department of Public Works covering the subject area under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:

- 1. The standard terms and conditions of the most current right-of-entry permit form, as may be amended from time to time;
- 2. Waive any fees and provide this right-of-entry gratis; and
- 3. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.



DPW Right-of-entry – GL S-5335, South Hilo, Hawaii




