REMARKS:

In accordance with Section 171-55, HRS, relating to <u>Permits</u>, the DOT proposes to issue a month-to-month revocable permit to GGP, for equipment and material staging at no charge, as stated in State Project No. AM4022-16R, Reconstruct Runway 3-21, Lāna'i Airport, Lāna'i, Hawai'i, Section 1.4A., <u>Provisions for Field Office/Storage and Space</u>: "Pending the availability of space on airport property, the State will issue a permit to the Contractor for the use of the space, at no charge, to be used specifically for a field office and/or storage of materials and equipment..."

RECOMMENDATION:

That the Board authorize the Department of Transportation to issue a month-to-month revocable permit to GGP, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.
