CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The environmental impacts of the proposed action to the subject land area are covered by the Honolulu International Airport, Airport Modernization Program Environmental Assessment (EA), State Project No. AO1030-13. The EA is a joint State and Federal document dated, January 2013, and published in the February 8, 2013 issue of the OEQC Bulletin. Accordingly, the actions have been determined to have little or no impact upon the environment.

REMARKS:

The Department of Transportation proposes to issue a permit to Kiewit Infrastructure West Co. for the use of the spaces for vehicle parking and construction staging area, free of rent, as specifically stated under Contract No. 69949, State Project No. AO1021-27, Runway 8L Widening, Phase 2, Daniel K. Inouye International Airport, Honolulu, Hawai'i. Section 1.04 –Provisions for Field Office/Storage and Space: “Pending the availability of space on airport property, the State will issue a permit to the Contractor for the use of the space, at no charge, to be used specifically for a field office and/or storage of materials and equipment....”

RECOMMENDATION:



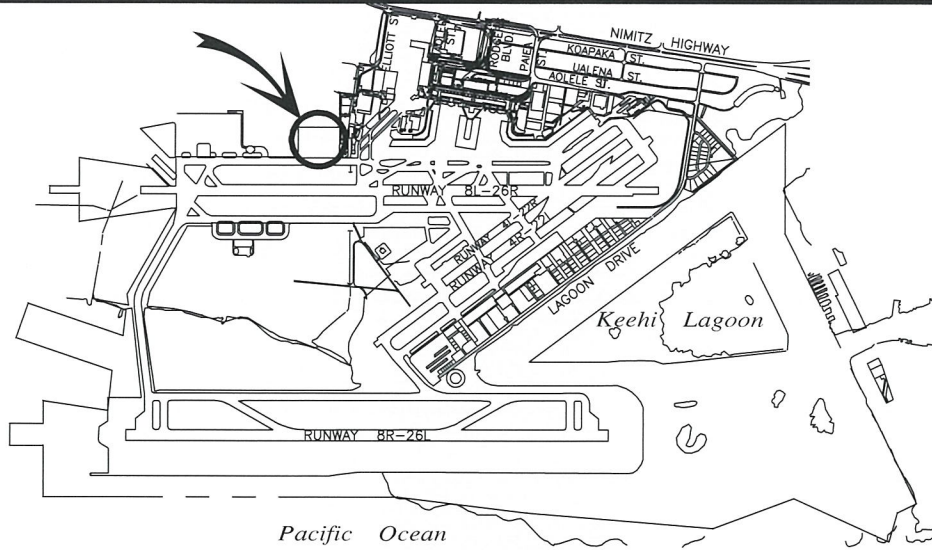

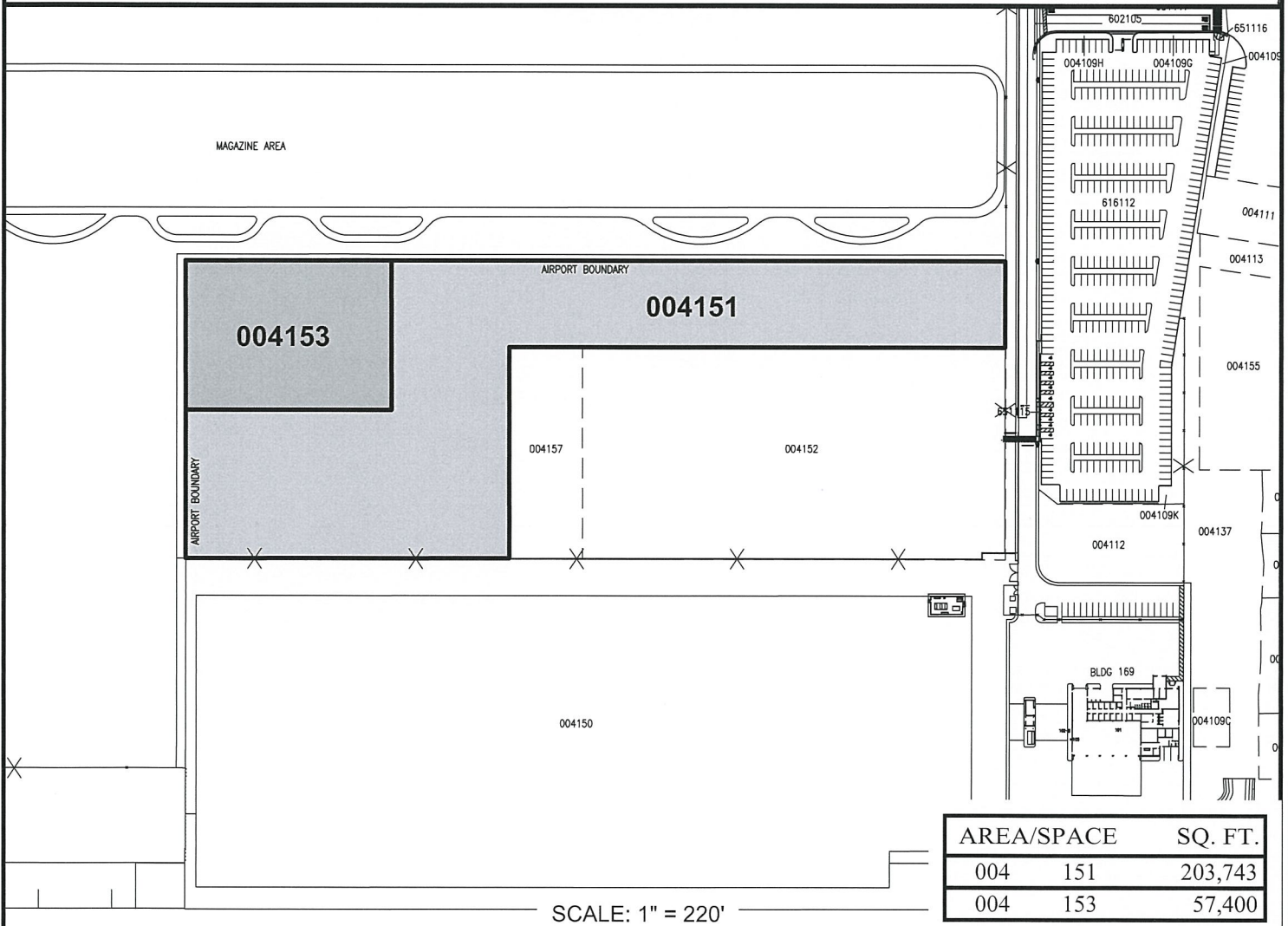
