REQUEST:

Issuance of a Revocable Permit for Aircraft Parking (Parking Permit) to Guardian Flight LLC at Moloka'i Airport (MKK).

LEGAL REFERENCE:

Section 171-55, Hawai'i Revised Statutes (HRS).

APPLICANT:

Guardian Flight LLC (GFL), whose business address is 150 Lagoon Drive, Honolulu, Hawai'i 96819.

LOCATION AND TAX MAP KEY:

Portion of Moloka'i Airport (MKK), Hoolehua, Island of Moloka'i, County of Maui, identified by Tax Map Key: 2nd Division, 5-2-04: Portion of 08.

AREA:

Area/Space No. 406-107, containing an area of approximately 2,030 square feet, as shown and delineated on the attached Exhibit A.

CURRENT USE STATUS:

Land presently encumbered by Governor's Executive Order No. 1019, dated May 10, 1943, setting aside 153.270 acres designated as Moloka'i Airport to be under the control and management of the State of Hawai'i, Department of Transportation for Public Purposes.

CHARACTER OF USE:

Aircraft tie-down (Raytheon C90, N-1083S).

GFL has 9 other aircraft (Beech C90, N-948AM, Beech C90, N-947AM, Raytheon C90, N-770VF, Raytheon C90, N-438CA, Raytheon C90, N-60VP, Raytheon C90, N-299RP, Raytheon C90, N-13GZ, Raytheon C90, N-902TS, and Beech C90, N-587PB) stationed at other DOTA airports, that are rotated based on flight time and may be parked in the tie-down as needed for its air ambulance operation at MKK.

COMMENCEMENT DATE:

Upon execution of the Parking Permit.

MONTHLY RENTAL:

\$90.00 (as determined from the Department of Transportation, Airports Division schedule of rates and charges established by appraisal of Airports property statewide).

SECURITY DEPOSIT:

\$270.00, or three (3) times the monthly rental in effect.

CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The State of Hawai'i, Department of Transportation, Airports Division has determined that the impacts of this action are de minimis and exempt, pursuant to <u>Department of Transportation</u>, Comprehensive Exemption List, Type 8, Part 1, 8(h), concurred to by the Environmental Advisory Council on February 1, 2022.

REMARKS:

In accordance with Section 171-55, HRS, relating to <u>Permits</u>, the Department of Transportation proposes to issue a month-to-month Parking Permit to GFL for aircraft parking as part of its air ambulance operation at MKK.

RECOMMENDATION:

That the Board authorize the Department of Transportation to issue a month-to-month Parking Permit to GFL, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.
