CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

In accordance with Section 11-200.1-15, Hawaii Administrative Rule (HAR), and the Exemption List for the Department of Land and Natural Resources reviewed and concurred by the Environmental Council on November 10, 2020, the subject request is exempt from the preparation of an environmental assessment pursuant to General Exemption Type 1, Part 1, Item 44, which states the "Permits, licenses, registrations, and rights-of-entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing". The subject request is a de minimis action that will probably have minimal or no significant effect on the environmental and should be declared exempt from the preparation of an environmental assessment and the requirements of § 11-200.1-17, HAR. See Exhibit 2.

REMARKS:

The Waikiki Roughwater Swim Committee, Inc. (WRSC) requests the issuance of a right-ofentry permit to use selected areas of the Duke Kahanamoku Beach for the finish of their 51.2 Annual Waikiki Roughwater Swim race event. The event is scheduled for Monday, September 5, 2022. Equipment will be set-up on the permitted beach areas starting from 5:30 a.m. and torn down by 1:30 p.m. Applicant has submitted a map delineating the selected beach areas requested for use relating to the subject event (See **Exhibit 3**). A ropedoff, finish line area (approximately 900 square feet) near the shoreline of Duke Kahanamoku Beach fronting the Hilton Hawaiian Village Hotel will contain the timing equipment, an announcer's table, and an area to remove race chips from the finished swimmers. WRSC is also requesting the use of an additional 700 square feet of beach area to the east of the finish line for the setting up of seven 10'x10' tents. The seven tents will be for the medical doctor, first aid, water station, ice tent, T-shirt distribution, bag tent, and information station (see Exhibit 3). All tents will be spaced at least 20 feet apart to allow public access between adjacent tents. The right-of-entry permit request includes the use of a total amount of 1,600 square feet of beach area.

Staff understands the Applicant is obtaining permits from the City and County of Honolulu, Department of Parks and Recreation for the race's starting-line segment located near the Natatorium, and the Division of Boating and Ocean Recreation for the off-shore segment of the race.

Office of Conservation and Coastal Lands has no objections on the request.

The applicant has not had a lease, permit, easement or other disposition of State lands terminated within the past five years due to non-compliance with such terms and conditions.

RECOMMENDATION: That the Board

- 1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200.1-15, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment as a de minimis action.
- 2. Authorize the issuance of a right-of-entry permit to Waikiki Roughwater Swim Committee, Inc. for the purpose of covering the subject area for the swim race event on September 5, 2022, under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
 - A. The standard terms and conditions of the most current right-of-entry form, as may be amended from time to time; and
 - B. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.





Such activities have resulted in no known significant impacts, whether immediate or cumulative, to the natural, environmental and/or cultural resources in the area. Staff also believes that the request would involve negligible or no expansion or change in use of the subject area beyond that previously existing.

Recommendation:

It is recommended that the Board find that this project will probably have minimal or no significant effect on the environment and is presumed to be exempt from the preparation of an environmental assessment.
