#### **PURPOSE**:

To amend the existing Concession Agreement No. DOT-A-18-0004 at the Daniel K. Inouye International Airport for additional parking space. Under Article IV of the Agreement, the specific area assigned or provided for the concession activity may be changed at the discretion of the State.

## **ADDITIONAL PREMISES:**

# **CONCESSION FEE:**

All revenue generated by the additional space shall be reported as gross receipts and included in the percentage fee under the Concession Agreement.

# **IMPROVEMENTS**:

The Concessionaire, at its own cost and expense, shall be responsible for any renovation, upgrade, remodeling, and improvement to the additional parking space.

# CHAPTER 343, HRS – ENVIRONMENTAL ASSESSMENT

The State of Hawai'i, Department of Transportation, Airports Division has determined that the impacts of this action are de minimis and exempt, pursuant to Department of Transportation, Comprehensive Exemption List, Type 8, Part 1, 8(g), concurred to by the Environmental Advisory Council on February 1, 2022.

#### **REMARKS:**

The DOT and ABM Aviation, Inc. entered into that certain Concession Agreement No. DOT-A-18-0004, effective June 1, 2018, for the Management and Operation of the Automobile Parking Facilities at Daniel K. Inouye International Airport. The additional parking space is integral to ABM's business operation at the Airport.


