Federal Express Corporation (FEDEX) whose business address is 3680 Hacks Cross Road, Building H, 3rd Floor, Memphis, Tennessee 38125.

Building/Room No. 301-140, containing an area of approximately 132 square feet, as shown and delineated on the attached Exhibit A.

CURRENT USE STATUS:

Land presently encumbered by Governor's Executive Order No. 1611, dated February 1, 1954, setting aside 10.321 acres designated as Moloka'i Airport to be under the control and management of the State of Hawai'i, Department of Transportation for Public Purposes.

CHARACTER OF USE:

FEDEX will use the space for an office in the terminal as part of its freight delivery operation at MKK.

COMMENCEMENT DATE:

Upon complete execution of the revocable permit.

MONTHLY RENTAL:

\$281.38 (\$210.10 as determined from the Department of Transportation, Airports Division schedule of rates and charges established by appraisal of Airports property statewide plus \$51.48 for utilities and \$19.80 for maintenance).

\$844.14, or three (3) times the monthly rental in effect.

CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The State of Hawai'i, Department of Transportation, Airports Division (HDOT-A), has determined that the subject area is covered by the Moloka'i Airport Improvements Environmental Assessment (EA), published by the Environmental Quality Commission (EQC) in the December 23, 1981 issue of the EQC Bulletin. Accordingly, all relevant mitigation from the EA and best management practices will be implemented to address the minimum impacts of this action.


