REQUEST:

Aris, Inc. (Aris) was issued a revocable permit for use of a trailer and land for vehicle parking as part of their Helicopter Tour Operations at Lihue Airport. Recently, the Department of Transportation, Airports Division (DOTA) discovered the premises occupied by Aris is larger than what was initially approved by the Land Board and is requesting to amend the revocable permit to include the additional area.

CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The State of Hawai'i, Department of Transportation, Airports Division (DOTA), has determined that the environmental impacts for the subject land use is covered by the Līhu'e Airport Ahukini Road Realignment and General Aviation Subdivision Final Environmental Assessment (FEA), published by the Office of Environmental Quality Control (OEQC) in the April 23, 1997, issue of The Environmental Notice. Accordingly, all relevant mitigation from the FEA and best management practices will be implemented to address the minimum impacts of this action.

REMARKS:

DOTA and Aris, Inc. entered into RP-9101, effective June 1, 2021, for use of a trailer and land for vehicle parking in support of their Helicopter Tour Operations. DOTA is requesting to amend RP-9101 to include the entire AREA used by Aris at Līhu'e Airport.

RECOMMENDATION:

That the Board approves Amendment No. 1 to RP-9101 to include the increase in area of the original premises, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.
