# REQUEST:

Issuance of a Revocable Permit for Aircraft Parking (Parking Permit) to Air Ventures Hawaii, LLC, situated at Līhu'e Airport.

#### **CURRENT USE STATUS:**

Land presently encumbered by Governor's Executive Order No. 4614, dated October 28, 2019, setting aside 883.583 acres designated as Līhu'e Airport to be under the control and management of the State of Hawai'i, Department of Transportation for Airport Purposes.

#### CHARACTER OF USE:

Aircraft Tie-down (2006 Gippsland GA-8, Tail No. N-699AV).

AVH has a second aircraft, 2007 Gippsland GA-8, Tail No. N-721AV stationed at LIH which will be rotated with Tail No. N-699AV based on flight time and may be parked in the tie-down as needed for its Commercial Airplane Tour and Charter Operations at LIH.

#### **COMMENCEMENT DATE:**

Upon execution of the revocable permit.

#### **MONTHLY RENTAL:**

\$126.00 (as determined from the DOTA schedule of rates and charges established by appraisal of Airports property statewide).

## **SECURITY DEPOSIT:**

\$378.00, or three (3) times the monthly rental in effect.

#### CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The State of Hawai'i, Department of Transportation, Airports Division (DOTA), has determined that the environmental impacts for the subject land use is covered by the Lihue Airport Ahukini Road Realignment and General Aviation Subdivision Final Environmental Assessment (FEA), published by the Office of Environmental Quality Control (OEQC) in the April 23, 1997, issue of The Environmental Notice. Accordingly, all relevant mitigation from the FEA and best management practices will be implemented to address the minimum impacts of this action.

#### **REMARKS:**

In accordance with Section 171-55, HRS, relating to <u>Permits</u>, the Department of Transportation proposes to issue a month-to-month Parking Permit to AVH for aircraft parking to support its Commercial Airplane Tour and Charter Operations at LIH.

## **RECOMMENDATION:**

That the Board authorize the Department of Transportation to issue a month-to-month Parking Permit to AVH, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.
