Air Ventures Hawaii, LLC (AVH), whose mailing address is 3745 Ahukini Road, Suite 102, Līhu'e, Hawai'i 96766.

## **CURRENT USE STATUS:**

Land presently encumbered by Governor's Executive Order No. 4614, dated October 28, 2019, setting aside 883.583 acres designated as Līhu'e Airport to be under the control and management of the State of Hawai'i, Department of Transportation for Airport Purposes.

# **CHARACTER OF USE:**

AVH will use the T-Hangar for storage of aircraft (2007 Gippsland GA-8, Tail No. N-721AV) and a maintenance hangar, as part of its Commercial Airplane Tour and Charter Operations at LIH.

AVH has another aircraft, 2006 Gippsland GA-8, Tail No. N-699AV, which will be stationed at LIH, and which will be rotated with Tail No. N-721AV based on flight time and may be parked in the T-hangar as needed for its Commercial Airplane Tour and Charter Operations at LIH.

No fixed-wing tour operations will be allowed from the T-hangar.

#### COMMENCEMENT DATE:

Upon execution of the revocable permit.

#### MONTHLY RENTAL:

\$1,672.72 (\$1,624.00 as determined from the DOTA schedule of rates and charges established by appraisal of Airports property statewide plus \$48.72 for electricity).

# **SECURITY DEPOSIT:**

\$5,018.16, or three (3) times the monthly rental in effect.

# CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The State of Hawai'i, Department of Transportation, Airports Division (DOTA), has determined that the environmental impacts for the subject land use is covered by the Lihue Airport Ahukini Road Realignment and General Aviation Subdivision Final Environmental Assessment (FEA), published by the Office of Environmental Quality Control (OEQC) in the April 23, 1997, issue of The Environmental Notice. Accordingly, all relevant mitigation from the FEA and best management practices will be implemented to address the minimum impacts of this action.

# **REMARKS:**

In accordance with Section 171-55, HRS, relating to <u>Permits</u>, the Department of Transportation proposes to issue a month-to-month revocable permit to AVH for storage of aircraft and a maintenance hangar, as part of its Commercial Airplane Tour and Charter Operations at LIH.

# **RECOMMENDATION:**

That the Board authorize the Department of Transportation to issue a month-to-month revocable permit to AVH, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.
