REQUEST:

Issuance of a Revocable Permit for Aircraft Parking (Parking Permit) to Shortcut LLC, for one (1) aircraft tie-down space, situated at Kahului Airport (OGG).

APPLICANT:

Shortcut LLC, whose mailing address is 100 Poailani Place, Kihei, Hawai'i 96753.

RECOMMENDATION:



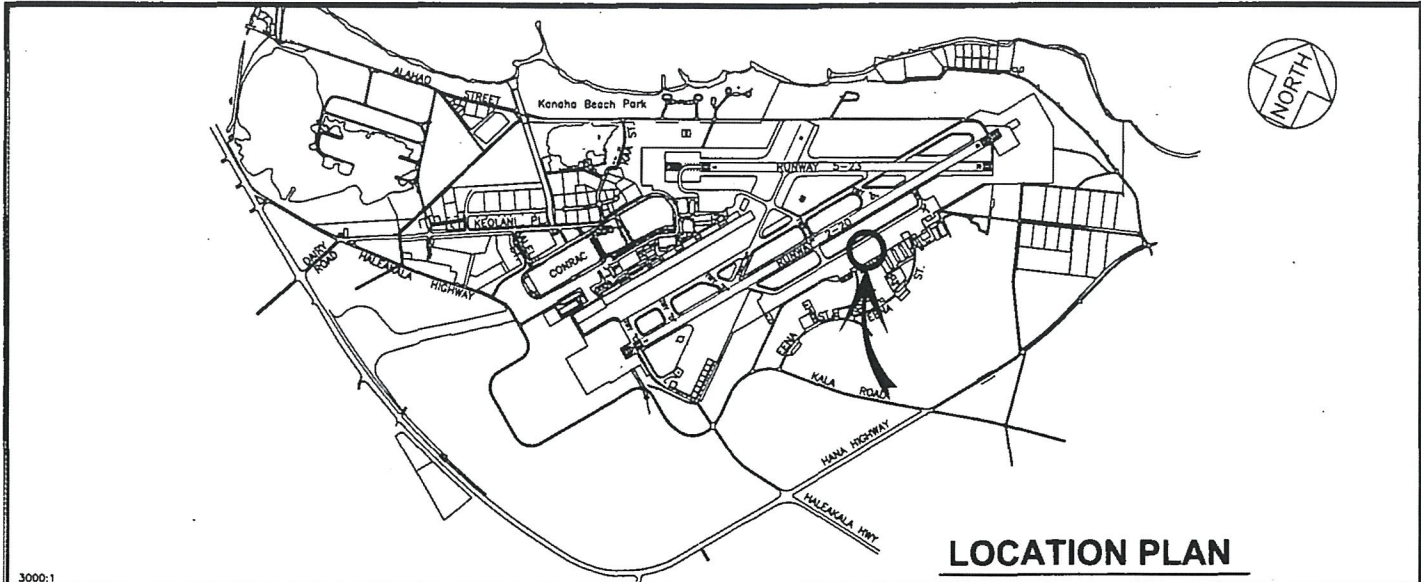

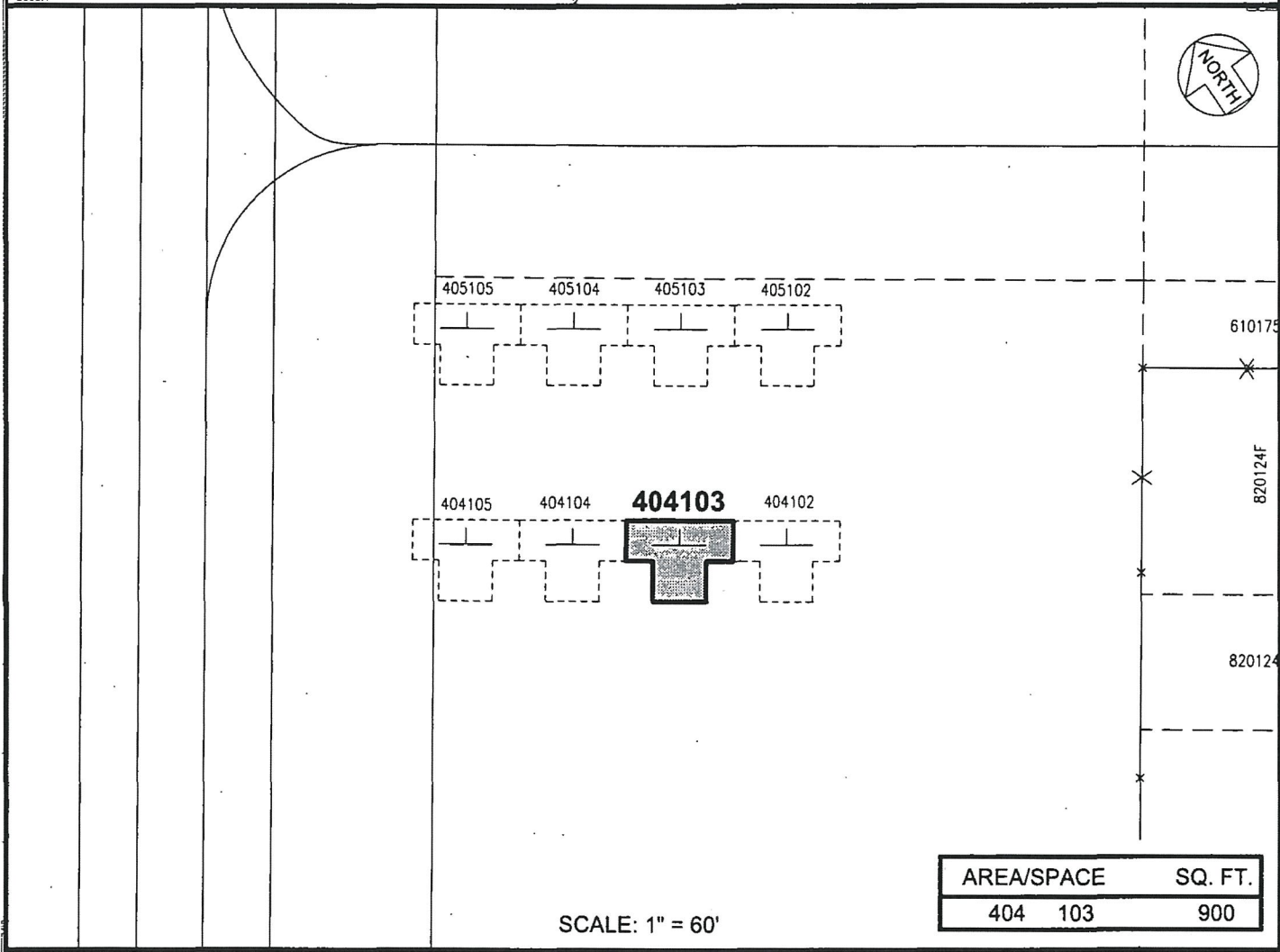
