REQUEST FOR ADAPTIVE MANAGEMENT MEASURES BY FORMAL BOARD ACTION PURSUANT TO SECTION 183D-3(b), HAWAII REVISED STATUTES, TO TEMPORARILY AMEND HAWAII ADMINISTRATIVE RULES (HAR) TITLE 13 CHAPTER 123 - RULES REGULATING GAME MAMMAL HUNTING, BY AMENDING EXHIBIT 1 AS REFERENCED IN HAR SECTIONS 13-123-3 (AUTHORIZED HUNTING), 13-123-4 (BAG LIMITS, OPEN SEASONS, AND HUNTING DAYS), 13-123-22 (CONDITIONS AND RESTRICTIONS), AND 13-123-23 (USE OF TAGS), FOR GAME MAMMALS TO BE TAKEN ON THE ISLAND OF KAUA'I, TO CHANGE OPEN HUNTING DAYS IN UNIT F FROM FOUR DAYS A WEEK AND STATE HOLIDAYS TO SEVEN DAYS A WEEK (DAILY).

# **SUMMARY**

The Department of Land and Natural Resources ("Department") Division of Forestry and Wildlife ("DOFAW") requests the Board of Land and Natural Resources ("Board") take formal board action to approve adoption of a temporary administrative rule change to Exhibit 1 in Chapter 13-123, Hawai'i Administrative Rules (HAR), "Rules Regulating Game Mammal Hunting", under the authority of HRS § 183D-3(b). The amendment would open hunting days for feral goats, feral pigs, and black-tailed deer taken in Unit F on Kaua'i by allowing for hunting seven days per week (daily) to limit populations of these game mammals which have been impacting Kaua'i's natural resources. Increasing hunting opportunities should curtail game populations back to sustainable numbers.

### ADMINISTRATIVE RULEMAKING AUTHORITY

The Department, through DOFAW, is charged to manage and administer the wildlife and wildlife resources of the State, enforce all laws relating to protecting, taking, hunting, killing, propagating, or increasing the wildlife within the State; regulate lands set apart as game management areas and public hunting areas; and must preserve, protect, and promote public hunting. HRS § 183D-2. DOFAW regulates game mammal hunting statewide through Chapter 13-123, HAR.

In 2021, the Hawai'i Legislature authorized the Department to conduct adaptive management measures other than by Chapter 91 rulemaking, if it timely adopts, amends, or repeals any rule pertaining to bag limits, size limits, open or closed hunting seasons, or gear restrictions by formal board action at a publicly noticed meeting in necessary response to rapidly changing resource conditions. HRS § 183D-3(b). To do so the Board must give notice of the rulemaking:

- (1) at least once statewide at least 30 days in advance of the public meeting;
- (2) include a statement of the topic of the proposed rule or a general description of the subjects involved;
- (3) include a statement that a copy of the proposed rule will be mailed to any interested person who requests a copy and pays the required fees for the copy and postage, if any, together with a description of where and how the requests may be made;
- (4) include a statement of when, where, and during what times the proposed rule may be reviewed;
- (5) include the date, time and place where the public meeting will be held and where interested persons may be heard on the proposed rule; and
- (6) mail to all persons who have made a timely written request of the Board for advance notice of its rulemaking proceedings.

If adopted, the new rule would be effective for an initial period of no longer than two years and be subject to legislative approval and renewal by the Board; provided that the renewal by the Board shall extend for up to one year at a time. If adopted, proposed rules become effective ten (10) days after the board action, unless a later date is specified in the proposed rule. Final rules are to be posted on DOFAW's website (at <a href="https://dlnr.hawaii.gov/dofaw/rules/">https://dlnr.hawaii.gov/dofaw/rules/</a>) for the duration of their validity. All rules adopted through the adaptive management process are subject to administrative penalties provided in HRS § 183D-12.

# **BACKGROUND**

High populations of feral mammals (goats, pigs, deer) have persisted on Kaua'i despite attempts in prior years to reduce those populations by allowing a muzzleloader control hunt for one year and allowing two months of muzzleloader hunts. Goats, pigs, and deer are prolific breeding mammals that do not require restrictions in open hunting days to persist in large numbers, so restricting hunter access is not necessary in most cases. In discussions with Kaua'i hunters, the current population of feral goats, pigs, and deer in Unit F should stop increasing and become sustainable if additional hunting days are


added. In addition, Unit F will benefit from curtailed mammal damage to natural resources (i.e. loss of vegetation, increase in soil erosion, other consequential changes to habitat from animal activities). Currently, means of take within Unit F are limited to archery and muzzleloaders<sup>1</sup> to balance hunter safety with game mammal population control. The purpose of these proposed amendments is that by increasing the number of days for authorized hunting (open hunting days), hunters will have additional flexibility in hunting days to remove deleterious game mammal species and the increasing damage to natural resources will be reduced.

### **PROJECT DESCRIPTION – Requirement of Adaptive Management Measures**

DOFAW has determined that the high populations of feral goats, pigs, and deer in Unit F on Kaua'i requires implementation of adaptive management measures in response to rapidly changing conditions; and requests that the Board find amending Exhibit 1 of Chapter 13-123, HAR, is necessary because the number of feral goats, pigs, and deer in Unit F is a resource condition requiring a necessary temporary administrative rule change, using Board authority under HRS § 183D-3. HAR sections 13-123-3, 13-123-4, 13-123-22, and 13-123-23 each reference Exhibit 1, which in turn provides regulations in Unit F for game mammals to be taken, means of take, bag limits, open hunting periods, open hunting days, and special conditions and restrictions. Current open hunting days for feral goats, pigs, and deer in Unit F are Fridays, Saturdays, Sundays, Mondays, and state holidays – effectively four to five days per week. The proposed rule would open hunting days to seven days per week. If approved, these proposed amendments would be effective for two years beginning ten days after the date of the Board's approval.

Unit F on the island of Kaua'i covers approximately 3,079 acres and consists of state-owned land within Waimea Canyon lying east of Highway 550, south of Units K and B, west of the six hundred foot contour, and north of a line due west of Waimea "Obake" Swinging Bridge. HAR § 13-123-15(g) (2015). See Figure 1.

The current administrative rules for hunting in Unit F on Kaua'i are shown in Exhibit 1, "Game mammals to be taken, means of take, daily bag limits, hunting periods, hunting days, and special conditions for hunting on the island of Kauai" located at the end of Chapter 13-123, HAR. # RECOMMENDATION

### That the Board

- 1. Find based on the above that appropriate adaptive management measures need to be instituted to address the rapidly changing population of deer, goats, and pigs in Unit F on Kaua'i to address increasing habitat degradation; and
- 2. Approve and temporarily amend the Division of Forestry and Wildlife Rules Regulating Game Mammal Hunting, Title 13 Chapter 123, HAR, by amending Exhibit 1 to administrative rules for regulating hunting in Unit F on Kaua'i to increase recreational hunting from four days per week and state holidays to seven days per week (daily) using the authority of HRS § 183D-3(b).

Attachment 1: Proposed adaptive management rule changes to be incorporated in Exhibit 1 of Chapter 13-123, HAR.

The adoption of these rules shall take effect ten days after this formal action by the Board of Land and Natural Resources ("Board") (January 23, 2023), and shall be effective for no longer than two years, subject to legislative approval and renewal by the Board; provided that renewal by the Board shall be extended for up to one year at a time. These rules shall be posted on the Division of Forestry and Wildlife's website, where they will remain for the duration of the time the rules are in effect.

These rules are subject to administrative penalties as provided by section 183D-12, HRS.

- \*/6 Hunting access and public use conditions in portions of Unit A and Unit L are subject to landowner/lessee approval. Confirm with the Lihue Division of Forestry and Wildlife Office before hunting at 808-274-3433.
