REQUEST:

Issuance of a Revocable Permit for Aircraft Parking (Parking Permit) to David Blancett-Maddock, for an aircraft tie-down space, situated at Ellison Onizuka Kona International Airport at Keahole.

LEGAL REFERENCE:

Section 171-55, Hawaii Revised Statutes (HRS), as amended.

Portion of Ellison Onizuka Kona International Airport at Keahole (KOA), Kailua-Kona, Island of Hawaii, identified by Tax Map Key: 3rd Division, 7-3-43: Portion of 003.

Area/Space No. 425-104, containing an area of approximately 1,659 square feet, as shown and delineated on the attached Exhibit A.

Aircraft tie-down (1966 Piper Cherokee PA-28-140/160, Tail No. N-6326R).

COMMENCEMENT DATE:

Upon complete execution of the parking permit.

MONTHLY RENTAL:

\$126.00 (as determined from the Department of Transportation, Airports Division schedule of rates and charges established by appraisal of Airports property statewide)

SECURITY DEPOSIT:

\$378.00, or three (3) times the monthly rental in effect.

<u>CHAPTER 343, HRS – ENVIRONMENTAL ASSESSMENT:</u>

The State of Hawaii, Department of Transportation, Airports Division, has determined the subject land areas are covered by the Final Environmental Assessment (EA)/Finding of No Significant Impact (FONSI), Airfield, Terminal, and Facility Improvements for the Kona International Airport at Keahole, published by the Office of Environmental Quality Control (OEQC) in the March 23, 2013, issue of The Environmental Notice. Accordingly, all relevant mitigation from the EA and best management practices will be implemented to address the minimum impacts of this action.
