# **LOCATION AND TAX MAP KEY:**

Portion of Lihue Airport (LIH), Lihue, Island of Kauai, State of Hawaii, identified by Tax Map Key: 4<sup>th</sup> Division, 3-5-001: Portion of 135.

## **CURRENT USE STATUS:**

Land presently encumbered by Governor's Executive Order No. 4614, dated October 28, 2019, setting aside 883.583 acres designated as Lihue Airport to be under the control and management of the State of Hawaii, Department of Transportation for Airport Purposes.

## **CHARACTER OF USE:**

GSA/TSA will use the spaces for administrative purposes as storage and an office/breakroom to support the Transportation Security Administration's (TSA) operation at LIH.

#### TERM OF LEASE:

Five (5) years.

## **COMMENCEMENT DATE:**

Upon execution of the Lease.

## **ANNUAL RENTAL:**

\$26,913.24 per annum (\$19,823.40, as determined from the DOTA schedule of rates and charges established by appraisal of Airports property statewide, plus \$4,506.84 for utilities and \$2,601.00 for air conditioning for Building/Room No. 306-305).

# CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The State of Hawaii, Department of Transportation, Airports Division, has determined that the environmental impacts of the proposed tenant use for the subject land use is covered by the Lihue Airport Master Plan Environmental Impact Statement, published by the Environmental Quality Commission (EQC) in the August 8, 1976 and August 23, 1976, issues of EQC Bulletin and accepted by the Governor on April 26, 1977. Accordingly, all relevant mitigation from the EIS and best management practices will be implemented to address the minimum impacts of this action.

#### **REMARKS:**

In accordance with Sections 171-59 (b), and other applicable sections of Chapter 171 HRS, as amended, relating generally to Management and Disposition of Public Lands, and relating specifically to the Disposition by Negotiation, the Department of Transportation (DOT) proposes to issue a directly negotiated lease to GSA/TSA for storage space and an office/breakroom to support TSA operations at LIH.

# **RECOMMENDATION:**

That the Board authorize the DOT to issue a directly negotiated lease to GSA/TSA, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State; and (3) review and approval of the Department of the Attorney General as to the lease form and content.






