Use of an office space at Kahului Harbor, island of Maui.

CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

This use is exempt from the Office of Planning and Sustainable Development, and Environmental Review Program requirements pursuant to Sub-Chapter 11-200.1, Hawaii Administrative Rules (HAR), that exempts the following:

"Exemption Type 1: Operations, repairs or maintenance of existing structures, facilities, equipment, or topographical features, involving minor expansion or minor change of use beyond that previously existing."

The DOTH deems the action as de minimis and exempts it from the preparation of an exemption notice in accordance with Sub-Chapter 11-200.1-16(b), HAR. The exemption declaration for the action described above is based on the Exemption List for the DOTH, reviewed and concurred to by the Environmental Advisory Council on February 1, 2022, is as follows: "Exemption Type 1, Part 1, Item No. A1."

REMARKS:

The three basic roles the USCG provides are maritime safety, security, and stewardship. The USCG's Marine Safety Team is an important resource for the waters surrounding the islands of Maui County.

RECOMMENDATION:

Based on this submittal, testimony and facts presented, the Department of Transportation recommends that the Board finds that approving the issuance of a month-to-month Revocable Permit to the Applicant, including its conditions and rent, will serve the best interest of the State.




