## CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

Pursuant to HAR 11-200.1-16(b), the Department of Transportation (DOT) has determined that the environmental impacts of the proposed land use is exempted under DOTs Exemption List, reviewed and concurred to by the Environmental Advisory Council on February 1, 2022, under Type 8, Part 1, (8)h. Creation or extension of leases,

revocable permits or easements of property for continuing aeronautical or maritime uses or complementary purposes.

## **REMARKS**:

In accordance with Section 171-55, HRS, relating to <u>Permits</u>, the Department of Transportation proposes to issue a month-to-month revocable permit to Nan for ramp space to install their own trailers for field offices as specifically stated in State Project No. AH2042-31R, Restroom Improvements and New Covered Walkway at Ellison Onizuka Kona International Airport at Keahole, Section 1.04, relating to <u>Provisions for Field Office/Storage Space</u>: "Pending the availability of space on airport property, the State will issue Revocable Permit(s) to the Contractor for the use of the space, assessed at a monthly fee of \$25 for each Revocable Permit issued. The space(s) may be used for a field office..."

## **RECOMMENDATION:**

Based on this submittal, and testimony and facts presented, the Department of Transportation recommends the Board finds that approving the issuance of a month-to-month Revocable Permit to Nan, including its conditions and rent, will serve the best interests of the State.
