We are resubmitting this request, which was previously approved on June 24, 2022 (please see enclosure). Upon review of the descriptions of the remnants, we found discrepancies, and we are requesting an approval of the amended square footage of Remnants E-6 Rev. 1 and 22-A.

REQUEST:

Authorization to convey subject Property, designated as Remnant E-6 Rev. 1 (Portion) and 22-A East Molokai Road, Federal Aid Secondary Project No. 2-A(1), Kaunakakai-Kamalo, Molokai, Tax Map Key No. (2) 5-4-02: Road (Portion) as shown on the enclosed Exhibit A to Gerald Alderson by Quitclaim Deed.

REQUEST:
