Aloha,

Waikīkī Beach Services, LLC has been a beach concessionaire in Waikīkī since 1955, teaching the Hawaiian arts of surfing and canoe surfing to visitors and locals alike. We have watched many changes take place in Waikīkī over the decades, but there is one change that we do not want to see: the loss of beach in Waikīkī. We **strongly support** beach improvement and maintenance projects in the Fort DeRussy, Halekulani, Royal Hawaiian, and Kūhiō Beach sectors of Waikīkī.

These beach improvement and maintenance projects include the construction of new beach stabilization structures, the recovery of offshore sand, and placement of said sand on the shoreline. The objectives of these actions are to restore and improve Waikīkī's public beaches, increase beach stability through improvement and maintenance of shoreline structures, provide and improve safe access to and along the shoreline, and increase resilience to coastal hazards and sea level rise. The proposed actions are intended to maintain the aesthetic, recreational, economic, cultural, and historical qualities of Waikīkī.



Waikīkī has experienced record high tides (King Tides) that have exacerbated erosion and flooding making the beach either inaccesible or dangerous to beachgoers. These events have been a preview to the devastating impacts sea level rise will continue to have in Waikīkī. Sand replenishment and groin maintenance projects have shown to be integral in preserving the beach at Waikīkī.

In 2020, the Royal Hawaiian groin was rebuilt after 50 years of no new beach stabilization projects; prior to this project, the beach in front of the Royal Hawaiian and Sheraton Waikīkī hotels had become almost non-existent due to the constant battering from storms and King Tides. The beach became a minefield of exposed rock, concrete, and pipes that beachgoers had to dodge in order to access the ocean. At one point, access to this area of Waikīkī beach was even restricted due to unsafe/unstable conditions. However, after the 2020 Royal Hawaiian groin renewal and sand replenishment, beachgoers have been able to experience safer access to the beach and enjoy the ability to sunbathe, recreate and relax.

Waikīkī is wahi pana, or a celebrated and storied place, both in ancient and modern Hawai'i;

famous surf breaks like *Kalehuawehe* were celebrated in many *moʻōlelo* and the surrounding land was prized for it's year-round pleasant weather, leading many *aliʻi* to erect their summer palaces and homes near the Waikīkī shoreline. In the 1900's, when aspects of the Hawaiian culture were near to fading away due to Missionary influence and the taboo on Hawaiian language and past-times, it was Waikīkī Beach where Hawaiians still continued to practice the arts of surfing and canoe surfing. Later, when tourism made it's way to our islands, Waikīkī furthered it's cultural significance by becoming the conduit where a group of expert watermen, known as Waikīkī Beachboys could not only hone their skills at these ancient Hawaiian watersports, but also share them with a world-wide audience. This practice of sharing our culture continues to this day. Waikīkī is known as the birthplace of modern surfing and it is still the only place in the world where a guest can experience the thrill of surfing a wave on a Hawaiian outrigger canoe.

Without our mālama and nourishment of this beach, through public and private partnerships, sea level rise will eventually lead to total beach loss. The economic impact would be devastating--\$2.23¹ billion in visitor expenditures and tens of thousands of lost jobs; but the loss of such a culturally important part of Hawaiian history is incalculable and the reverberations of this loss will be felt by residents and for many generations.

The University of Hawai'i Sea Grant (UHSG) program provides the following comments for the proposed Waikīkī Beach Improvement and Maintenance Project by the Hawai'i Department of Land and Natural Resources (DLNR). These comments are meant to provide clarity and to assist in providing the Board of Land and Natural Resources (BLNR) with up to date coastal and climate science and data to help make informed decision-making. The proposed beach improvement and maintenance projects are intended to mitigate the forecast impacts of sea-level rise as well as the observed beach loss and associated coastal inundation in Waikīkī. These projects are examples of climate adaptation designs within a dense urban coastal environment and are generally consistent with coastal engineering standards and practices around the world. These measures are part of a broader effort to adapt the built environment of Waikīkī to the predicted impacts of climate change and coastal hazards. Some of these adaptation efforts include the development of the Waikīkī Resilience and Adaptation Plan (WRAP), adaptation urban design architecture charrettes, updates to the Waikīkī Special District Design Guidelines along with other City and State policy changes to facilitate adaptation of Waikīkī.

The Hawai'i Sea Level Rise Vulnerability and Adaptation Report¹ found that 3.2 feet of sea level rise will have profound impacts on O'ahu. \$12.9 billion in structures and land could be lost; 3,800 structures could be flooded, including hotels and resorts in Waikīkī; over 13,000 residents could

be displaced; and nearly 18 miles of major roads could be flooded. The report estimates that O'ahu will account for an estimated 66% of the total statewide economic losses due to sea level rise. The State recommended that private and public entities in Waikīkī should begin planning for sea level rise adaptation, including beach restoration, to prepare for higher sea levels in the future.

Global scientific studies reinforce the urgent need to implement adaptation measures in our plans, polices and projects. According to Working Group I of the Sixth Assessment Report (AR6) from the United Nations Intergovernmental Panel on Climate Change (IPCC) it is "unequivocal that human influence has warmed the atmosphere, ocean, and land. As a result, widespread and rapid changes in the atmosphere, ocean, cryosphere, and biosphere have occurred including global sea level rise". As a result of this scientific information, the City and County of Honolulu (City) Climate Change Commission (Commission) made the following recommendations for the City (updated in February, 2023) for planning for sea level rise². This report builds on findings in the Hawai'i Sea Level Rise Vulnerability and Adaptation Report (2017), Sweet et al. (2017), USGCRP (2017), Sweet et al. (2018), and other scientific literature to provide specific policy and planning guidance on responding to sea level rise by the City.

- The City and County of Honolulu should set as a planning and policy benchmark the interagency Intermediate (1.16 m, 3.8 ft by 2100) sea level rise scenario, as modeled for the Honolulu Tide Station, as the minimum scenario for all planning and design.
- The City and County of Honolulu should set as a planning and policy benchmark the interagency Intermediate High (1.78 m, 5.8 ft by 2100) sea level rise scenario for all planning and design of public infrastructure projects and other projects with low tolerance for risk.

The project is part of a broader collaborative initiative, the "Ho'omau 'O Waikīkī Kahakai' (Waikīkī Beach Renews itself) which includes development of a community-based beach management plan, economic study of the value of Waikīkī Beach, stakeholder perception surveys, and other related endeavors. These supporting efforts are being carried out in coordination with the Department of Land and Natural Resources, the Waikīkī Beach Special Improvement District Association (WBSIDA) and the University of Hawai'i Sea Grant College Program (Hawai'i Sea Grant). Strategic Outreach efforts define the primary project priorities and strategies. The WBSIDA has developed a Waikīkī Beach Community Advisory Committee to help inform projects and serving as a community representative to the projects³.

The UHSG offers the following summary of project-specific comments.

- 1. The stated project objective is to increase the resilience to climate change and coastal hazards, this is an extremely common concern shared by Waikīkī stakeholders.
- 2. The proposed beach improvement projects in Waikīkī are essential for the stated future goal to maintain a viable beach in these areas.
- 3. Climate change impacts including sea-level rise projected by the state of Hawai'i Climate Change Commission indicate significant flooding, wave overtopping and beach erosion in Waikīkī for the coming decades and suggest stakeholders and communities plan for 3.2 feet of sea-level rise now. This project has a strong climate change adaptation component that is consistent with the recommendations of the State Climate Commission.
- 4. The proposed projects are consistent with existing engineering standards and planning studies for Waikiki Beach improvements and are capable of being implemented as phased or stand-alone projects. The engineering designs of the groins also account for predicted sea level rise, thus providing a minimum level of sea-level rise adaptation and protection. Furthermore, the proposed groin designs allow for future elevation adjustments to provide a minimum level of function for the next 30-40 years but can be adjusted to accommodate increased sea-level rise beyond that.
- 5. Alternative groin design recommendations, including T-Head groins have been previously assessed and recommended as possible strategies for beach improvements in Waikīkī^{4,5}. Other examples such as the Royal Hawaiian Groin, Hawaii Kai channel entrance groin and Iroquois Point at Pearl Harbor all demonstrate the successful use of L and T-head groins in a similar nearshore setting.
- 6. The recently replaced Royal Hawaiian Groin (August, 2020) is demonstrating to be effective at stabilizing the beach area in the Royal Hawaiian beach cell⁶. Beach volume monitoring by the University of Hawai'i indicates that the Royal Hawaiian beach is not only stable but has been growing in overall volume since the May, 2021 Waikīkī Beach

Maintenance project was completed⁷. This includes recent beach monitoring data before and after the historic south swell of July, 2022 that increased the overall volume in the Royal Hawaiian Beach by 3%⁸.

- 7. Without a stabilizing and energy-buffering beach to protect public and private coastal infrastructure, we can anticipate even larger and more expensive structural repair and improvement projects to be required soon to prevent the destruction of threatened coastal structures including critical public access walkways and beaches that serve as important recreational and lateral access amenities.
- 8. Acknowledging that Waikīkī is a very dense urban costal environment with extremely high land values, strategic relocation (managed retreat) is an important long-term planning objective but may be a more challenging short and mid-term adaptation option. Recent planning efforts in Waikīkī support developing adaptation pathways, and phased implementation of strategic retreat in the long-term (50+ years). Various forms of adaptation in the short and mid-term may allow more time to develop strategic, rather than forced relocation of coastal development and infrastructure.

Dear Board Members:

On behalf of the Hawai'i Lodging & Tourism Association, the state's largest private sector tourism organization, I am conveying our unequivocal support for the Waikiki Beach improvement project being proposed by the Department of Land and Natural Resources and Waikiki Beach Special Improvement District.

The purpose of the beach project has been well-documented, as have the specific steps recommended to preserve this expanse of our beachfront in the face of continuing erosion, climate change, and other natural factors. From the perspective of the HLTA, this initiative is absolutely vital to the visitor industry, for these reasons:

- 1. Waikiki is the engine of the state's tourism economy. While we have succeeded in diversifying our island destinations and hotel inventory, Waikiki remains the first choice for millions of travelers every year and will remain so for the foreseeable future.
- 2. According to a forecast by the Department of Business, Economic Development & Tourism, visitor arrivals for 2023 are projected to rebound to near pre-pandemic levels at more than 9 million. Visitor spending will exceed \$21 billion, infusing our state economy with much-needed money to replenish a depleted treasury. Much of this money will be generated by Waikiki.

Aloha Chair Chang and Members of the Board:

My name is Jerry Gibson, and I am the President of the Hawai'i Hotel Alliance. The Hawai'i Hotel Alliance members represent some 40,000 hotel rooms, including from all major brands such as Hilton, Marriott, Outrigger, Hyatt, Disney, Highgate, Springboard and others. We write this testimony in support of the DLNR's proposed Waikīkī Beach Maintenance Program.

Waikīkī is not only a treasured resource to local residents, it is also a vital part of Hawai'i's economy. The Hawai'i Hotel Alliance believes strongly that preserving and protecting Waikīkī Beach is critical to the economic viability of Waikīkī and of Hawai'i generally. Waikīkī is responsible for bringing billions of dollars in visitor expenditures to Hawai'i's economy annually. There are more than 30,000 visitor accommodation units in the resorts, hotels and condominiums in Waikīkī. Tourism-related activities in Waikīkī contribute very substantially to Hawai'i's tax revenues, including General Excise Tax, Transient Accommodations Tax, and income tax from tourism-related employment.

The proposed beach improvement projects in Waikīkī are essential for the future goal to maintain a viable beach in these areas. Several beachfront areas in Waikīkī are seeing the rapid deterioration of both public and private backshore infrastructure such as groins, seawalls and walkways. This highlights the need to make long-term investments into beach stabilizing structures throughout Waikīkī in addition to more immediate emergency repairs to damaged infrastructure.

Without a stabilizing and energy-buffering beach to protect public and private coastal infrastructure, we can anticipate even larger and more expensive structural repair and improvement projects to be required soon to prevent the destruction of threatened coastal structures including crucial public access walkways and beaches that serve as important recreational and lateral access amenities.

The Hawai'i Hotel Alliance encourages the BLNR to move forward with the Waikīkī Beach Maintenance Program as soon as possible.

ABC Stores strongly supports the proposed beach improvement project by the Hawai'i Department of Land and Natural Resources (DLNR). The DLNR proposes beach improvement and maintenance projects in the Fort DeRussy, Halekulani, Royal Hawaiian, and Kūhiō Beach sectors of Waikīkī. The proposed actions are intended to maintain the economic, social, aesthetic, recreational, environmental, cultural, and historical qualities of Waikīkī.

We support comprehensive, forward-thinking improvement projects like those proposed and recognize its urgency. With the combination of beach erosion and King Tides, the backshore is frequently flooded, particularly during high surf events, accelerating damage to backshore infrastructure. Without beach improvements and maintenance, sea level rise is likely to result in total beach loss in Waikīkī before the end of the century and result in an estimated economic loss of \$50 million to \$150 million per hectare. The loss of Waikīkī Beach alone would result in an annual loss of \$2.223 billion in visitor expenditures¹. Improvements and maintenance like those proposed in the DPEIS are necessary to restore and maintain the beaches of Waikīkī to continue to support Hawaii's tourism-based economy.

In recent meetings at the Sheraton Hotel and past visits to Halekulani Hotel, quite noticeable is the non-existing walkway that existed before. So much so that one is able to see pilings instead of the walkway. This area has been lost to erosion, with this occurring over recent years. As stakeholders along ocean properties are exposed to the changes in sea level and climate change, help is needed to ensure further degradation of the beachfront and loss to these properties can be abated. One only

needs to see reports on the effects of beach erosion in areas such as in Kaanapali and on the North Shore of Oahu.

Tourism is an economic driver for Hawaii and Waikiki is one of the go to destination for these travelers. While many will visit other areas of the island for their beach activities the beach front in Waikiki is still iconic for many. Visitors and locals both have a vested interest in preserving this iconic coastline.

A well thought out plan for the Waikiki coastline is needed to preserve the area for businesses and future generations of both local and tourists alike. The partnership between WBSIDA and the Hawaii Sea Grants Program is a good start to proper management of the coastline. With the Waikiki Beach Management Plan, and related projects, partnership with DLNR will move forward the much needed long term sustained efforts for long-term capital improvements and comprehensive beach maintenance.

Summary:

- 1. The proposed beach improvement projects in Waikīkī are essential for the future goal to maintain a viable beach in these areas. Several beachfront areas in Waikīkī are seeing the rapid deterioration of both public and private backshore infrastructure such as groins, seawalls and walkways. This highlights the need to make long-term investments into beach stabilizing structures throughout Waikīkī in addition to more immediate emergency repairs to damaged infrastructure.
- 2. Climate change impacts including sea-level rise projected by the state of Hawai'i Climate Change Commission indicate significant flooding, wave overtopping and beach erosion in Waikīkī for the coming decades and suggest stakeholders and communities plan for at least 3.2 feet of sea-level rise now. This project has a strong climate change adaption component that is consistent with the recommendations of the State Climate Commission.
- 3. Without a stabilizing and energy-buffering beach to protect public and private coastal infrastructure, we can anticipate even larger and more expensive structural repair and improvement projects to be required soon to prevent the destruction of threatened coastal structures including critical public access walkways and beaches that serve as important recreational and lateral access amenities.
- 4. There is a need to balance and connect historical recreational beach uses with the maintenance of beach areas in the face of physical processes. This balanced management needs to account for the needs of a variety of user groups and needs to consider the impacts of the effects of climate change and coastal storms.



Now please see below, the reduced beach size by 2010 and then the accelerated reduction that has occurred, in only 13 years, in the final photo.

In the photo from this week, you can see even at low tide (as shown) only a narrow slither of beach shows. The arrows show the areas where this beach disappears at high tide.

Absent action, we could end up with the need for an ugly wall all the way from the Sheraton hotel to mid-way at Fort DeRussy Park.

That would be around 600 feet of Waikiki Beach coastline loss since the world famous Waikiki Beach was first envisaged.

Aloha Chair Chang and Members of the Board:

I join HHA in support of the beach improvement and maintenance projects in the Fort DeRussy, Halekulani, Royal Hawaiian and Kuhio beach sectors of Waikiki proposed by DLNR ("Proposed Projects").

HHA concurs with findings as described below in the Draft Programmatic EIS June 2021 ("DPEIS") which support the Proposed Projects.

A. Beach Erosion Threatens to Diminish Economic Viability of Waikiki.

Waikiki is a critical part of Hawaii's economy.

1. "Loss of Waikiki Beach would result in annual loss of \$2.223 billion in visitor expenditures (Tarui et al. 2018). Beach improvements and maintenance actions are urgently needed to restore and maintain the beaches of Waikiki to continue to support Hawaii's tourism-based economy and preserve the recreational, social, cultural, environmental, aesthetic and economic values of Waikiki for future generations".

"Waikiki is recognized as Hawaii's primary visitor destination and is home to more than 30,000 visitor accommodation units including resorts, hotels, and condominiums which accounts for 90% of all units on Oahu and nearly half of all units in the State of Hawaii (HTA, 2018). In 2002, tourism-related activities in Waikiki accounted for an estimated \$3.6 billion, which was 8% of Hawaii's Gross State Product. In addition, 12% of all State and County tax revenues and 10% of all civilian jobs statewide can be credited to Waikiki's attraction of visitors (DBEDT, 2003). In 2015, Waikiki generated 41% of the State's visitor industry activity and contributed 7% to Hawaii's Gross State Product (State of Hawaii, 2015; Porr, 2020)."

"The actions proposed for implementation in Waikīkī will be undertaken by the State of Hawai'i Department of Land and Natural Resources (DLNR), which is responsible for overseeing beaches and submerged lands out to the seaward extent of the State's jurisdiction. The proposed actions were developed in collaboration with public and private stakeholders with the shared goal and vision of improving the beaches of Waikīkī for current and future generations."

"Project coordination and implementation is being done in collaboration with the Waikīkī Beach Special Improvement District Association (WBSIDA), which is a private non-profit organization that was created in 2015 by City ordinance to preserve and restore Waikīkī Beach, and to serve as a cost-share partner in a public-private partnership with the DLNR. The WBSIDA is governed by a Board of Directors that consists of representatives of Waikīkī's major resorts, property owners, State and County government designees, and other stakeholders. The WBSIDA provides a mechanism for coordination of the proposed actions with a broad spectrum of Waikīkī stakeholders and securing private funding to support project implementation."

"The proposed actions were developed in close collaboration with the Waikīkī Beach Community Advisory Committee (WBCAC), which was formed in 2017 to provide a forum to engage stakeholders and provide guidance and feedback on design criteria and rationale for beach improvement and maintenance projects in Waikīkī. The WBCAC is composed of various stakeholders representing business (34%), government (30%), hotels and resorts (15%), non-profit organizations (12%), and science and engineering (9%). The WBCAC serves as a representative body to communicate the diversity of perspectives and priorities in the broader Waikīkī community, provide guidance and feedback for beach management and planning activities in Waikīkī, and

ensure that future beach management projects address the issues and concerns of the Waikīkī community and local stakeholders."

"The WBCAC has and continues to serve a vital role in the planning process that led to the selection of the proposed actions. The WBCAC was directly involved in determining the priorities and objectives for each beach sector, establishing planning and design criteria, evaluating conceptual options, and providing feedback on the conceptual designs for the proposed actions. The function of the WBCAC is further enhanced by the role of the University of Hawai'i Sea Grant Program's Waikīkī Beach Management Coordinator, which provides technical support, education and outreach, and project coordination. The WBCAC held six (6) formal meetings from 2017 to 2021. The meeting agendas and outcomes are included as Appendix A. The WBCAC will continue to provide feedback on the proposed actions throughout the environmental review, final design, and permitting processes."







Notice the level of sand is just below the smoothed out portion of cement wall, I am standing with my elbows on top of wall. Waikiki Beach Services used to run their outrigger canoe, and surf lessons down by the Hau Tree. This picture taken in 1976



The sand used to come up to at least the third step, bottom of hand rails were buried in the sand. Beach goers now have to traipse around Sheraton Hotel or cut through pool area to get back on Waikiki beach.

Notice a small beach is forming on the Ewa end of Royal Hawaiian groin. Picture taken July 5, 2023





For purposes of scale and proportion, I am standing in the general vicinity of where we used to land our catamaran on the beach in 1976. I estimate since 1999 to present day, there has been approximately 7 plus vertical feet of sand(at wall) that has moved either off shore or in Halekulani channel.

I can understand why some businesses and operators want the immediate replenishment of sand without the use of rock T groins. This may very well work in the Kawehewehe sector (Outrigger Reef Hotel and section of Halekulani Hotel). However in the area of Sheraton Waikiki Hotel (Gray's Beach) the vertical wall is too high, any sand added should be stabilised by T groins.

To our friends in the "Save Our Surf" the sea wall at the Sheraton as it is now, is not helping the surf form at least in the near shore. High tides and surf hit the wall head on and forms a back wave headed seaward disrupting any small surf coming towards shore. In the past this was a favorite spot for beginners and surf instruction.

As a permit holder and catamaran operator for the last 47 years at Gray's beach, I would be in favour of replenishing sand with T groins to help stabilise the beach.

My name is Carl A. Mayfield and I am the Executive Vice President — Design & Construction of Park Hotels & Resorts ("Park"), the owner of the Hilton Hawaiian Village in Waikiki. We offer this testimony in support of the beach improvement and maintenance projects in the Fort DeRussy, Halekulani, Royal Hawaiian and Kuhio beach sectors of Waikiki proposed by DLNR.

We need your urgent help to address this matter to the benefit of both kama'aina and visitors.




EVOLUTION OF FORT DERUSSY BEACH OVER NEARLY 100 YEARS












Waikīkī Beach accounts for over \$2 billion in annual income for the local economy. However, a 2008 visitor survey found that 12% of visitors would not return to Waikīkī due, in part, to limited beach area and resulting overcrowding. Those looking for a beach destination will naturally crowd other O'ahu communities and beaches, such as Kailua and the North Shore.

Preserving, restoring and maintaining these beach resources are of critical importance for the social, cultural, economic and environmental value for Hawai'i's communities.



Without a stabilizing and energy-buffering beach to protect public and private coastal infrastructure, we can anticipate even larger and more expensive structural repair and improvement projects to be required soon to prevent the destruction of threatened coastal structures including critical public access walkways and beaches that serve as important recreational and lateral access amenities.

An Economic Impact Analysis of the Potential Erosion of Waikīkī Beach by UH Sea Grant College in April 2018 estimated that the loss of Waikīkī Beach alone would result in an annual loss of \$2.223 billion in visitor expenditures.

The beaches of Waikīkī are all man made or highly altered, almost entirely composed of imported sand and the current shoreline configuration is largely the result of past construction efforts to widen and stabilize the beaches. Likewise, most of the beaches of Waikīkī are chronically eroding, with frequent backshore flooding, particularly during high tides and high-surf events. Due to Waikīkī Beach being man made, it is critical to have a maintenance strategy in place.

Improvements and maintenance like those proposed in the DPEIS are necessary to restore and maintain the beaches of Waikīkī to continue to support Hawai'i's tourism-based economy and significant cultural relevance for generations to follow. We do not have time to pass this issue to the next session, next council, next board, etc. We need immediate and swift action in order to prevent damage to the future of our State's economic health, along with the ability to preserve the traditions of Hawai'i for our keiki.

The Waikiki Shore Beach Condominiums owners, its managers, and tenants, have been especially interested and supportive of the efforts to improve the condition of this natural resource since the hydraulic dredging project in 2012 to restore sand between the Kuhio Beach Ewa Groin and the Royal Hawaiian Groin. It was expected that some continual beach maintenance would be accomplished regularly, as the value of Waikiki and Waikiki Beach is self-evident from long ago. However, the task is huge, involves a multitude of diverse people, and requires the type of long term management effort that is now before you.

The leadership behind the establishment of the Waikiki Beach Special Improvement District bears witness to this need:

The Waikiki Beach Special Improvement District was created on May 18th, 2015 by city ordinance to preserve and restore Waikiki Beach and to provide consistent and credible management for future beach revitalization. SIDs are among the most effective ways of forming and funding public-private partnerships to muster resources to tackle especially complicated challenges.

Through the facilitation of the Waikiki Beach Special Improvement District Association, a comprehensive Waikiki Beach Improvements Plan was developed, which included all people interested the process. The Waikiki Beach Condominiums Association formally endorsed the project's Draft Environmental Impact Statement in June 2021 and we are doing so again in July 2023.







The Waikīkī Beach Special Improvement District Association (WBSIDA) strongly supports the proposed beach improvement projects by the Hawai'i Department of Land and Natural Resources (DLNR). The proposed beach improvement and maintenance projects are an essential component to the overall resilience of this critically important area. The proposed projects in the Fort DeRussy, Halekulani, Royal Hawaiian, and Kūhiō Beach sectors of Waikīkī are critical projects to mitigate the forecast impacts of sea-level rise as well as the observed beach loss and coastal inundation already being experienced on a more frequent basis in Waikīkī. The proposed actions to restore and improve Waikīkī's public beaches and increase beach stability through improvement and maintenance of shoreline structures will greatly enhance safe access to and along the shoreline and greatly reduce the vulnerability of Waikīkī to coastal hazards and sea level rise. We are now at a crossroads with a clear and increasingly urgent need to implement maintenance and improvements to the shoreline in order to preserve and protect this unique and highly prized natural resource.

The Hawai'i Sea Level Rise Vulnerability and Adaptation Report¹ found that 3.2 feet of sea level rise will have profound impacts on O'ahu. \$12.9 billion in structures and land could be lost; 3,800 structures could be flooded, including hotels and resorts in Waikīkī; over 13,000 residents could be displaced; and nearly 18 miles of major roads could be flooded. The report estimates that O'ahu will account for an estimated 66% of the total statewide economic losses due to sea level rise. The State recommended that private and public entities in Waikīkī should begin planning for sea level rise adaptation, including beach restoration, to prepare for higher sea levels in the future, the WBSIDA whole-heartedly agrees.

The WBSIDA supports comprehensive, forward-thinking improvement projects like those proposed in the FPEIS and recognizes its urgency. With the combination of beach erosion and

King Tides, the backshore is frequently flooded, particularly during high surf events, accelerating damage to backshore infrastructure. Without beach improvements and maintenance, sea level rise is likely to result in total beach loss in Waikīkī before the end of the century and result in an estimated economic loss of \$50 million to \$150 million per hectare. The loss of Waikīkī Beach alone would result in an annual loss of \$2.223 billion in visitor expenditures². Improvements and maintenance like those proposed in the FPEIS are necessary to restore and maintain the beaches of Waikīkī to continue to support Hawaii's tourism-based economy.

The project is part of a broader collaborative initiative, the "Ho'omau 'O Waikīkī Kahakai" (Waikīkī Beach Renews itself) which includes development of a community-based beach management plan, economic study of the value of Waikīkī Beach, stakeholder perception surveys, and other related endeavors. These supporting efforts will be carried out in coordination with the Department of Land and Natural Resources, the Waikīkī Beach Special Improvement District Association (WBSIDA) and the University of Hawai'i Sea Grant College Program (Hawai'i Sea Grant). Strategic Outreach efforts define the primary project priorities and strategies. The WBSIDA has developed a Waikīkī Beach community advisory committee to help inform project development, serving as a community representative to the project team.

These events have highlighted the impacts of sea level rise on the beaches of Waikīkī. As sea levels continue to rise, beach loss will progressively degrade the recreational, social, cultural, environmental, aesthetic, and economic value of Waikīkī. The Royal Hawaiian groin was rebuilt in 2020, after nearly 50 years without any new beach stabilization projects in Waikīkī. The proposed improvements in this project come at a critical time of renewal and much-needed maintenance of critical beach-stabilizing structures throughout Waikīkī Beach. These measures also will facilitate projected sea level rise impacts to the beaches of Waikīkī.

Waikīkī generates approximately 42% of the state's visitor industry revenue and is responsible for 8% (\$5 billion) of the Gross State Product³. Beaches are a primary attraction for visitors to Waikīkī and we know that Waikīkī Beach accounts for over \$2 billion in annual income for the local economy. However, a 2008 visitor survey found that 12% of visitors would not return to Waikīkī due, in part, to limited beach area and resulting overcrowding⁴. Waikīkī Beach also has tremendous cultural significance as a former playground of Hawaiian royalty and the birthplace of the sport and culture of surfing. The beaches and myriad of world-renowned surf breaks and reef ecosystem located offshore are valuable natural resources that support the culture and lifestyle of Hawai'i, and the idyllic image of Waikīkī. Preserving, restoring and maintaining these beach resources are of critical importance for the social, cultural, economic and environmental value for Hawai'i's communities.

The ongoing partnership between WBSIDA and the Department of Land and Natural Resources has resulted in a number of successful projects. The Royal Hawaiian groin which was completed in August of 2020 is working better than anyone had anticipated. The Kuhio Beach sandbag groin (completed November, 2019) and the Waikiki Beach Maintenance project (completed May, 2021) collectively have greatly stabilized the Royal Hawaiian Beach Sector. These are just some of the successful projects that the WBSIDA is proud to have been a part of. On May 9, 2023, the Waikiki Neighborhood Board unanimously adopted a resolution to support the DLNR's efforts to strengthen and improve Waikiki Beach and we ask the board to include that resolution in the record as well. Further a number of residents have submitted supportive testimony but are unable to attend today and we would like to acknowledge those testimonies.

The WBSIDA offers the following summary of project-specific comments.

- 1. The stated project objective to increase the resilience to climate change and coastal hazards cannot be overstated, this is an extremely common concern shared by Waikīkī stakeholders.
- 2. The proposed beach improvement projects in Waikīkī are essential for the future goal to maintain a viable beach in these areas. Several beachfront areas in Waikīkī are seeing the rapid deterioration of both public and private backshore infrastructure such as groins, seawalls and public walkways. This highlights the need to make long-term investments into beach stabilizing structures throughout Waikīkī in addition to more immediate emergency repairs to damaged infrastructure.

- 3. Climate change impacts including sea-level rise projected by the state of Hawai'i Climate Change Commission indicate significant flooding, wave overtopping and beach erosion in Waikīkī for the coming decades and suggest stakeholders and communities plan for 3.2 feet of sea-level rise now. This project has a strong climate change adaptation component that is consistent with the recommendations of the State Climate Commission.
- 4. A project benefit to cost analysis was completed by the U.S. Army Corps of Engineers in 2002 to determine Federal interest in restoring and improving Waikiki Beach, with a ratio greater than one indicating that benefits exceed costs⁵. The overall benefit to cost ratio for all of Waikiki was about 6 to 1. The total Waikiki Gross National Product (GNP) contribution to the annual Federal economy is an estimated \$3.3 billion. This estimate excludes spending by mainland west coast visitors.
- 5. The proposed projects are consistent with existing engineering standards and planning studies for Waikiki Beach improvements, and are capable of being implemented as phased or stand-alone projects.
- 6. The WBSIDA has agreed in concept, to provide a partial project match of up to \$3 million as part of a public-private partnership demonstrating the value and economic importance of this project to the stakeholders and community of Waikīkī.
- 7. Alternative groin design recommendations, including T-Head groins have been previously assessed and recommended as possible strategies for beach improvements in Waikīkī^{6,7}. Other examples such as the Royal Hawaiian Groin, Hawaii Kai channel entrance groin and Iroquois Point at Pearl Harbor all demonstrate the successful use of T-head groins in a similar nearshore setting.
- 8. Without a stabilizing and energy-buffering beach to protect public and private coastal infrastructure, we can anticipate even larger and more expensive structural repair and improvement projects to be required soon to prevent the destruction of threatened coastal structures including critical public access walkways and beaches that serve as important recreational and lateral access amenities.
- 9. The WBSIDA supports all the proposed projects in the FPEIS but would like to highlight and emphasize the urgent need for mitigation to wave and tide-induced impacts in the Halekulani (Gray's Beach) cell. The WBSIDA supports prioritizing some form of improvement in this section since this region demonstrates the most severe impacts which

The Waikiki Neighborhood Board strongly supports the proposed beach improvement project by the Hawai'i Department of Land and Natural Resources (DLNR). The DLNR proposes beach improvement and maintenance projects in the Fort DeRussy, Halekulani, Royal Hawaiian, and Kūhiō Beach sectors of Waikīkī. These projects include the construction of new beach stabilization structures, and the recovery of offshore sand and its placement on the shoreline. The objectives of the proposed actions are to restore and improve Waikīkī's public beaches, increase beach stability through improvement and maintenance of shoreline structures, provide and improve safe access to and along the shoreline, and increase resilience to coastal hazards and sea level rise. The proposed actions are intended to maintain the economic, social, aesthetic, recreational, environmental, cultural, and historical qualities of Waikīkī.

Over the past several years, and as recently as this year, Waikīkī has experienced record high tides (King Tides) that have exacerbated erosion and flooding. These events have highlighted the impacts of sea level rise on the beaches of Waikīkī. As sea levels continue to rise, beach loss will progressively degrade the recreational, social, cultural, environmental, aesthetic, and economic value of Waikīkī. The Royal Hawaiian groin was rebuilt in 2020, after nearly 50 years of no new beach stabilization projects in Waikīkī. We are now at a crossroads with a clear and increasingly urgent need to implement maintenance and improvements to the Waikīkī shoreline in order to preserve and protect this unique and highly prized natural resource.

We support comprehensive, forward-thinking improvement projects like those proposed and recognize its urgency. With the combination of beach erosion and King Tides, the backshore is frequently flooded, particularly during high surf events, accelerating damage to backshore infrastructure. Without beach improvements and maintenance, sea level rise is likely to result in total beach loss in Waikīkī before the end of the century and result in an estimated economic loss of \$50 million to \$150 million per hectare. The loss of Waikīkī Beach alone would result in an annual loss of \$2.223 billion in visitor

expenditures. Improvements and maintenance like those proposed in the DPEIS are necessary to restore and maintain the beaches of Waikīkī to continue to support Hawaii's tourism-based economy.

We offer the following summary of project-specific comments.

- The Waikiki Beach Special Improvement District has been a frequent presenter at the Waikiki Neighborhood Board and the board has voted to support this proposed Environmental Impact Statement to restore and improve the area known at Waikiki Beach.
- As described this project, or series of improvements is essential to the preservation of this area of
 Waikiki used by our residents for healthy exercise and to our visitors who travel thousands of
 miles to Waikiki.
- Unlike many communities that find fault with government projects, the cooperation between DNLR, the WBSIDA and the Waikiki Neighborhood Board, which represents the 25,000 or so residents, could be used as a model for future Beach preservation attempts in Hawaii.
- The body of this testimony addresses the monetary loss to the State of Hawaii but there is also the potential damage to our historic water front that includes so many World-Famous Hotels, the traditional Beach Services that host generations of Water men (and Water women) who hospitality is legendary in Waikiki.
- 1. The proposed beach improvement projects in Waikīkī are essential for the future goal to maintain a viable beach in these areas. Several beachfront areas in Waikīkī are seeing the rapid deterioration of both public and private backshore infrastructure such as groins, seawalls and walkways. This highlights the need to make long-term investments into beach stabilizing structures throughout Waikīkī in addition to more immediate emergency repairs to damaged infrastructure.
- 2. Climate change impacts including sea-level rise projected by the state of Hawai'i Climate Change Commission indicate significant flooding, wave overtopping and beach erosion in Waikīkī for the coming decades and suggest stakeholders and communities plan for *at least* 3.2 feet of sea-level rise now. This project has a strong climate change adaption component that is consistent with the recommendations of the State Climate Commission.
- 3. Without a stabilizing and energy-buffering beach to protect public and private coastal infrastructure, we can anticipate even larger and more expensive structural repair and improvement projects to be required soon to prevent the destruction of threatened coastal structures including critical public access walkways and beaches that serve as important recreational and lateral access amenities.
- 4. There is a need to balance and connect historical recreational beach uses with the maintenance of beach areas in the face of physical processes. This balanced management needs to account for the needs of a variety of user groups and needs and needs to consider the impacts of the effects of climate change and coastal storms.
