We are writing to express our strong opposition to extending expired permits to the developer RP21 Coco Palms LLC for the State land required to construct a 350-room luxury resort hotel on the former Coco Palms site in Wailua, Kaua'i.

As residents of Wailua Homesteads, we have witnessed the decline of the dilapidated ruins of the former Coco Palms fronting Wailua beach for thirty-one years. As Hawai'i taxpayers, we are left to ask, "What special privileges has our government continued to offer the ongoing slate of potential developers that has enabled this?" Ordinary residential law-abiding property owners wouldn't be allowed this many violations and transfer of expired permits over three decades. We are appalled that our own DLNR is supporting the developer's application for these expired permits and thus is operating against its own stated mission statement to "enhance, protect, conserve, and manage Hawai'i's unique and limited natural, cultural, and historic resources held in public trust."

This property is not suitable for development due to its protected wetland status, historic fishponds, Hawaiian burials and royal status, and because sea level rise is threatening the Wailua coastline as well as Kūhīo Highway. Wasn't it just last year that bulldozers were working to save the highway, when "king tides" had washed away most of the beach and land all the way up to the bike path? How brave those heavy equipment operators were as they operated their massive machines tilted at an angle on the narrow ribbon of sand left, the ocean lapping at their tires as they created and placed sandbags. Is our collective memory so short or our eyes too blind to see what's right in front of us?

Our small community, over capacity for tourist visitors, neither wants nor needs another hotel; what we do need is to work at enriching guest experiences by honoring our island's cultural heritage and accepting that the time has long passed for a hotel at this sacred and environmentally vulnerable site. We embrace the vision of the community group I Ola Wailuanui, who sees this site as a center for cultural enrichment, historic preservation, land conservation, and indigenous Hawaiian education and interpretation.

Since 1992, when Hurticane Iniki leveled most of Kauai there has been an increase in population and resorts on the island. we do not need another resort, let alone one that is being developed by a group that has no interest in the needs of Kauai. are now congested intersections near Wailua River and Kuhio Highway and the addition of a 300 + bedroom hotel will make things far worse. Such a development will add more negative impact to the quality of life for those traveling the roads nearby (who are numering in the tens of thousands), safe operation for the nearby waste water treatment plant that is already ailing, for the environmental protection of the ocean and river whose waters are very likely to be polluted with the demolition and construction because of a high water table and direct connection between the site's drainage canal behind the hotel which runs under Kuamo'o to the Wailua River. I am a resource teacher in creative arts and Hawaiian studies and have taught principally in schools from Kapa'a to Hanalei but have taught at all public elementary schools throughout the island as well. I am a hula practitioner and have been teaching a small class in hula for over 20 years.

It is my kuleana to once again write to you to please consider the following points when receving updates from Coco Plams LLC.

That hotel flourished in a time much different than today. Currently the traffic flow is horrendous in that area. That is a limited land area with an already too dense traffic flow. Putting a big resort there would create insurmountable infrastructure challenges. The community has been pointing this out for many years.

Please also consider the following very important facts.

- <!--[if !supportLists]-->• <!--[endif]-->Without the Revocable Permits (RPs), which were terminated by the BLNR in August 2023, one parcel of which was designated for parking, the developers do not have space for the legally required number of parking stalls for a 350-room resort;
- <!--[if !supportLists]-->• <!--[endif]-->The environmental, cultural, traffic, and other assessments are inadequate and outdated;
- <!--[if !supportLists]-->• <!--[endif]-->No shoreline setback survey has been conducted;
- <!--[if !supportLists]-->• <!--[endif]-->No required workforce housing sites have been obtained by the developer;
- <!--[if !supportLists]-->• <!--[endif]-->No NPDES (National Pollutant Discharge Elimination System) has been obtained; and

Aloha Chair and Board Members,

I am offering this testimony today as a resident of Wailua Homesteads on Kaua'i, a grandfather with children and grandchildren born and raised in this ahupua'a, the former Director of the Office of Environmental Quality Control (OEQC), former State Senator representing Kaua'i and Ni'ihau, and former 4 term member of the Kaua'i County Council -

To be clear, this testimony is in strong opposition.

I cannot understand why the BLNR would consider granting any easements, revocable permits, leases, or right-of-entry to an entity that is now under investigation for grading, grubbing, and other destructive activity on state conservation lands without permits AND who has been trespassing on these lands for the past year AND whose intention is to use these state lands to support a resort development without conducting at the minimum an environmental assessment to determine impacts.

This proposal is especially puzzling because a local, credible, Kaua'i based community organization also seeks to manage these lands for the benefit of the broader community in a manner that protects the significant environmental, cultural, and cultural elements contained within this area.

Therefore to reiterate, this testimony is in strong opposition to this agenda item.

However, in the event any easements, revocable permits, leases, or right-of-entry is granted, I strongly encourage the BLNR to ensure compliance with HRS343 and require at the minimum an environmental assessment fully disclosing potential environmental impacts from the planned use of these parcels as part of the proposed resort development.

An outline of the facts:

- 1) RP- 21 and related entities are presently under investigation for grading and grubbing and cutting down coconut trees on State land and on conservation lands without the appropriate permits or permission from the State of Hawai'i.
- 2) I have personally witnessed and photographed the grading and grubbing and seen in person

the many fresh cut stumps being dug up by workers for the developers.

- 3) BLNR leadership has already acknowledged that RP-21 has no legal authority nor any permission in writing from the BLNR to intrude upon or utilize the State lands in question.
- 4) RP-21 on a daily basis operates their equipment upon these same properties. Since they possess no valid State Lease nor any valid RP's, they are essentially trespassing on State land. They have constructed barriers preventing others from accessing these properties. They also conduct grading and grubbing on the property (without the presence of a qualified archeological observer), and actively utilizes these lands to facilitate and support the ongoing development of adjacent lands I personally witness this activity on a regular basis as I drive and walk by these properties on a daily basis.
- 5) Any new lease or revocable permits issued on these lands trigger HRS323 and thus any proposed use that accompanies the granting of any new lease, revocable permit, right of entry, or easement must require an environmental review in order to comply with the law.
- 6) These lands are situated in environmentally sensitive areas with unquestionable historical and cultural significance. They are located in a coastal tsunami zone, clearly impacted by issues relating to sea level rise, adjacent to wetland areas, currently and historically impacted by frequent flooding, known habitats for rare native birds, and include ancient fishponds and waterways that connect to and ultimately drain into the Wailua River and nearby ocean.
- 7) The RP-21 and related entities involved in the proposed CocoPalms resort development have unambiguous and specific plans to utilize these State lands to facilitate and support their planned resort.
- 8) Allowing the use of these State lands in conjunction with the planned resort commercial development will contribute directly to increased impacts on the shoreline, nearshore water quality, and further degrade existing cultural, historical, and archeological elements.
- 9) I Ola Wailuanui, a community based nonprofit has formally applied to lease and or secure the required RP's in order to provide appropriate community stewardship of these lands in a manner that protects the environment, honors the historical and cultural significance, and is beneficial to the entire community.
- 10) Any and all entities that are granted a lease or RP to these lands must be required to comply with HRS Chapter 343 and at the minimum conduct an Environmental Assessment (EA) of their proposed uses and impacts, and conduct a full Environmental Impact Statement (EIS) if those proposed uses and impacts are related to the facilitation of new resort development.

First, I am disappointed that this item is on the agenda for consideration at this time when I Ola Wailua Nui's Application, filed under their 501(c)(3) community nonprofit corporation, to preserve the Coco Palms site as a park and historic cultural center is still under consideration and they applied earlier for RPs to the same 3 parcels of land that the Coco Palms developers are also trying to obtain. [(4) 4-1-003:044; (4) 4-1-005:por. 017; (4) 4-1-003:017] Next at the recent hearing on November 9, 2023, the judge found that the Land board continued to renew the Coco Palms Ventures LLC revocable permits from 2017 to 2022 for a "defunct entity". Then RP21 Coco Palms LLC did irreparable damage having contractors cut down at least 75 palm trees from state land without prior notice to or consent from the State. On April 19, 2023, the Office of Conservation and Coastal Land Management served RP21 with a Notice of Violation and Order requiring them to Cease the activity and answer for the trespass and damage to state property. Thank you to DLNR staff for proposing, for the first time ever, to give A&B a reasonable amount of water based on its actual needs and uses. I urge the board to honor the staff's recommendation and approve setting the maximum diversion amount from East Maui's streams at 27.4 million gallons a day.

I also urge the board to reject the proposal to allow the Chair to increase this cap without giving the board or the public any notice, much less a chance to review and comment. As the board knows, we have been experiencing unprecedented and ongoing drought conditions, and yet there are current proposals to grow more thirsty citrus trees in Central Maui than East Maui's streams may be able to handle. Increasing stream diversions during a time when our streams may be seeing less water than ever before may have significant impacts on the public's many interests in our public trust water resources. The board must not abdicate its kuleana to conduct its own due diligence and independent review, informed by public and expert input, in its oversight of East Maui's public trust resources.

Finally, I urge the board to mandate as a condition of this permit that A&B and Mahi Pono fix their diversion infrastructure and to use lined reservoirs, so that we can finally stop the waste of millions of gallons of water per day. Again, our drought conditions only emphasize the preciousness of our water resources, and such massive amounts of water waste can no longer be tolerated. The use of lined reservoirs in particular will allow Mahi Pono to grow much more food using much less water from East Maui's streams, and provide a much more stable amount of available water during potential water shortages and to fight fires.

My name is Alex Remy and I am reaching out to testify in support of the restoration of the Coco Palms Resort and, in particular, the disposition of lands to RP21.

These lands have long been designated as part of the Coco Palms Resort Historic District under both state and national historic registers. In addition, since 1962 these lands have been assigned to the owners of the Coco Palms Resort. Based on this historic information, these lands should continue to be used accordingly and disposed to RP21.

These lands will be used to fund various public benefits that would be funded entirely by Coco Palms. Namely, public parking space, public restrooms, and public access to historic lands that would otherwise be taken away.

The Coco Palms restoration has already been approved, and the Kauai County Planning Commission and Director have affirmed that the restoration is property permitted and ready to move forward.

Finally, the Board needs to consider the incredible economic benefits that will result from approving the disposition of these lands to RP21. First, the construction effort will generate significant job activity for the local community, with an expected job count for 300. In addition, once the resort is completed, roughly 400 full-time jobs will be generated and benefit the local labor market. Finally, the restoration effort is expected to generate \$300,000,000 in direct economic activity to Kauai.

Aloha Chair Chang and members of the Board of Land and Natural Resources,

The Sierra Club of Hawai'i stands with the Sierra Club Kaua'i Group in **OPPOSITION** to the premature issuance of easements and other access rights to the owners of the former Coco Palms resort property, and adds the following notes for the Board of Land and Natural Resources' (BLNR's) consideration.

As the BLNR likely knows, Coco Palms developers have not been required to comply with the same modern permitting requirements and standards as any other developer on Kaua'i. This is because their special management area permit has been considered "grandfathered" under a now-repealed ordinance that was to enable the rapid rebuilding of Kaua'i after Hurricane 'Iniki. However, there are many reasons why they should. Over the last 30 years, since Hurricane 'Iniki struck the island:

- There has been significant coastal erosion of the shoreline fronting the Coco Palms property, such that the decades-old certified shoreline its current developers rely upon no longer exists;
- The island population has also increased from 54,000 in 1992 to more than 70,000 today:
- There are considerably more tourists and rental cars on the road; and

 We have much more evidence and understanding of the impacts of the climate crisis and the need to consider climate resilience and sea level rise in land use and development decisions.

Moreover, community concerns have only grown regarding the impacts that resort redevelopment may have on Native Hawaiian burials and cultural sites in this area of great cultural and historical significance, and the community has now put forward their own vision for a culturally grounded, community-centered site appropriate to the history and character of Wailuanuiahoʻāno.

Notably, the current envisioned use of the Coco Palms property may also have significant impacts on adjacent properties including the state-owned parcels under consideration today.

All of the aforementioned things, and more, should be considered in a modern permit application before any redevelopment of the Coco Palms property is allowed to begin. At minimum, the current Coco Palms property owners should be required to apply for a special management area permit with a shoreline certification based on current facts and regulatory protections, *before* they commence with any redevelopment plans – and not be allowed to ignore reality using an allegedly "grandfathered" permit issued over 30 years ago.

Accordingly, please deny the staff recommendation to issue easements, rights of entry, and revocable permits that would only facilitate the premature and foolhardy redevelopment of the Coco Palms property.


