CURRENT USE STATUS:

Land presently encumbered by Governors Executive Order No. 3074, dated August 20, 1981, setting aside 4,204.10 acres designated as KOA under the control and management of the State of Hawaii, Department of Transportation (HDOT) for Airport Purposes.

CHARACTER OF USE:

SWA will use the space for ground service equipment parking as part of its signatory airline carrier operation at KOA.

COMMENCEMENT DATE:

To be determined by the Director of Transportation at a later date.

MONTHLY RENTAL:

\$296.41 (based on the improved, paved land rate of \$3.43 per square foot, per annum, as determined from the HDOT schedule of rates and charges established by appraisal of Airports property statewide).

CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

HDOT has determined the subject land area pertaining to this action was evaluated for environmental impact by the Keahole Airport Master Plan Final Environmental Impact Statement (EIS), published in The Environmental Notice on November 8, 1988, and accepted by the Governor on December 19, 1988. This action is consistent with the 1988 EIS and the same mitigation conditions apply.

REMARKS:

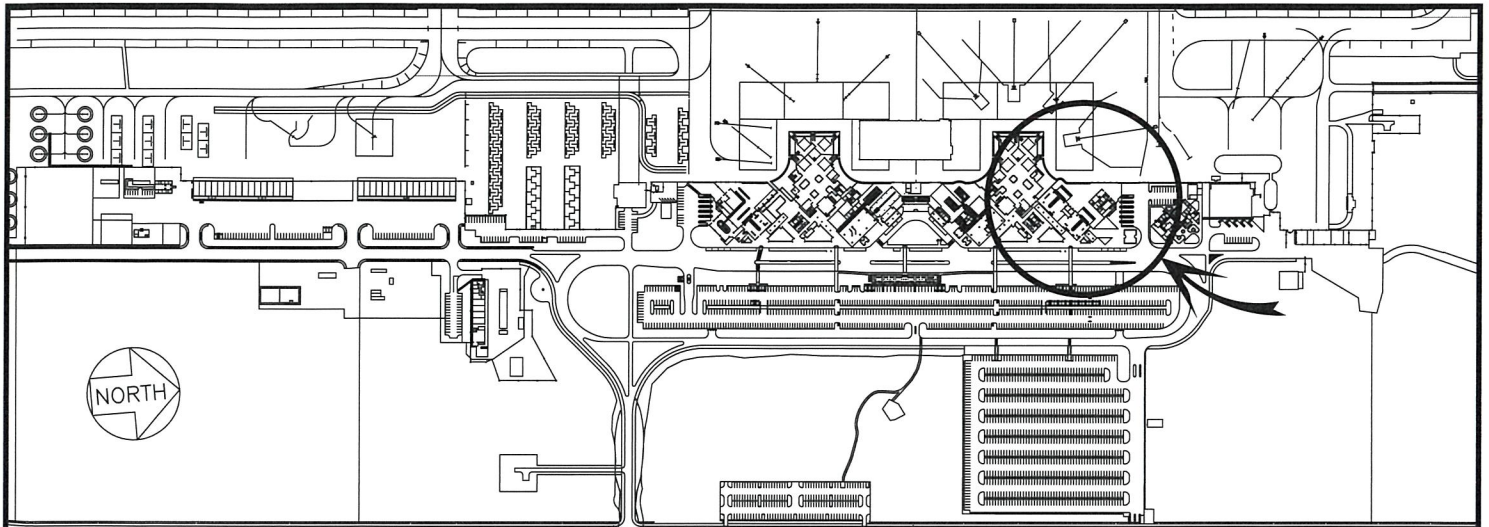

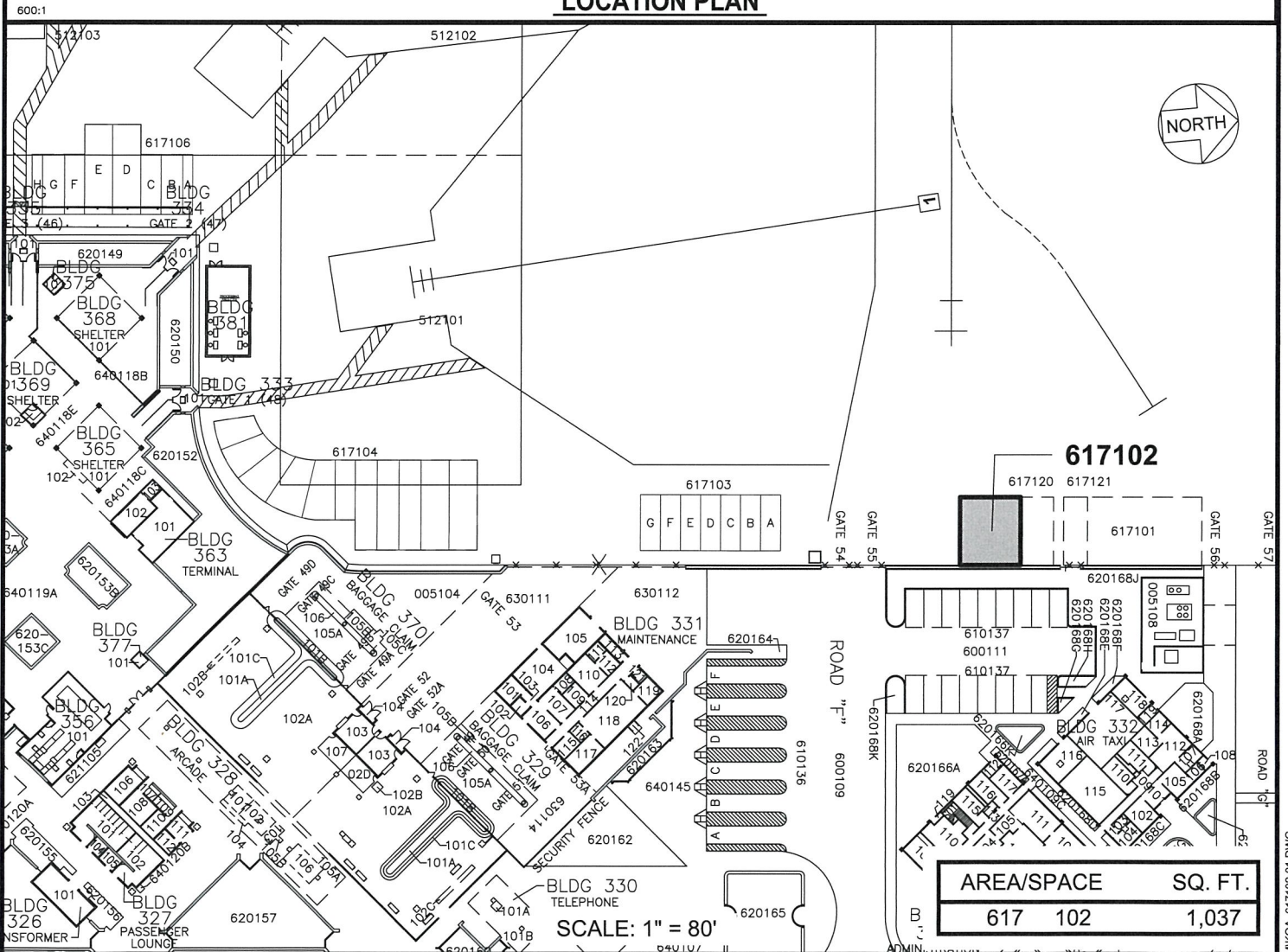
