Film production for upcoming television series production, "Rescue: HI Surf".

TERM OF RIGHT-OF-ENTRY:

January 17, 2024 to May 31, 2024.

CONSIDERATION:

\$0.10 per square foot per day was adopted by the Board at its meeting of September 28 2001 (item D-4), as the rent for any right-of-entry permit. Using this unit rate, the applicable rent for the subject request would be $15,000 \text{ sf x } \$0.10 \text{ x } 136 \text{ days} = \frac{\$204,000}{\$1,500 \text{ per day}}$, or \$1,500 per day.

\$1,500 per day for 15,000 square feet of exclusive use along shoreline property does not seem unreasonable. Staff understands that permit fees for film production on private land can generate \$1,000 per prep and wrap day and \$4,000 per shoot day.

CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

In accordance with Hawaii Administrative Rules ("HAR") § 11-200.1-15 and the Exemption List for the Department of Land and Natural Resources reviewed and concurred on by the Environmental Council on November 10, 2020, the subject request is exempt from the preparation of an environmental assessment pursuant to General Exemption Type 1, that states "Operations, repairs or maintenance of existing structures, facilities, equipment, or topographical features, involving negligible or no expansion or change of use beyond that previously existing," Part 1, Item 44, that states the "Permits, licenses, registrations, and rights-of-entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing". See **Exhibit B**.

REMARKS:

Recently, State Film Office advised the division about a new television series called *Rescue: HI Surf*, which is officially set to start filming on January 17, 2024. It is a 12-episode production anticipated to air in fall 2024. One of the filming locations targeted by the production is the Papailoa Beach in Haleiwa. The main theme of the series is lifeguards in Hawaii with a lifeguard tower placed on the subject location being the main set of the upcoming series.

In addition, Applicant plans to place a stationary jet ski (on trailer) and cars, and other

equipment next to the lifeguard tower to create the background for the lifeguard daily activities. An ATV will also be filmed operating during the production. Actual filming will not be conducted every day and the applicant will provide 24/7 security to maintain set dressing items and equipment. No nighttime filming will be allowed as bright production lights may be pointed out to sea at night and generate some negative impact to birds. Lateral access for the public along on the beach will not be prohibited other than actual rolling of the camera. The production will utilize the adjacent (mauka) private parcel for staging and parking purposes during the production, leaving only the lifeguard tower on the beach at night and on non-production days.

Further, the production indicated that they received support from the community including the business sector about the upcoming production. A local consulting firm hired by the applicant was tasked to reach out to the community for any comments on the production. At the time of writing this submittal, staff did not receive any formal communications between the applicant and the community, e.g., neighborhood board, about the latter comment on the subject request. In view of the tight timeline between the commencement of the production and the Board meeting schedule, staff reminded the applicant bring the comments from the community to the Board meeting.

Office of Conservation and Coastal Lands authorized the placing of the lifeguard tower via its Site Plan Approval (SPA OA-24-21) dated December 28., 2023 (Exhibit C).

Office of Conservation and Coastal Lands and the Division of Boating and Ocean Recreation do not have any comment or objection to the request.

There are no other pertinent issues or concerns, and staff recommends the issuance of the requested right-of-entry permit.

<u>RECOMMENDATION</u>: That the Chairperson:

- 1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200.1, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
- 2. Authorize the issuance of a right-of-entry permit to Bumper Productions LLC, covering the subject area under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
 - A. The standard terms and conditions of the most current right-of-entry permit form, as may be amended from time to time; and
 - B. Terms and conditions of Site Plan Approval (SPA OA-24-21) dated December 28, 2023;
 - C. Lateral shoreline access shall not be prohibited except during the actual rolling of the camera;

- D. No filming or setting up lighting pointed out to the sea at nighttime is allowed; and
- E. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.

The Office of Conservation and Coastal Lands (OCCL) is in receipt of your Site Plan Approval (SPA) application regarding the installation of a lifeguard tower in the vicinity of Papailoa Beach. (**Exhibit 1**). For reference, the project area is located on submerged lands seaward (*makai*) of the subject parcel within the State Land Use (SLU) Conservation District, Resource Subzone.

The proposed project site is located on the northern coast of the island of Oʻahu. There are no existing building or structures nearby on the beach. There is naupaka and shoreline vegetation that separates the beach from the vacant private property. The beach is used for recreation with all manner of water activities (i.e., swimming, snorkeling, fishing) being enjoyed, as well as contemplation. Cultural and traditional uses practiced here would most likely be similar to other beaches in the vicinity.

PROPOSED LAND USE

The proposed land use is to install a lifeguard tower as part of the film set to produce a television series currently entitled "Rescue: HI Surf". The lifeguard stand is approximately 15.5-ft high; 15-ft wide; and 16.6' long with a 17' ramp and will be occupying space of approximately 260-ft². **(Exhibit 2)** The stand is made of fiberglass and requires little maintenance. The set is proposed to be on the beach until May 31, 2024. All evidence of the land use shall be removed upon completion of filming. While filming will not take place every day, the set will be maintained. Security shall be provided 24 hours/ 7 days a week.

Sand may be redistributed to level the area of the placement of the lifeguard stand. The skid attached to the platform will aid in keeping the tower in place. Water barrels as well as reenforced steel from the platform may also be used to stabilize the tower. Should extra high

tides affect the stability of the tower, the following protocols will be taken: 1) Communication with water safety officiates; 2) Implement best management practices; and 3) if required, relocate the tower until the high tide event is over.

Biological and cultural monitors shall be on site to notify the crew of any endangered fauna that may visit the site; bird activity; and cultural finds. For endangered species, the federal buffer of 50-feet shall be observed and no actions within the buffered area will take place until the animal leaves the area. For endangered bird nesting activities and burrows, all work will stop in the area and a buffered area will be created. The area will be avoided, or the monitors will advise on the next course of action. Bird Best Management Practices shall be observed. (Exhibit 3). While cultural monitors will be present, given the dynamic shoreline processes that take place, burials are not expected makai of the shoreline.

ANALYSIS

The temporary installation of a lifeguard tower as part of a film set is considered an identified land use in the State Land Use Conservation District pursuant to the Hawai'i Administrative Rules (HAR) §13-5-22, P-8 (B-1) Demolition, removal, or minor alteration of existing structures, facilities, land, and equipment.

In conformance with Hawai'i Revised Statute (HRS), Chapter 343, as amended, and HAR §11-200.1-16(a)(1), the proposed use falls under General Exemption Type 3, which applies to "Construction and location of single new, small facilities or structures and the alteration and modification of same and installation of new, small, equipment and facilities and the alteration and modification of same..."; and pursuant to the Exemption List for the Department of Land and Natural Resources (DLNR) dated 11/10/2020, specifically: Part 1 #9, "Construction and location of new, small facilities or structures necessary to support or enhance public recreational use of lands and waters, such as outdoor showers, signage, interpretive kiosks, viewing platforms, tables, grills, lifeguard stations, improvements necessary for compliance with the Americans with Disabilities Act, and other similar structures; and HAR §11-200.1-16(a)(1) General **Exemption Type 4** Minor alteration in the conditions of land, water, or vegetation; and DLNR exemption list, Part 1 #7. Minor ground adjustments (e.g., grading, grubbing, cutting, clearing, or filling) that do not require grading permits. The Land Division concurred with the proposed exemption.

Site Plan Approval authorization is hereby granted to Kevin Foster of Bumper Productions, LLC for the installation of a Lifeguard Tower for the Rescue Hi Surf Film Set located at Kawailoa, Waialua, O'ahu, Makai of Tax Map Key: (1) 6-2-001:001, subject to the following conditions:

- 1. The permittee shall comply with all applicable statutes, ordinances, rules, and regulations of the federal, state, and county governments, and applicable parts of this chapter;
- 2. The permittee, its successors and assigns, shall indemnify and hold the State of Hawaii harmless from and against any loss, liability, claim, or demand for property damage, personal injury, and death arising out of any act or omission of the applicant, its successors, assigns, officers, employees, contractors, and agents under this permit or relating to or connected with the granting of this permit;

- 3. The permittee shall obtain appropriate authorization from the department for the occupancy of state lands;
- 4. The permittee shall comply with all applicable department of health administrative rules;
- 5. Unless otherwise authorized, the duration of the placement of the lifeguard tower as part of the film set shall be completed by July 1, 2024. All introduced materials shall be removed and the site restored to a condition acceptable to the department;
- 6. The permittee understands and agrees that the permit does not convey any vested right(s) or exclusive privilege;
- 7. In issuing the permit, the department and board have relied on the information and data that the permittee has provided in connection with the permit application. If, subsequent to the issuance of the permit such information and data prove to be false, incomplete, or inaccurate, this permit may be modified, suspended, or revoked, in whole or in part, and the department may, in addition, institute appropriate legal proceedings;
- 8. Where any interference, nuisance, or harm may be caused, or hazard established by the use, the permittee shall be required to take measures to minimize or eliminate the interference, nuisance, harm, or hazard;
- 9. Obstruction of public roads, trails, **lateral shoreline access**, and pathways shall be avoided or minimized. If obstruction is unavoidable, the permittee shall provide alternative roads, trails, lateral beach access, or pathways acceptable to the department;
- 10. For the duration of the project, appropriate mitigation measures shall be implemented to minimize impacts to the land, ocean, flora and fauna, and other natural and cultural resources;
- 11. The activity/use shall not adversely affect a federally listed threatened or endangered species or a species proposed for such designation, or destroy or adversely modify its designated critical habitat;
- 12. The activity/use shall not substantially disrupt the movement of those species of aquatic life indigenous to the area, including those species, which normally migrate through the area;
- 13. When the Chairperson is notified by the public that an individual activity deviates from the scope of the activity/uses, or activities are adversely affecting fish or wildlife resources or their harvest, the Chairperson will direct the applicant(s) to undertake corrective measures to address the condition affecting these resources. The applicant(s) must suspend or modify the activity to the extent necessary to mitigate or eliminate the adverse effect;
- 14. When the Chairperson is notified by the U.S. Fish and Wildlife Service, the National Marine Fisheries Service or the State Department of Land and Natural Resources that an individual activity/use or activities conducted under this authorization is adversely affecting fish or wildlife resources or their harvest, the Chairperson will direct the

applicant(s) to undertake corrective measures to address the condition affecting these resources. The applicant(s) must suspend or modify the activity to the extent necessary to mitigate or eliminate the adverse effect;

- 15. The permittee acknowledges that the approved work shall not hamper, impede, or otherwise limit the exercise of traditional, customary, or religious practices of native Hawaiians in the immediate area, to the extent the practices are provided for by the Constitution of the State of Hawaii, and by Hawaii statutory and case law; and
- 16. Other terms and conditions as prescribed by the chairperson.
- 17. Failure to comply with any of these conditions shall render a permit void, as determined by the chairperson or board.

Seabird Best Management Practices for Shoreline Vegetation Management For OCCL Shoreline Encroachment Enforcement

October 20, 2021

Background

There are about 20 different indigenous seabird species on O'ahu--all protected by state and federal law. The most common is the Wedge-tailed Shearwater (*Adrenna pacifica*). Wedge-Tailed Shearwaters (WTSH) are seasonal ground nesting seabirds. LA majority of the larger colonies are located on State managed offshore islet Wildlife Sanctuaries (https://dlnr.hawaii.gov/wildlife/sanctuaries/). Smaller subcolonies often pop up in areas that are close in proximity to the large offshore islet colonies. Nesting colonies generally seen on the main island of Oahu are composed of WTSH, which are the most numerous and tolerant species in regard to urban interactions.

Naupaka (*Scaevola taccada*) is a common coastal shrub that provides the most common WTSH nesting habitat. Birds may nest directly in the shrub or dig burrows in and around shrubs. Burrow collapses caused by walking in a nesting area is an extremely detrimental activity that can directly kill birds. Burrows are not always easily visible, so it is imperative to conduct proper and comprehensive surveys when looking at potential nesting colonies.

Per Hawaii Revised Statutes, §13-124 the following activities are prohibited in regard to Wedge-Tailed Shearwaters:

- Catch, possess, injure, kill, destroy, sell, offer for sale, or transport any such species, or any young or egg, or the dead body or skin thereof;
- No person shall remove, damage, or disturb the nest of any indigenous wildlife except as provided in subsection

A full set of the rules can be found here: https://dlnr.hawaii.gov/dofaw/files/2013/09/Chap124a.pdf In order to avoid violations to the Administrative Rules, the following Best Management Practices (BMPs) are recommended:

Best Management Practices

- All work should be done non-nesting season for seabirds (December March)
- If work must proceed during the nesting season (March November) the area must be surveyed to ensure there are no signs of nesting or no birds present.
 - Use of a qualified Wildlife Biologist to conduct the survey is suggested
 - o If survey is not done by qualified personnel, conditions should be documented by photo with proof of date included.
 - Inspect the encroaching vegetation for signs: seabird poop, webbed footprints, grayish/white brood feathers, burrows, and other obvious indicators

- If a seabird is found while trimming vegetation, all activities shall be immediately postponed until nesting season is done or under the direction of a qualified wildlife biologist.
- If a seabird is injured during work the bird should be immediately taken to Feather and Fur Animal Hospital. (25 Kane'ohe Bay Dr Ste 132, Kailua, HI 96734). All costs for care and rehabilitation of the bird will be assumed by the violating party.

Any work conducted that results in take of a protected species is subject to enforcement action.
