<u>CHAPTER 343 – ENVIRONMENTAL ASSESSMENT:</u>

In accordance with Section 11-200.1-15, Hawaii Administrative Rules (HAR) and the Exemption List for the Department of Land and Natural Resources, reviewed and concurred by the Environmental Council on November 10, 2020, the subject request is exempt from the preparation of an Environmental Assessment pursuant to General

Exemption Type 1, "Operations, repairs or maintenance of existing structures, facilities, equipment, or topographical features, involving minor expansion or minor change of use beyond that previously existing," Part 1, Item No. 44, which states, "Permits, licenses, registrations, and rights-of-entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing."

JUSTIFICATION FOR REVOCABLE PERMIT:

The issuance of revocable permit is a short-term measure which will allow staff to test the market to determine if it's practicable to seek the issuance of concession contract for a food truck at this location.

REMARKS:

The Wailoa Small Boat Harbor in Hilo on Hawaii Island is frequently used by fisherman. It would be beneficial to have a concessionaire like Belly Rolls, LLC to provide hot meals and beverages to the harbor users and community.

Staff sent a copy of this submittal to DLNR Division of Aquatic Resources (DAR), DLNR Office of Conservation and Coastal Lands (OCCL), DLNR State Parks, Department of Health (DOH) Food Safety Branch, and County of Hawaii Department of Planning for their review and comment and their response are as follows:

The applicant has not had a lease, permit, easement, or other disposition of State lands terminated within the last five years due to non-compliance with such terms and conditions.

RECOMMENDATION:

That the Board of Land and Natural Resources:

 Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200.1, Hawaii Administrative Rules, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.

- Based on the testimony and facts presented, the Board finds that approving the revocable permit under the conditions and rent set forth herein will serve the best interests of the State.
- 3. Authorize the issuance of Revocable Permit to Belly Rolls, LLC covering the subject area for a mobile food concession under the terms and conditions cited above, which are by this reference, incorporated herein and further subject to the following:
 - a. The standard terms and conditions of the most current Revocable Permit form, as may be amended from time to time;
 - b. Review and approval by the Department of the Attorney General.
 - c. The Applicant is required to apply for a Special Management Area Use Permit (SMA) to be reviewed and approved by the County of Hawaii Department of Planning.
 - d. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.
