I oppose the rule changes to expand hunting opportunities in these areas

First off HB 1872 passed into law in 2022, which the DLNR is to provide quality habitat and this includes water for OUR game animals and game birds. If the DLNR was pro active in wildfire prevention you would have controlled burning of mature fountain grass in small areas that the ungulates would be able keep under control with grazing the new growth. As is seen along saddle road that burnt several hundred acres of fountain grass. Goats, sheep and turkeys moved into this burnt area keeping the fountain grass under control and the native shrubs were able to establish themselves with the help of the goats and sheep.

There are plenty of studies of ungulates being used to keep grasses under control for the use of fire prevention in the western states. We should be utilizing these animals in fire prevention not trying to eradicate the herds.

Look at your own East Hawaii Biolagist Kanalu Sproat paper "Have your cake and eat it too" which lays out the benefits of the game animals controlling wildfires on the big island.

During drought conditions the animals are congregating in the 50 yard no hunting zone where they can't be hunted anyway.

With today's modern bows and crossbows, are able to send an arrow up to a hundred yards, creating a new hazard of arrows going into the roads.

High hunting pressure is going to do several things first it's going to push the animals into non hunting areas creating a larger nuisance with the animals interacting with the public in a non positive way. Second the animals close to the road are going to be pushed into the road trying to get away from the hunters and or learn they are safe next to the road. These animals are capable of learning where food, water and safety can be found.

Supplying quality habitat that includes sufficient water will be a much better way to encourage the animals away from the road side

The current season is taking a toll on the wild turkey numbers and making it difficult for a sustainable population to exist due to over hunting. Along with natural conditions that we cannot control, that may make the population decrease even more ,that also affects our wild turkey population. So you may have a big harvest in the fall but no harvest in the spring.

Turkey hunting has become so popular nationwide. Other states that are experiencing the same situation with their turkey numbers have closed their fall turkey seasons to help build back sustainability in their wild turkey numbers. I have met hunters here and from the mainland that want to harvest a wild turkey in all states that allow it. It is a very challenging type of hunt that involves special equipment and skills.

When I worked for a large ranch on the Big Island I realized the Spring turkey hunting has become very popular that Hawaii Island has become a tourist sportsmen destination during March and April for the spring turkey season. Usually the people with the means will book hunts with guides on private ranches and the more budget friendly options is to hunt on public lands. I met lots of them over the years. Non Resident Hunters and their families travel to the Big Island for a spring vacation and for spring turkey hunting thus bringing in a tourist economy to our local businesses and island. Spring turkey hunting is gaining popularity with our resident hunters and families thus adding to our treasured hunting traditions and bringing food to our tables. Of the out of state hunters that I have met usually tell me "My wife and kids are shopping and I will meet them after the hunt and go to the beach."

I really feel that our fall turkey season should be changed back to ONLY the month of November with hunting permitted only on the weekends and holidays with a daily bag limit of one turkey to help our turkey numbers get back to stable numbers. I feel it is a better option than having a long fall season with mostly young birds harvested, then having to scramble to close the next season due to low numbers.

Re: Testimony against hunting rule changes for Pu'uanahulu and Pu'uwa'awa'a, March 8, 2024, 9 am Board meeting.

I oppose rule changes to expand hunting opportunities in these areas.

In 2022 HB1872 passed through the Legislature and became law. HB1872 required an amend to the HRS and requires the State to recognize that, "Game mammals and game birds provide a sustainable food source that merits high-quality habitats with sufficient food, water, and refuge to support viable populations sufficient for hunting." This new law has gone unrecognized by the DLNR.

The purpose of the proposed rule changes is to reduce the hazard of roadside goats and pigs. Roadsides often provide water catchment and become attractive to thirsting animals. Clearings along roads also cause fresh vegetation growth, drawing the wild goats and pigs.

This results from game animals being drawn away from poor habitats. The deprivation of watering units, the lack of habitat improvements, and the fencing off of quality habitats cause animals to become roadside hazards, and not the overpopulation of game animals. Reducing the population of game animals by extreme hunting opportunities is eradication, and not game management for a sustainable resource and sufficient hunting opportunities for the future. Over hunting will also drive the remaining animals out of GMA's and into private lands.
