- A. Introducing Ryan Kanaka'ole as the Board of Land and Natural Resources (BLNR) Chair's Designee- Also introduced DAG Ching as MKSOA Board Counsel
- B. Report on the Senate Higher Education Committee Hearing regarding the Sunshine law- Majority of hearing dealt with University of Hawai'i (UH) Board of Regents difficulties due to Sunshine Law, Senators showed interest in the experienced operational challenges. Chair related Sunshine Law-related communication difficulties as they affect standing up a new State agency. Attorney General's office has drafted a bill intended to remedy UH Regents' concerns, MKSOA also has a bill being introduced to allow greater ease of communications for the duration of 5-year transition period while still upholding the intention of Sunshine Law in its other aspects.
- C. Report on the Senate Water and Land Committee Hearing regarding SB 2297—The bill would in effect revert the BLNR to being the final authority on matters regarding the Mauna Kea lands over that of MKSOA and enforcement powers remaining with the Division of Conservation and Resources Enforcement (DOCARE). Bill passed committee, although the two aye votes aside from the Committee Chair's were made with reservations.
