Item L.1. Approval of Dole Food Company Inc.'s Schedule for the Removal of Wahiawa Dam (OA-0017), Wahiawa, Oahu, Tax Map Keys, (1) 7-1-012:014, (1) 7-3-013:003, (1) 7-3- 012:002, and (1) 7-3-007:001.

Chairperson Chang and members of the Board of Land and Natural Resources:

I am Blake Oshiro, Governor's Senior Advisor and provide this testimony on behalf of he Office of the Governor. We support this request. Pursuant to Act 218, Session Laws of Hawaii 2023 ("Act 218") (see Exhibit 3), funds were appropriated to upgrade the dam's spillway and authorized various state agencies to acquire the Wahiawa Irrigation System (WIS), which includes the Wahiawa Dam

The Act specifies that::

The office of the governor shall negotiate with Wahiawa Water Company, Inc.; Dole Food Company, Inc.; Sustainable Hawaii, LLC; or any other appropriate owner for the State's fee simple acquisition of the Wahiawa irrigation system.

Act 231, Section 3(a), Session Laws of Hawaii 2023.

Our office has conducted preliminary discussions to fulfil the provisions of this law, but there remain significant and substantive steps before meaningful negotiations can proceed. As such, we understand that this request before the Board is to provide the applicant with a different time schedule with which our office hopes to concurrently also proceed with steps to advance the negotiations.
