Issuance of Right-of-Entry Permit to Hawaii Explosives & Pyrotechnics, Inc. for Fireworks Ground Display at Duke Kahanamoku Lagoon on Friday, June 7, 2024, Waikiki, Honolulu, Oahu, Tax Map Key: (1) 2-3-037: portion of 021.

APPLICANT:

Hawaii Explosives & Pyrotechnics, Inc., a Hawaii profit corporation.

LEGAL REFERENCE:

Section 171-55 and Chapter 343, Hawaii Revised Statutes (HRS), as amended.
Chapter 11-200.1, Hawaii Administrative Rules (HAR), as amended.

LOCATION:

Portion of Government lands situated at Waikiki, Honolulu, Oahu, identified by Tax Map Key: (1) 2-3-037: portion of 021, as shown on **Exhibit A**.

AREA:

Firing zone (approximate) 17,671.5 square feet

ZONING:

CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

In accordance with Hawaii Administrative Rules ("HAR") §11-200.1-15 and -16 and the Exemption List for the Department of Land and Natural Resources reviewed and concurred on by the Environmental Council on November 10, 2020, the subject request is exempt from the preparation of an environmental assessment pursuant to General Exemption Type 1 for "[o]perations, repairs or maintenance of existing structures, facilities, equipment, or topographical features, involving negligible or no expansion or change of use beyond that previously existing." Specifically, the subject request is exempt under Part 1, Item 44, which applies to "[p]ermits, licenses, registrations, and rights-of entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing."

APPLICANT REQUIREMENTS:

Applicant will be required to post a deposit of \$2,500 to ensure timely clean-up after the event described above. Payment shall be made in the form of a certified check payable to the Department of Land and Natural Resources. The deposit may be held by the Department for up to seven (7) days after the scheduled

fireworks event and, if not forfeited under the conditions discussed below, will be returned to the Applicant.

REMARKS:

At its meeting on April 26, 2024, under agenda item D-12, the Board approved an annual right-of-entry permit to Hawaii Explosives & Pyrotechnics, Inc. (HE) for the setup and firing of public fireworks displays at Duke Kahanamoku Beach, every Friday night from May 31, 2024, through April 25, 2025. The fireworks displays approved by the April 26, 2024, Board action are designed to be viewed by the public, provided they remain outside of the safety zone during the event.

The Applicant contacted Land Division on April 24, 2024, requesting a permit for an additional fireworks ground display piece to be ignited after the public display on June 7, 2024. (**Exhibit C**) This additional request was not received timely to be heard on the same date as the Board submittal for the annual right-of-entry permit referenced above and Land Division staff determined that it would not be appropriate to include the additional request as an amendment to HE's annual permit request. Therefore, Land Division agreed to bring this request to the Board in a separate submittal, to be heard and considered by the Board at the first available opportunity.

The present submittal addresses HE's request for issuance of a right-of-entry permit for the setup and firing of a fireworks ground display piece, also known as a set piece, at Duke Kahanamoku Lagoon on June 7, 2024, for display to a private event being hosted at the adjacent Hilton Hawaiian Village's Great Lawn. The use and location requested in the present submittal are not included in the right-of-entry approved by the Board on April 26, 2024.

The set piece comprises a wooden frame measuring seven feet high by nine feet wide. The frame holds flares, called lances, that are each approximately the size of a pencil and display varying colors of light. When the lances on the set piece are ignited, they will display the corporate logo of CP Cosmetics, the host of the private event at the Hilton Hawaiian Village, and will be illuminated for approximately thirty to forty seconds. (**Exhibit D**) The Applicant plans to assemble the set piece on a land-based canoe within the same 500 square foot work zone that is included in the right-of-entry permit already approved by the Board at its April 26, 2024, meeting under agenda item D-12. (**Exhibit E**)

The canoe with the assembled set piece will be transported from the work zone, floated across the lagoon, and secured in place at some point before the aerial display begins. The set piece will be ignited immediately after the public fireworks display ends.

When ignited, the set piece requires a firing zone of 17,671.5 square feet, which is entirely contained within Duke Kahanamoku Lagoon. The firing zone includes

both the canoe containing the set piece and a buffer area to protect public safety. A licensed display operator will be present on or next to the canoe with the set piece during the ignition period. No other individuals will be allowed within the firing zone during the ignition period. Duke Kahanamoku Lagoon is not located within the safety zone for the aerial display approved by the Board. **(Exhibit F)**

The Applicant has not requested closure of any area other than the 17,671.5 square foot firing zone. Therefore, Duke Kahanamoku Lagoon and any part of the surrounding area that is outside of the safety zone approved by the Board on April 26, 2024, will be open to and accessible by the public. The Applicant will be solely and fully responsible for excluding the public from the firing zone and ensuring the safety of the public in and around Duke Kahanamoku Lagoon while the set piece is in transport to and from the firing zone, while it is situated in the firing zone, and during its ignition.

According to the Applicant, the set piece produces virtually no debris. All remnants of ash will be contained on the canoe which will be removed from the lagoon island after the display and will be disassembled on land within the safety zone for the aerial display. The Applicant does not anticipate the need for additional clean up beyond its standard protocols, which have been previously submitted to the Board.

The Applicant has provided the Department with a certificate of liability insurance documenting the following current policies:

Explanation of Rental Amount:

Rent for the set piece was calculated using the Department's standard rate of \$0.10 per square foot of State land. The firing zone requested by the Applicant measures 17,671.5 square feet. The firing zone constitutes a circle with a radius of 75 feet, with the set piece located at the midpoint of the circle.

The set piece is designed and located to be visible from the Great Lawn of the Hilton Hawaiian Village hotel, where the private event hosted by CP Cosmetics will be held. The set piece will likely not be visible to the general public because of its orientation toward the private event and its location relative to the aerial display's safety zone, from which members of the public are excluded at the time that the set piece will be ignited. It is relatively small, only nine feet high, and will be placed at a low-lying point on the landscape. There are no aerial effects that would be visible over the horizon. It appears from maps and information provided by the Applicant that the only location from which the set piece will be fully visible is the private property of the Hilton Hawaiian Village, which will be occupied by CP Cosmetics' private event. **(Exhibit F)**

Further, the set piece will display the corporate logo of CP Cosmetics company, which is sponsoring a private event at the Hilton Hawaiian Village's Great Lawn,

and no other image or design. The nature of the display and its orientation make it clear that the set piece is intended to benefit the private event and its corporate sponsor rather than the general public.

The Office of Conservation and Coastal Lands (OCCL) was consulted on this submittal. OCCL had no objections and concurred with the proposed Environmental Assessment exemption.

The Applicant has not had a lease, permit, easement, or other disposition of State lands terminated within the past five years due to non-compliance with such terms and conditions.

There are no additional pertinent issues or concerns.

RECOMMENDATION: That the Board:

1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Sections 11-200.1-15 and -16, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
2. Authorize the issuance of a right-of-entry permit to Hawaii Explosives & Pyrotechnics, Inc. covering the subject area for set piece fireworks display purposes under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
 - A. The standard terms and conditions of the most current right-of-entry permit form for firework displays, as may be amended from time to time; and
 - B. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.

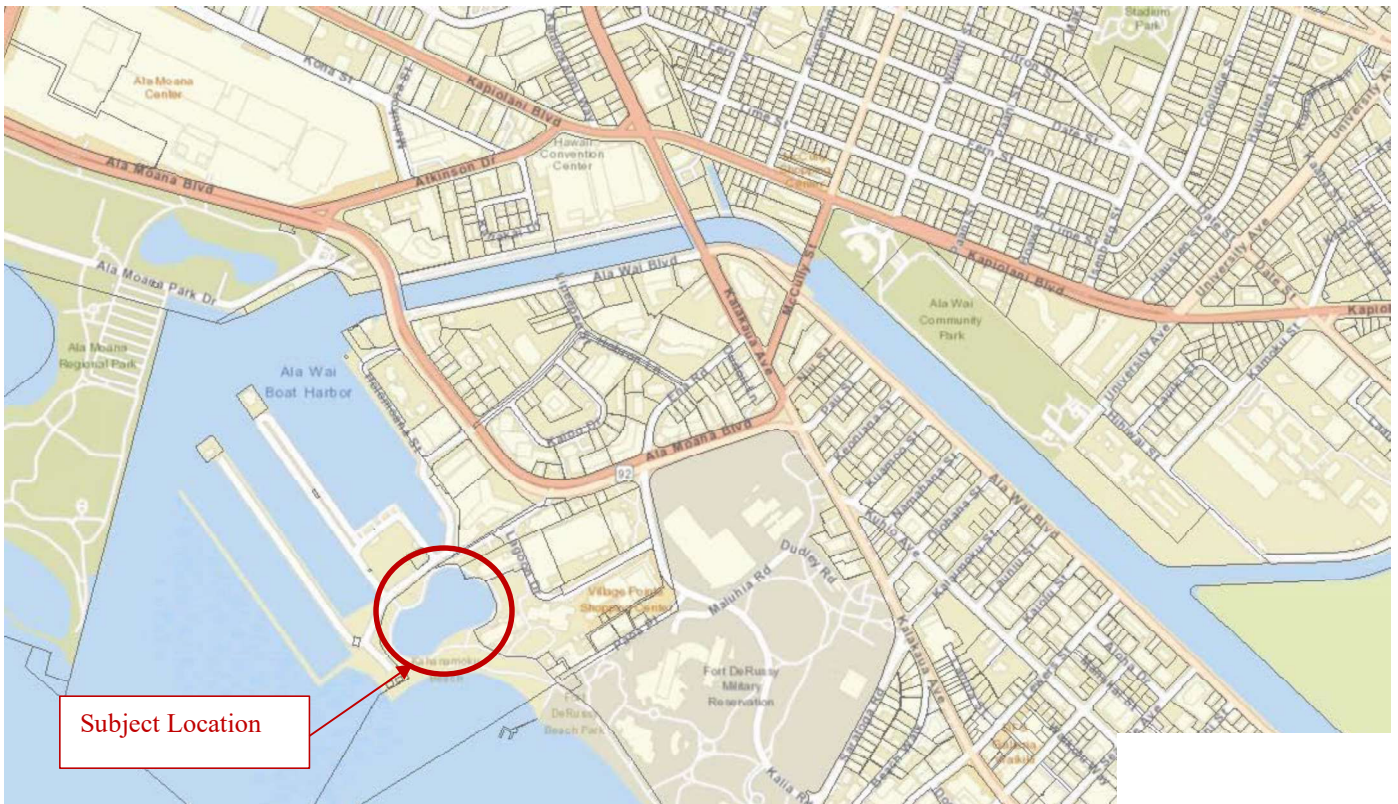
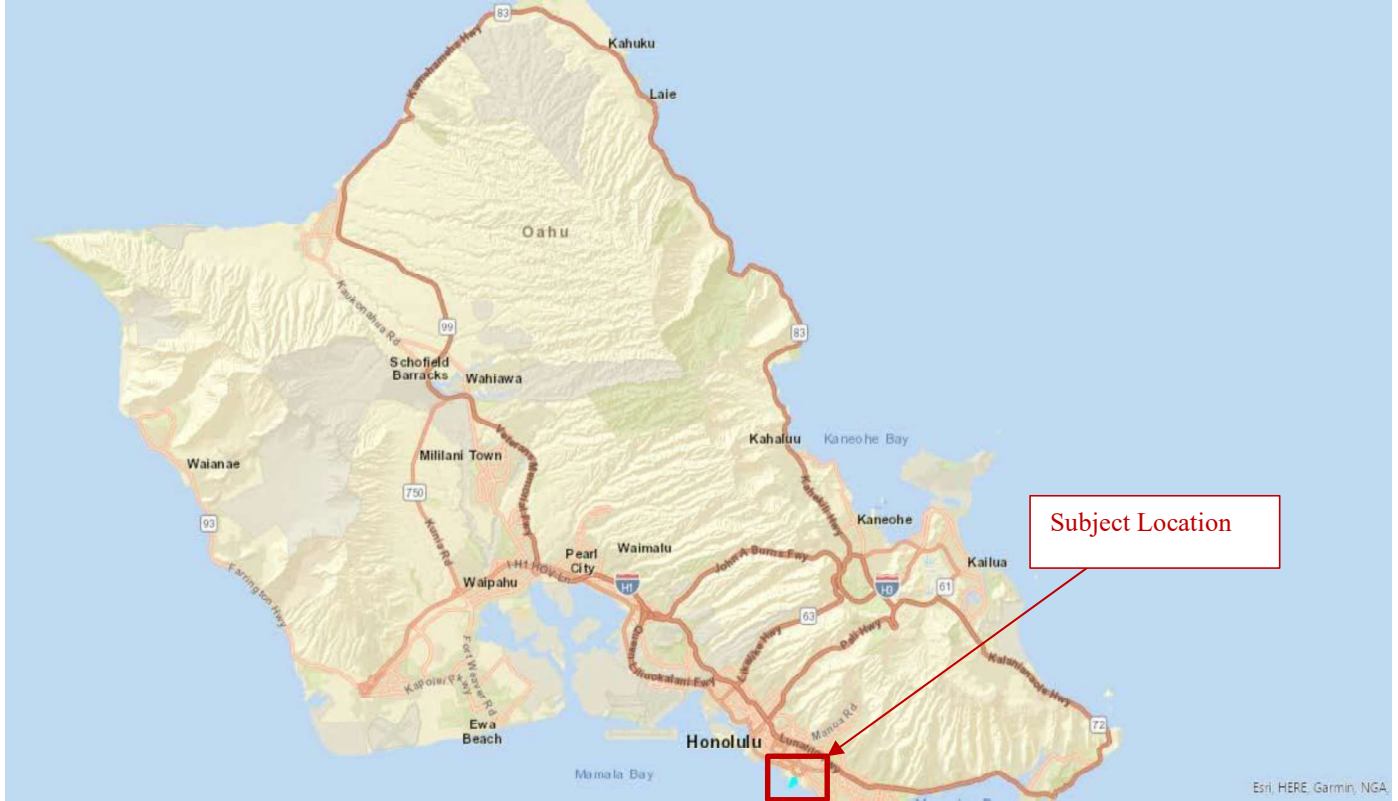

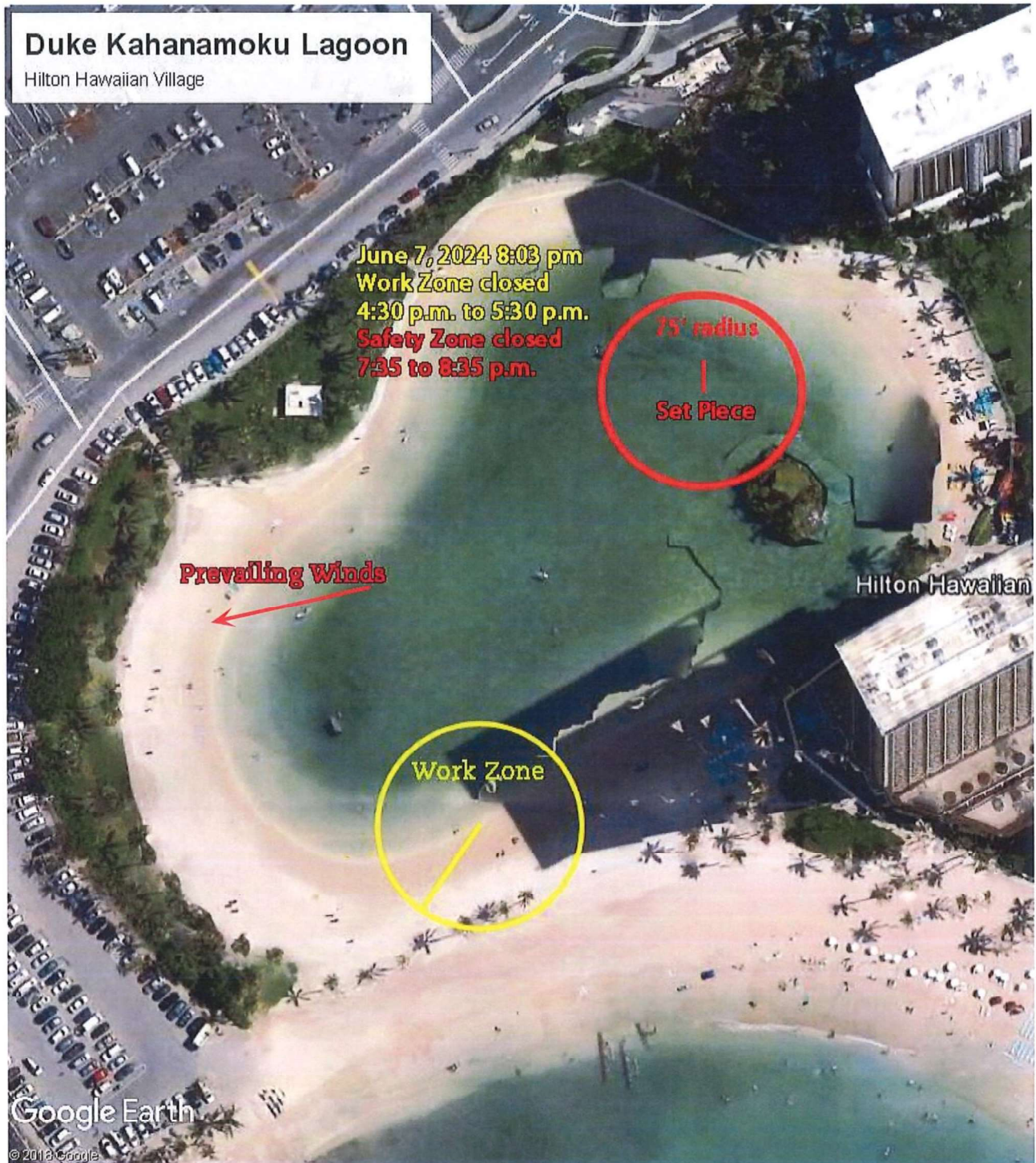
Trigger(s):
Exemption Class No.: In accordance with Hawaii Administrative Rules (HAR) sections 11-200.1-15 and -16 and the Exemption List for the Department of Land and Natural Resources reviewed and concurred on by the Environmental Council on November 10, 2020, the subject request is exempt from the preparation of an environmental assessment pursuant to General Exemption Type 1 for "[o]perations, repairs or maintenance of existing structures, facilities, equipment, or topographical features, involving negligible or no expansion or change of use beyond that previously existing." Specifically, the subject request is exempt under Part 1, Item 44, which applies to "[p]ermits, licenses, registrations, and rights-of entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing."

Cumulative Impact of Planned Successive Actions in Same Place Significant? No. Similar events occur at the same location from time to time. However, based on the multiple environmental clean-ups conducted after each display to remove debris from the lagoon area, staff believes that there would be no significant cumulative impact.

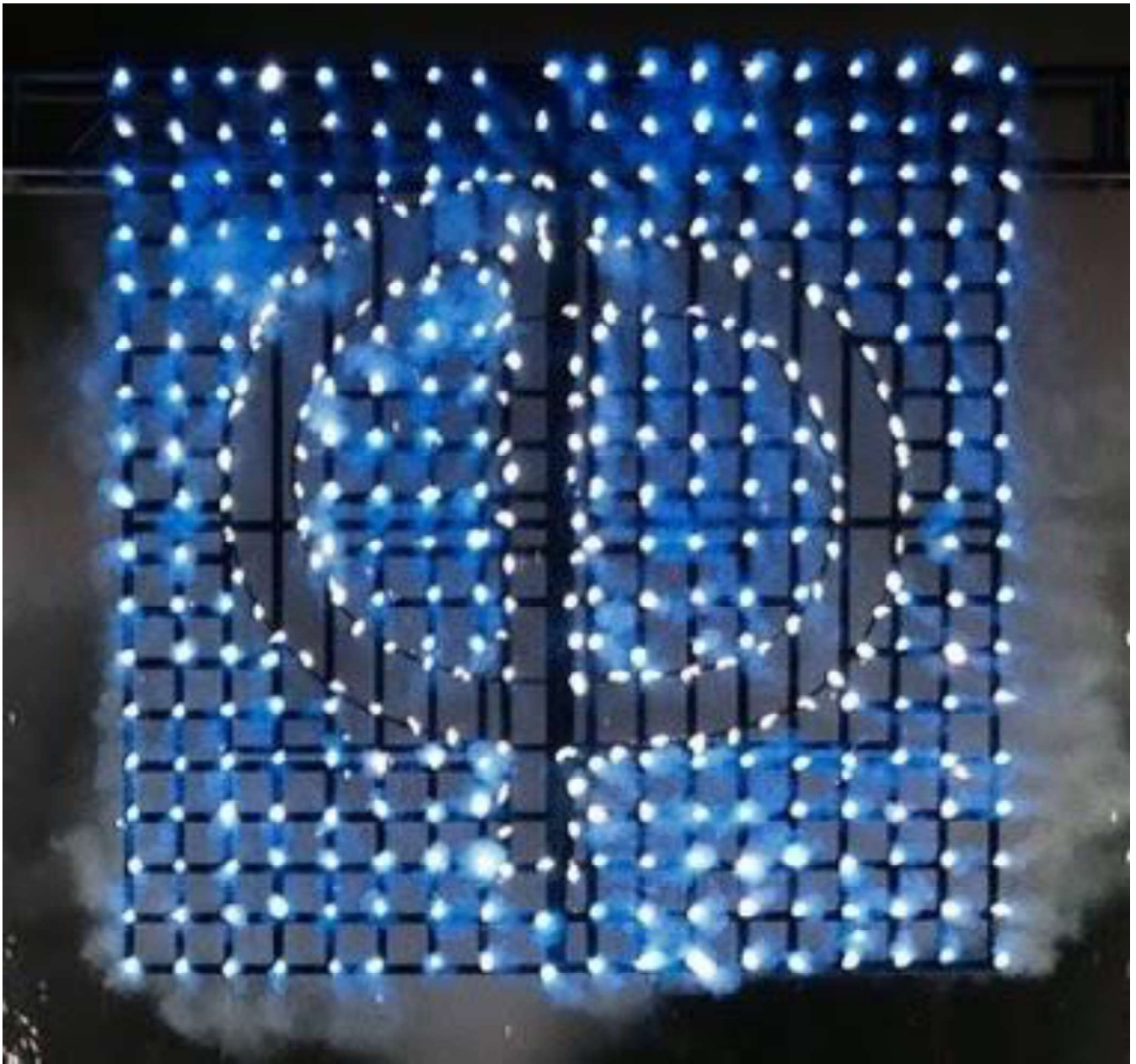
Action May Have Significant Impact on Particularly Sensitive Environment? The requested area is a portion of State beach visited by tourists and residents and is heavily impacted by human activity. Public access across the requested area is maintained by the Hilton Hawaiian Village staff. In addition, based on the analysis below, staff believes there would be no significant impact to sensitive environmental or ecological receptors.

- Consulted Parties: Office of Conservation and Coastal Lands (OCCL) concurs with the proposed exemption.
- Analysis: The Board has permitted similar events in the past. The proposed activity is of a similar type and scope of beach activities that have periodically occurred and continue to occur on this and other beach areas across the State. Such activities have resulted in no known significant impacts, whether immediate or cumulative, to the natural, environmental and/or cultural resources in the area. Staff also believes that the request would involve negligible or no expansion or change in use of the subject area beyond that previously existing.
- Recommendation: It is recommended that the Board find that this project will probably have minimal or no significant effect on the environment and is presumed to be exempt from the preparation of an environmental assessment.
