CURRENT USE STATUS:

Land Court Lot C-2-B extends into the middle of David and Jeannette Paddock's backyard. Land Court Lot C-2-B is currently being used as an unpaved parking lot for the Paddock's vehicles. There is a fence, a hedge and trees crossing the property.

COMMENCEMENT DATE:

Upon transfer of title to the abutting owner.

COMPENSATION:

Remnant is to be disposed of in compliance with HRS, Section 171-52 and is pending appraisal from a state approved and State of Hawaii licensed appraiser.

LIENS AND/OR ENCUMBRANCES:

None.

CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

Not applicable. Parcel was part of the roadway and will become privately owned land upon transfer. HRS, Chapter 343, would not apply to any future development on the parcel as no state lands would be involved.

REMARKS:

The parcel was deemed surplus to HDOT's needs. HDOT has no objection to the disposal and transfer to an abutting property owner as prescribed by the Director in the best interest of the State of Hawaii. We have enclosed the TMK map, proposed Land Court map, Geographic Information System map with Lot C-2-B highlighted and a title report for the referenced parcel.

Please note the title report refers to the parcel being sold as Land Court Lot C-2. Per the enclosed Land Court map, C-2 is being subdivided into the aforementioned Lot C-2-B and Lot C-2-A. Lot C-2-A will remain as a part of the highway.

<u>RECOMMENDATION</u>:

Authorize HDOT to dispose of Kamehameha Highway, Federal Aid Project No. 1-D, Laiewai, Koolauloa, Oahu, Hawaii, TMK No. (1) 5-5-009:058 (Portion) aka Land Court Lot C-2-B in compliance with HRS, Section 171-52 and any reimbursement of the Federal Aid Project, in accordance with HRS, subject to the following:

- 1. The property will be conveyed to the owner through Quitclaim Deed;
- 2. Review and approval by the Department of the Attorney General;
- 3. Such other terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the state;
- 4. The parcel shall be sold at fair market value to be determined by a licensed appraiser, chosen by the State of Hawaii;
- 5. The parcel shall be conveyed in an "as is" condition and the state makes no warranty or representation about its condition or the presence of hazardous materials on, under or about the same.




