CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

In accordance with Hawaii Administrative Rules ("HAR") §§11-200.1-15 and -16 and the Exemption List for the Department of Land and Natural Resources, reviewed and concurred on by the Environmental Council on November 10, 2020, the subject request is exempt from the preparation of an environmental

assessment pursuant to General Exemption Type 1 for "[o]perations, repairs or maintenance of existing structures, facilities, equipment, or topographical features, involving negligible or no expansion or change of use beyond that previously existing." Specifically, the subject request is exempt under Item 44, which exempts "[p]ermits, licenses, registrations, and rights-of entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing." It is expected that the subject request will have minimal or no significant effect on the environment and therefore should be declared exempt from the preparation of an environmental assessment and the requirements of §11-200.1-17, HAR (**Exhibit C**).

REMARKS:

Oahu Pentathlon, LLC is requesting a right-of-entry permit to conduct beach activities on State-owned shoreline lands in conjunction with a long-distance, multi-modal race event.

The Oahu Pentathlon is a multi-modal race that traverses the Windward, North Shore, and Leeward sides of Oahu. It includes six sections as follows: a two-mile swim course from Kailua Boat Ramp at Kailua Beach Park to Castles Beach in Kailua, a sixteen-mile running course from Castles Beach to Kualoa Regional Park on Kaneohe Bay, a twelve-mile ocean paddle course from Kualoa Regional Park to Laniloa/ Clissold's Beach in Laie, a twenty-nine mile bike course from Laniloa/ Clissold's Beach to Kaena State Park, a ten-mile carry course (hiking with weighted pack) on Kaena Point Trail to Keaau Beach Park in Waianae, and a final sixty-six mile bike course from Keaau Beach Park returning to Kailua Boat Ramp. Athletes may participate in the race as solo participants or as part of a two-to-seven-member team where athletes divide the various segments among themselves and complete the course relay-style. The event is open to athletes of varying skill levels and age. Participation is estimated at 150 to 200 participants. The Applicant will hire Honolulu Police Department Special Duty Officers to provide security and help manage traffic where needed.

The race begins at sunrise at Kailua Beach Park, which is approximately 6:05 AM. Participants must finish the full racecourse within twenty-four hours, returning to Kailua Beach Park no later than 6:05 AM on August 4, 2024. The two sites for which permits are requested in the present submittal will be used only on August 3, 2024, at the times specified above.

The Applicant requests that the Board approve right-of-entry permits for its use of specified areas at Castles Beach in Kailua (Exhibit D) and Laniloa/ Clissold's Beach in Laie (Exhibit E). The Applicant has submitted permit applications to other agencies as follows:

The Office of Conservation and Coastal Lands has reviewed this submittal and concurs with the requested Environmental Assessment exemption.

As of the date of drafting this submittal, Staff did not receive a response to requests for comments from the City & County of Honolulu, State Parks Division, or Division of Boating and Ocean Recreation.

The Castles Beach site is a checkpoint and exchange site for transition from the initial swimming section of the race to the running portion. This site will be located on the sandy beach near a public access route that connects the beach to Kalaheo Avenue. The Applicant is requesting a permit for a 50' x 50' area at this site. Located within the 50' x 50' permitted area will be a 10' x 10' pop-up tent with a table for athlete support (food, drinks, and first aid), two 3' x 3' changing tents, and a 15' tall event flag that will be positioned so that it is visible to the participating athletes from the water near the final swim buoy in Kailua Bay. Since there will be no equipment changes at this checkpoint, there is no equipment staging area included at this location. The Applicant expects that there will be approximately 150 to 200 people at this location over the two-hour period for which the site is permitted.

The Laniloa/ Clissold's Beach site is a checkpoint and exchange site for the transition from the paddling section of the race to the first biking portion. This site will be located on the sandy beach near a public access route that connects the beach to Kamehameha Highway. The Applicant is requesting a permit for a total area of 20' x 20' at this site. Located within the 20' x 20' permitted area will be one 10' x 10' pop-up tent with a table for athlete support (food, drinks, and first aid), one 3' x 3' changing tent, two 15' tall event flags positioned so they are visible to the athletes from the water, and a staging area for paddled watercraft (e.g. kayaks. paddle boards) for athletes emerging from the water. Consistent with the 2023 race, the Applicant expects that no more than two watercraft will be in the area at one time. The Applicant reports that the owner of an abutting private property has agreed to locate a staging area for athletes' bicycles on that private property. The Applicant will not bring bicycles onto State land at this checkpoint. The Applicant expects that there will be up to thirty to forty people present at this location at one time and up to 150 people present over the six-and-a-half-hour period for which the site is permitted.

The Applicant has been in contact with the Kailua Neighborhood Board and Koolauloa Neighborhood Board to schedule presentations at Neighborhood Board meetings to address local community concerns. The Applicant will also provide notice of the event to businesses and residents in the vicinity of the event course by public postings and mailbox notices. Posters will be placed near each end of the paddle section one week prior to the event and mailers will be sent to local neighborhoods to inform residents of the event and its schedule.

The Applicant will not conduct any sales or other commercial activity under this right-of-entry permit.

The Applicant has not had a lease, permit, easement, or other disposition of State lands terminated within the past five years due to non-compliance with such terms and conditions.

There are no other pertinent issues or concerns regarding the subject request.

RECOMMENDATION: That the Board

- Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200.1, HAR, this activity will likely have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
- Authorize the issuance of a right-of-entry permit to Oahu Pentathlon, LLC covering the subject areas for the Oahu Pentathlon race under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
 - a. Payment of the rental amount stated above;
 - b. The standard terms and conditions of the most current right-of-entry form, as may be amended from time to time;
 - c. No commercial activity shall be conducted on State land pursuant to this permit;

- d. The Applicant shall maintain public lateral access across both shoreline sites for the entire duration of the right-of-entry permit; and
- e. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.

Cumulative Impact of Planned Successive Actions in Same Place Significant?

No. The Oahu Pentathlon occurs annually at a variety of sites across Oahu and the Applicant does not contemplate increasing the frequency of this event. As such, staff believes that there would be no significant cumulative impact as a result of the event.

Action May Have Significant Impact on Particularly Sensitive Environment? The requested areas are portions of State beach and submerged land that have long been available for public access and are located in close proximity to public shoreline access routes. Race organizers anticipate approximately 150 to 200 participants. Most participants are members of teams that will divide the segments of the race among members, which will reduce the number of participants actively on the racecourse at any one time. In addition, based on the analysis below, staff believes there would be no significant impact to sensitive environmental or ecological receptors.


Analysis:

The Board has permitted similar events in the past including paddling, swimming, biking, and running race events. The proposed activity is of a similar type and scope of beach activities that have periodically occurred and continue to occur on this and other beach areas across the State. Such activities have resulted in no known significant impacts, whether immediate or cumulative, to the natural, environmental and/or cultural resources in the area. Staff also finds that the request will involve negligible or no expansion or change in use of the subject area beyond that previously existing.

Recommendation:

It is recommended that the Board find that this event is likely to have minimal or no significant effect on the environment and is presumed to be exempt from the preparation of an environmental assessment.
