SUBJECT: Request for contested case hearing by Ohana Kayak Rentals and Ms. Janell Jensen, both individually and as owner of Ohana Kayak Rentals, regarding the Board's April 26, 2024 decision to impose fines and prohibit Ohana Kayak Rentals and Ms. Jensen from obtaining any Division of Boating and Ocean Recreation use permits for 24 months, for alleged violations described in the staff submittal for Item J-1 on the Board's April 26, 2024 meeting agenda.

> The Board may go into Executive Session pursuant to Section 92-5(a)(4), Hawaii Revised Statutes, in order to consult with its attorney on questions and issues pertaining to the Board's powers, duties, privileges, immunities, and liabilities.

BACKGROUND:

At the April 26, 2024 regularly scheduled Board of Land and Natural Resources (Board) meeting, as Agenda Item J-1, the Board approved civil penalties against Ohana Kayak Rentals and Janell Jensen, both individually and as owner of Ohana Kayak Rentals, regarding illegal rentals of commercial ocean recreational equipment for use in Kaneohe Bay ocean waters, for pre-positioning of that equipment within 1,000 feet of any shoreline of Kaneohe Bay, and for advertising these illegal activities, all without the required permit, on at least seven (7) separate dates, two of which were Sundays and/or federal holidays, in violation of Hawaii law.

Ms. Jensen did not request a contested case hearing (CCH) before the close of the April 26, 2024 meeting, as is required by Hawaii Administrative Rules (HAR) Section 13-1-29(a). Although she did call a Division of Boating and Ocean Recreation (DOBOR) office before the close of the meeting to ask whether she could appeal the Board's decision, Ms. Jensen *did not* contact the Board's Secretary or otherwise inform the *Board* that she wished to request a CCH before the close of the meeting, as was clearly instructed on the April 26, 2024 meeting Agenda itself and also read aloud at the April 26, 2024 Board meeting. On April 30, 2024, Ms. Jensen submitted a written petition for a contested case hearing for this matter (attached as **Exhibit A**).

DISCUSSION:

At the April 26, 2024 regularly scheduled Board meeting, DOBOR brought a civil enforcement action against Ohana Kayak Rentals and Ms. Janell Jensen, individually, and as owner of Ohana Kayak Rentals, for offering illegal rentals of commercial ocean recreational equipment, namely kayaks, for commercial ocean use activity within Kaneohe Bay ocean waters, and/or delivering for hire or pre-positioning for hire within one thousand feet of any shoreline of Kaneohe Bay, on the Island of O'ahu, such commercial ocean recreational equipment for these purposes, and for advertising these illegal activities, all without a commercial use permit issued by the department on at least five separate dates, and for allegedly conducting these prohibited commercial activities on Sundays and/or federal holidays on at least two of those dates, for a total of at least seven (7) separate violations of Hawaii Revised Statutes (HRS) Section 200-39 and HAR Sections 13-256-3 and 13-256-73.¹

Ms. Jensen appeared in person at the April 26, 2024 Board meeting. Ms. Jensen was present in the Board's meeting room when the meeting began and the CCH statement appearing on the Board's agenda was read out loud.² When Ms. Jensen's item was called, she acknowledged that she received notice of the meeting and that she had reviewed the meeting Agenda as well as the staff submittal detailing the allegations against her. Ms. Jensen provided oral testimony during the meeting, but she did not submit written testimony prior to the end of the meeting, as allowed by HRS Section 92-3.

During the discussion on Item J-1, Ms. Jensen also informed the Board that she consulted an attorney earlier that same week regarding the pending enforcement action against her. Following testimony and discussion, the Board voted unanimously to accept the recommendations in the staff submittal, which included imposing the following penalties: (1) a civil fine of \$35,000.00; and (2) a prohibition on both Ohana Kayak Rentals and Ms. Jensen, individually and as owner of Ohana Kayak Rentals, from obtaining any type of DOBOR use permit for a period of 24 months from the date of the decision.³

In some of the matters before the Board, a person may wish to request a contested case hearing. If such a request is made before the Board's decision, then the Board will consider the request first – before considering the merits of the item before it. A person who wants a contested case may also wait until the Board decides the issue, then request the contested case after the decision but before the close of the board meeting. It is up to you. Any request must also be made in writing within ten calendar days. If no request for contested case is made, the Board will make a decision. The Department will treat the decision as final and proceed accordingly.

BLNR – Contested Case Hearing Petition by Ohana Kayak Rentals and Janell Jensen

Ms. Jensen did not request a CCH before the close of the April 26, 2024 Board meeting, as required by law. Ms. Jensen submitted a written petition for CCH regarding Item J-1 on April 30, 2024 (attached as **Exhibit A**).

The rules setting forth the required procedure for requesting a contested case hearing are set forth in the HAR. Specifically, HAR Section 13-1-31.1 provides, in relevant part:

[W]hen a violation is alleged for which an administrative remedy is provided and with respect to which the alleged violator is entitled to a contested case hearing, a contested case shall be held upon the petition of the alleged violator, provided that the petition is made in accordance with the provisions of section 13-1-29(a).

Section 13-1-29(a), HAR, provides, in relevant part:

An oral or written request for a contested case hearing must be made to the board no later than the close of the board meeting at which the subject matter of the request is scheduled for board disposition. An agency or person so requesting a contested case must also file (or mail a postmarked) written petition with the board for a contested case no later than ten calendar days after the close of the board meeting at which the matter was scheduled for disposition.

(Emphasis added.) Thus, under the relevant HAR, a proper request for a CCH must be made *during* the relevant Board meeting and must be made *to the Board*. The request must also be followed up with a written petition to the Board within ten days of the board meeting in question.

Here, as mentioned above, no oral or written request for CCH was made before the close of the April 26, 2024 Board meeting. Although Ms. Jensen did call DOBOR's office during the meeting to inquire about how to appeal from the Board's decision,⁴ she did not contact *the Board* at all, nor did she orally request *a contested case hearing* at any time before the close of the meeting. *After* the close of the April 26, 2024 meeting, Ms. Jensen submitted a written petition for CCH within ten calendar days (on or about April 30, 2024). Ms. Jensen therefore did not comply with HAR Section 13-1-31.1 because she failed to make an oral or written request for a CCH to the Board no later than the close of the April 26, 2024 meeting. That Ms. Jensen followed up with the required written CCH petition within ten (10) days cannot cure her procedural defect.

Notwithstanding any incomplete information provided by DOBOR during the brief phone call with Ms. Jensen on April 26, 2024 (see n.4, above), Ms. Jensen had ample notice of the proper, legally required procedures for making her request in the form of prior written

notice of the meeting, which included a copy of the Board agenda with the CCH statement (reproduced in n.2, above) and in-person, verbal notice of the contested case hearing procedure given at the start of the Board meeting when Ms. Jensen was present. Staff also notes that Ms. Jensen appeared to be in possession of a written copy of the Board agenda while present in the meeting room on April 26, 2024 and therefore would have been in possession of the CCH statement detailing the procedure for requesting a CCH.

In its discretion, the Board *may* choose to grant Ms. Jensen's improper request for a CCH; if the Board chooses to do so, the Board must first vote to waive the procedural requirements of HAR Section 13-1-29(a).

RECOMMENDATION:

That the Board *deny* Ms. Jensen's procedurally defective request for a CCH. However, if the Board is inclined to grant the CCH request despite Ms. Jensen's procedural defects, then staff recommends that the Board vote to:

- Waive the requirement for making a request for a contested case hearing to the Board no later than the close of the board meeting at which the subject matter of the request is scheduled for board disposition, as contained in HAR Section 13-1-29(a) and approve Ms. Jensen's request for contested case hearing; and
- 2. Authorize the Chairperson to take any and all actions necessary to effectuate its decision including, but not limited to, appointing a hearing officer for this matter.

I have gathered several declarations from my neighbors who believe that I should be allowed to run my business, as they think it doesn't change the character of the neighborhood. They have never been bothered by kayakers nor have they seen any traffic blocked by them. Additionally, I have a letter from a lady who lives near the public access area where I was accused of chainsawing trees. Her friend Wayne falsely accused me of doing such and even claimed that, I poisoned the water. Wayne was the same person who keyed my car while I was kayaking with my friend Marcy before her heart surgery. The lady named Anne informed me through email that she saw a white Caucasian man sawing the trees at the public access area. I am confused as to why people are so eager to falsify police reports and defame me. I have tried to seek answers to simple questions, but the process has been confusing. I even emailed DLNR, but they never got back to me.

I was also told by DLNR managers they didn't have jurisdiction outside of the water on a few occasions. as well as a recording transcript left a voice message. I have a voice-to-text transcript. That it is not required of me to have a permit as long as I'm renting from my house and not in the water.

All this could have been avoided if simple questions could have been answered. I sought it out but, I didn't receive the answers and understanding.

Now, recently, I received this long letter this week more so the packet that details things that I didn't understand before such as not being able to say Sandbar in a review response why couldn't they just plainly tell me that before?? I would've never thought a review response would be considered an advertisement. I had assumed that the advertisement meant an Advertisement a cost mentioning something like kayaking Kaneohe Bays Coral Reefs for such and such price as many of the other rental companies advertise kayaking for Kaneohe Bay like that. I have many examples of what I thought was an advertisement too with me. I don't want to point the finger. I think all kayaking businesses are doing a good service and should be allowed to conduct their business in fitting safe caring ways. I, believe that Hawaii's anti-trust laws, grandfather clauses, and 1st amendment rights, along with constitutional rights should not be infringed on.

I'm getting the book of new law thrown At me without any explanation regardless if it's false. At least if I know I'm doing something wrong I could make corrections or adjustments accordingly. I'll gladly do my best to make corrections and maintain respect among all even the few disrespectful liars. At least, now I can respond and interject on misleading false statements in the letter.

I did not think people taking a picture in the bay and posting it on reviews was advertising as well. This is a new law and there are lots of previous pictures anyone could review them at any time with an old picture as well when they, please. I do not always review at the time of review sometimes I look at my Google reviews and realize I didn't review a place I like and then I go back and review them months later maybe years later. I assumed I was not breaking any of the laws because nobody would talk to me from DLNR.

I don't have to or need to say anything about Kane'ohe Bay or the sandBar Ahu O' Laka but people are still going to rent kayaks to access the bay regardless. If that's where they wanted to go as long as I wasn't steering them there or telling them to go there. Sometimes people ask me what I suggest and I say I can't you have to know where you want to go then if they need help I help them as far as possible suggestions to have kualena to malama the area. My opinion is not an advertisement it's my first amendment right as well.

This law passed really seems to go against statehood's sacred rights to freedom to recreate and enjoy navigable water rights wouldn't you say??

-----If you Don't want to say yes at least think about this.

It's not right to make bay access exclusive to only people who own a kayak, outrigger, canoe, boat, or sup which are expensive. It is like privatizing the bay for only such people. And detouring people from accessing sacred human rights.

I do not deliver Or transport again another new law that you can't transport was passed the grandfather clause should apply. If that law hadn't passed, I would have helped deliver occasionally if needed for the people, Greg was complaining about. People that took the bus. IF LAW WASNT CHANGED I COULD OF HELPED TRANSPORT DELIVER help

occasionally if needed, Instead, a few kayaks got carried down the road that had, severely bothered Greg and Ward. I do not instruct in the water I do not do business in the water i did not think to be considered as in water.

I go to church on Sundays and spend the Day with my kids. Sunday belongs to God and my savior Jesus and my family.

However many rental shops rent on Sunday to people that go to Kaneohe Bay that are not on or in the water. Kama'aina Eco Tours were on the waters edge and did not rent on Sundays or holidays. it's a shame they are not in business now, lots of big business event outings would rent from them that no one else could accommodate I know because I referred big groups to them.

nobody spoke plainly and simply to me and the law didn't make sense to me. It was incomprehensible. I think the term advertising is unclear but when getting an example it helps me to understand better and could of beenavoided. If I'm doing something wrong I need to be told if it can be corrected and or if it can not be corrected.

It's difficult when someone refuses to answer questions. I'm not sure what might have changed regarding the permit for renting kayaks from my house, but it might be worth trying to reach out to Bruce again to see if he can provide any clarification. Perhaps there was a misunderstanding or miscommunication that can be cleared up.

By the way, if kayakers were educated properly and told what they need to know it would have a very low impact on the environment if any at all. not allowing people to have or rent access to water equipment for navigable water is very strange. Saying I need a permit when they are not given for Kane'ohe Bay for any business since 1993; and saying you need one after they tell you don't need one is deceitful obscure practice. No kayak businesses have permits for kaneohe Bay. If places would and were allowed to go over things in such a way that people understand they'ed behave better and be more caring towards the environment and the reef. There are good ways to get the point across It's important to be mindful of the reef when snorkeling or swimming in the ocean. Touching the reef can actually damage its protective mechanism and make it more susceptible to disease, which can ultimately kill the reef. Additionally, touching the reef can be dangerous for humans as it can cause cuts that may lead to infections. It's also important to note that damaging the reef can result in fines. And, if you accidentally bump into the reef, you wouldn't want to bump into a moray eel as they have sharp teeth that can cause serious injury. To avoid drifting into the reef while snorkeling, it's best to avoid treading water and swim flat with straight legs, even when emptying your snorkel. It's important to protect the environment and be mindful of its delicate ecosystem. Janell Jensen

I loved sharing kayaking and did a good service to the community to share necessary information equipment needed to know to be safe and enjoy.

There was No regard for my privacy. As my name home address blasted all over your websites fb instagram shared so forth with blatant disregard and immense misrepresentation. Hopefully I am not hurt due to how this was treated and how I was unfairly treated through all this

I hope I never go through anything like this again

I loved sharing kayaking and did a good service to the community to share necessary information needed to know to be safe and enjoy.

I will freely speak for no gain or profit off Kaneohe Bay

New laws would not allow any commerce water activity purchases to enter Kaneohe bay would be in violation if boats are sold and recommended use of Kaneohe bay so forth even. This is an unfair abuse of a too powerful government agency. Laws are too strict and are not natural law. To impossible for all to follow and not enforceable for all to comply so its pick and choose or go after based on complaints versus evidence or real advertisement. Not right in my opinion..to not be able to purchase for use to take ocean activities to Kaneohe bay not allowed to enter the bay or its considered advertisement.. Burden is too great. It's like you'll only be able to purchase rent from the black market. **That's likely going to create an excess trash problem. People will still kayak Kaneohe Bay without knowing what they need to know with no regard or understanding of their surroundings. Tourists kayaking out there not knowing anything will likely be a greater public safety risk to the community and reefs.**

I received a letter regarding a BLNR meeting packet 4/22/24 first examples of how I did anything wrong ever after several tries to inquire what I had done wrong.

I called Jenna after the cease and desist letter in October. She would not answer how I broke any laws, only that she received complaints. I emailed DOBAR MANAGERS and they never responded back to me about what I had done wrong. I'm not proud of our conversation but I was genuinely trying to figure out and understand though I lacked the mental capability to know what I don't know and don't understand.

I received criminal citation 2/24/24 I pleaded not guilty and it was dismissed

Cease Desist order went briefly on laws not detailed addressed like in packet!

I made every attempt to understand and comply to cease and desist order. I even stopped working while gathering information.. Loren, one of my neighbor friends on luiu, told me I should throw it away and never respond to it, less is more. I don't know I don't feel that way but I wish I knew how to respond better in the heat of the moment and anxiety.

When I called to simply ask how I was breaking laws I was also very off topic. I was frustrated I didn't get a response. I wasn't trying to grill or bother Jenna. I think I was just trying to gather information to comply. But I asked more unnecessary questions wasting time because I didn't get the answer or understanding I was seeking wasn't provided.. I feel I overstepped and was too hot headed , because of the lack of no jurisdiction out of water confusion in my mind. I was thinking it had no merit. No jurisdictions and different jurisdictions again stated by Bruce so forth even in the January Kahaluu neighborhood board meeting..

I was not counseled well fairly by agency by dobar (I KEEP CALLING DOBAR DLNR THINKING ITS SAME AS DOBAR GETTING AGENCY STRAIGHT IS CONFUSING) DOBAR managers BRUCE SWARTZ AND JENNA said they did not have jurisdiction and did not answer my email regarding question the laws on cease desist letter was unclear as to how I broke those laws. No other rental shops stopped and were clearly advertising Kaneohe bay. I did not want to eat any one out. I was only on the defense. I believed fair business was violated which felt discriminatory but not shared emailed in best way again. I know I should know better but I have no wit and I am awkward in saying too much.

Word of mouth is a first amendment right. Prima facie guilty until proven innocent WHAT? WHERE'S the CIVIL RIGHT in that? where's THE RIGHT that guilty before proven innocent.

Cease all illegal activity when illegal activity though illegal activity stated did not pertain to me and was not clear though stated on letter doesn't mean anyone could understand.

Even the lawyer said I didn't seem to break any laws just to not advertise which I thought I was compliant on but my definition of advertisement is different from said interpretations in packet. I didn't not know my 1st amendment rights could be considered illegal?

Catamaran registration LAW stated on what? IN STATE WATER COMMERCIAL PERMIT WHAT?

WHEN I WAS advised BEFORE BY BRUCE I DID NOT NEED A CUP | DID NOT UNDERSTAND WHAT or how that CHANGED.

WHY ALL OTHER PLACES COULD OPERATE KAYAK RENTALS WITHOUT CUP

I DID NOT THINK I WAS ADVERTISING EITHER AND DID NOT GET EXAMPLES OF THAT how i was clearly if i did i would of fixed it

SAID ADVERTISEMENT COULD OF LIKELY COMMENCED BEFORE CEASE DESIST LETTER, CORRESPONDENCE IS NOT AN ADVERTISEMENT.

THIS ALL IS SO FAR FETCHED! I TRIED TO COMPLY IN EVERYWAY I could UNDERSTOOD TO. I DON'T KNOW HOW TO STOP ILLEGAL ACTIVITY IF I'M NOT GIVEN EXAMPLE OF HOW WHAT I was DOING IS/ was ILLEGAL WHEN IT DID NOT SEEM TO PERTAIN.

MARCH 2024 I also went in person to DOBAR SAND ISLAND TO asK BRUCE SWARTZ if I was within 1000 feet of water. Was it via road or way bird flies in March 2024 after law passed into effect that kamaaina kids shut down because of new law. They never had a permit CUP to do business in state waters. I went to try to understand what had changed seeking council understanding of what had changed district manager Bruce said he did not wish to answer my questions. He did answer one of my questions though I had also emailed about the citation about being required to have registration on boats. I thought maybe it was a new sticker system for kayak renters. It was for people that obtained commercial use permits but it was impossible for me or anyone to get. Because I did not hold a commercial use permit to do business in water it was unobtainably impossible to get registration for kayaks. Blnr found me noncompliant although I did everything in my power to understand what most lawyers don't even understand.

Correspondence is my first amendment right to be "matter of fact' and doing right to provide safety needs to know, while answering questions is not an advertisement. An advertisement was charged merely because people were photographed going to from the bay with kayaks. They charge me for operating on holiday and Sunday which is illegal for **In** water business that hold CUP. I Didn't think or know I was operating in state water because I wasn't. They find me for not having CUP and they find me all based on pictures the neighbor **Ward Graessle** provided. Totaling 35k presented to me only 4/22/24

Background which led up to this in the beginning I delivered kayaks and kayaked with friends from the **Pokole Point** area as(I was familiar with that area from living there and living there many years ago as well before, I lived at my current residence. My oldest son is 18 and both my kids went to Heeia elementary.) some people went to the board and some of the information was a complete lie and false accusation as well as board hearings have had complete lies and false testimony as to the amount of kayaks I have when all actuality I am not a busy business some months I did not rent at all on too windy of conditions. I have less than 5 kayaks going out daily and 6 at the most. One neighbor did not like anyone parking on the public easement to access the bay where there is a ramp that several people park there and use. I never blocked her way. I was always courteous. I am a courteous person. I only parked there briefly sometimes and later started asking people to not park there because it bothered her. Mr. Kam next to her said it did not bother him if people parked in front of his house second house in from Hunakona on Kamehameha highway and he also owns house on corner of Honekoa, someone parked there once and Neighbor across from him called me that they didn't want anyone parking in front of Kams on Honekoa because they have a big trailer and need to park there and have space to pull in driveway, so i respected that and told people to not Park there. I have delivered to the shoreline but not after the law changed, also I stopped sending people to Pokole Point area out of respect about a year and half ago. People told anyone kayaking in the area saying what they were doing was illegal, telling them to not visit to go back where they came from even to locals that grew up here. That lady from in she filmed me anytime I was around from the 3rd house in on kamehameha from Honakoa she complained to Wayne German is what he told me and he keyed my car with a metal leash chain he had with his dog, when I was kayaking with my friend before her heart surgery. I confronted him because Marcy and I saw him go in the back of my car up against it close against it with no space. When he saw us out there we kayaked back in and there was the scratch 4k damage all the way across my car. He did it because I was the kayak lady. I recorded saved on youtube video him saying you betcha when I asked if he keyed my car because I was the kayak lady. I alternatively used the public beach access by Hunalepo where there is no parking next to anyone's house that seemed to work well. When people wanted to go to the bay. Some people knew what they wanted to do and knew where they wanted to go and just went because they were already familiar. But if they have questions I'd be helpful to go over and answer questions for them, (my first amendment rights). I also ask questions and tell people what they need to know for where they are going, Also to respect the area, wherever they are going and be courteous to not obstruct the road way. I've done my best to do my best and be patient and go over things with people. people have rented boats and have gone all over with them as well kailua wilson lake Kahana bay ect. If i was able to deliver for people that took a bus that didn't have a car i think that would have caused less havoc of people carrying kayaks down the road that is really difficult to carry a kayak down road and was recommended to not rent from me without a vehicle. So people walking down the road was not a common occurrence.

The Kaneohe Bay is a great sacred place that people should not be prevented from renting. Its a safe place to kayak with the calmest waters with many good weather days. People should not be deprived of being able to rent if they don't own Water mode of transportation. Business should not be prevented from renting to people that want to **recreate and enjoy navigable** water rights.

Exhibit # C.11 I was Inspected 3 times DPP they never told me I did anything wrong from inspections. From those 3 business inspections inside. I never denied them to go anywhere else like Jacki said. on property like **Jacolyn** said. I was not told I needed anything further from dpp.. until later I received violations plants rocks kayak unloading of kayak. I addressed the situation with a long letter and went into dpp. Also corrected violations to remedy. **Catherine Weinhardt** mentioned kayakers have to pull into my driveway. I complied and asked people to pull in when they did not from there on out. I have letters of support from email correspondence of things senator gill had said about me without seeking my side but I did call him and have a chat with him. Which is more than I can say for our council members I have reached out to. She

also said I had not been inspected in a long time and I gave her permission to inspect the full property anytime.

Neighbors wrote in letters of support. Exhibit # C.11

I was unaware I was violating any laws that were on the cease and desist letter and citation. one of the laws on the citation was about registering for stickers for commercial use in water operators that was irrelevant and not applicable to me stated by DLNR/DOBAR again because I didn't have CUP. violations were unclear. I'm supposed to have my boats registered but it's only for tour boats that have permits. I'm not a lawyer but I did my best to try to understand but was **incapable of doing so and found it very impossible no matter how much I tried and thought I understood I was compliant.**

11/23/24 I did not know I could not rent on holiday or sunday as I am not in the water like I thought. I thought that was only for water business as stated by laws I read. Maybe that changed to I don't know i can't keep up with all the law changes and no council on laws changing. The path to the beach is about 1500 feet from my house. Meanwhile while Kamaaina kids were still renting they rented till march 2024. I assume they got the courtesy to get the law explained to them that they could no longer operate no matter what like I didn't get the courteous explanation. I wish I got the same courtesy to be told how I'm doing something wrong. And no way to comply no matter what. I wish there was an opportunity to comply and continue business in full compliance.

I should have got a cease and desist letter that said I can not rent kayaks from my house no way,no can, whatsoever. if I continue I'd be find endlessly like a drug dealer. Not a bunch of laws, I don't understand that aren't and weren't clear how i'm violating them. For a law of extended boundary and extended use activity and changed revisions is confusing'

How was I supposed to know people picking up kayaks from my house would be considered delivering or prepositioning kayaks within 1000 feet of shore??? when its my residence how does DLNR/DOBAR/BLNR have jurisdiction over my rights?

I've called for days for lawyers and only found one previously that is not avail to help till after may 7th

BLNR/DLNR to blast me my house with address business name my name all over DLNR/BLNR websites facebooks instagrams.

THIS IS ALL VERY MISCONSTRUED

I feel my civil rights, rights to privacy, saying I've done illegal business and many people talking are derogatory who knows their intent nowadays, there's much violence. ONE PERSON SAID I SHOULD BE SUED FOR THE DEATH OF A KAYAKER THAT HAS NOTHING TO DO WITH ME! people saying TALKING WHAT THEY DON'T KNOW things I should have started procedures correctly etcetera and lying about what they don't know and they don't know the full story.. The worst anyone slightly got hurt was stung my man o' war or a cut on the foot or finger and needed cleaning and maybe a bandaid.

I DID MY BEST TO ADHERE COMPLY TO EVERY RULE REGULATION AND DID DUE DILIGENCE BY CHECKING IN WITH DOBAR DLNR DPP AND DCCA. I GOT BAD GOVERNANCE BY THEM

I have several declarations from neighbors that my business did not bother them. I HAVE SOM LETTERS OF SUPPORT FROM NEIGHBORS AS WELL..When I brought that up in the BLNRmeeting they said I should of submitted them and testimony with less than a weeks notice and made it sound like I had as much time as oct 26 23 how would that be possible when I didn't even get notice of this civil preceding received 4/22/24. I should be allowed extension and a fair contested hearing with an unbiased jury that's not the government. Not knowing how the procedures work and I am expected to know... definitely not a fair trial at all. I did my best to do my due diligence to do my best to understand without being pesky. Forgive my repetition. I am stressed and anxious over this. It's not like I was doing business without checking in with all departments.. departments

my rights have been violated: the right to freedom, the pursuit of happiness, including **jurisdictions extending boundaries.** the right of first amendment freedom of speech without being considered an advertisement breaking the law 5k each pictured offense. The right to a fair trial as I am responding within 10 days.

Arbitrary government enlarging its boundaries allocating horizontal agreements of exemption of permitting to advertise Kaneohe bay by other companies not affected like I have been the perpetuation of a witch hunt. Other same businesses with no permit advertise and continue to advertise Kaneohe bay and Mokolii within Kaneohe bay without commercial use permit very clearly.

DOBAR Bruce Swartz district manager say I can do business withOUT a cup. \$300 or 3% OR whichever is more. It is als pretty unobtainable to insure people its easy to insure equipment but not possible to get enough make enough to enough to satisfy state requirement insurance for kayak rentals.. That's why there are waivers and it is safer for people to know they are responsible for themselves rather than the possibility of relying on or thinking they can get hurt and sue for their carelessness..

By saying I need a cup is like implying I can get one?

in state waters implying I can get one though I can't ! nobody can! cups have not been obtainable since the 1990's!

So are they trying to be **sneaky** because it says they don't want to allow me to get a permit in j-1??

As well either within a few years is there **something else I don't know about???** are they not telling me something? I need to know is it possible or was it possible for me to get a CUP? **Are they impeding my rights by not being honest forthright fair in dealings?** I'd like to know why they couldn't just come out and tell me in plain simple language?? And why do they recommend in j1 that I should be barred from getting one??

Why not send cease desist letter stating no rental of kayaks at all whats so ever all oahu or you can but only here and never Kaneohe Bay, kind of example??!!!

This all brings in the law of impossibility.

I have done everything to comply best of ability. Other continuing kayak business and to not allow me to continue business regardless of not advertising. **unfair everyone is saying if i was brown no one would have bothered me.** The board had their mind up and appeared to buy into every false witness false accusation and arbitrary testimony. Dlnr/dobar chose to not administer clear guidance of any examples of what I had done wrong.

Bad governance creates localism no one's welcome. You didn't grow here lets send her to hell and mistreat her best as possible.. only allow Hawaiian commerce is allowed underlying attitude.

I have never had an accident to report. I have been adamant to promote safety of paddling and protection of reefs and rights to recreate and enjoy. **Navigable Sacred water rights.** I went over reasons to not touch reefs or kayak over them, in reason that every customer will understand for fear of not treading or kayaking too close to reefs for fear of getting bit by an eel or rolled and injured on reef. I set clear safety guidelines. As well not to bother commercial areas or commercial boats to steer clear away from them so they can keep count of their commercial people area. Showing a picture of an eel with jagged teeth really works to keep people off and away from reefs. Importance to follow and understand basic law otherwise might not of known to follow local laws if not told. People may not know like Kapapa island is prohibited to not go behind the sandbar. It could be dangerous. I ask people to not anchor to reef and show proper way to anchor to sand. shared windalert.com could be used anywhere to be a good one to use. It shows the direction of wind and updates often within 20 mins to an hour behind. I asked

people to drive slowly and carefully in the neighborhood, not to unload or walk on the highway, it's even on the contract. It's important people know they are responsible for themselves not to be dangerous. any rescue charge ect if I have to call the coast guard if they don't return on time they are responsible for charges if any. it's important to be careful and have an understanding of the area, they intend to go. A few people have not liked the mere sight of anyone using the bay. Some don't even like seeing locals use the bay. One didn't like me using the public easement though I was respectful and never in her way she didn't like it and I stopped sharing her near by entrance to the bay over about a year and half ago or so along time anyway. I can be respectful to people that are disrespectful to me. I do have respect for my neighbors. I certainly do not ask customers to demonize and look in Joclyns windows, howards wife, where much of this stir comes from. I am a christian. They have followed and stalked me for over a year and half on numerous occasions even stopped on hwy to take pictures of me and other car I was driving like a neighborhood mafia gang thugs vandalizing threatened to hurt me again. They get off on it; while feeding my friend's dog and enjoying the view no kayak business going on. I did confront Ward and called him a psychopath. I video him back and told him to stop stalking me. I should be careful what I say. Its not fun being followed and stalked often.

He's a liar even proven with all his false stated dates of pictures presented said to be after cease desist letter Oct 2023 come to find out there not but he presented in a way as so. Untrue even shown untrue and some not used and some were used with previous date then said to be the start of complaint fabricated als decided to be used for a different purpose.. that was said by him all pics were after cease and desist he so graciously provided. He is a proven liar. The truth is in the evidence stated and shown to be false Ward provided. I should sue ward Jacki there friends that falsely testified for defamation. He had presented to neighborhood board meeting #29 January 2024 1;16 minutes. In the presentation he stated all pictures were after cease desist letter hes a liar. They all lied. lied about dates and lied about how many kayaks I have and lied about the road constantly being blocked. Lied that I chainsaw trees in police report Greg and testimony Wayne I chainsawed trees and poisoned the water. They'd drive up and down in front of my house out of their way several times, daily and often. Falsified police reports. Exhibit # Funny their friend said i cut down trees then Greg falsified police report saying he saw me cut down trees with a chainsaw why didn't he take a picture? of me then?? that he saw me with a chainsaw called ward to take pics of cuttings. really?? I have an email from Anne who lives at the public access saying she saw white caucasian man sawing trees. I Think you should watch the Kahaluu board meetings January #29 as a Exhibit # C13

Also, Greg said when he called to complain he was advised my business was legal as well as stated on **Kahaluu neighborhood board meeting**.

John Rapun** got close in my face mad and yelled what is wrong with me that I was stupid and what's wrong with me that I spoke out of turn. I have anxiety and don't always respond correctly and people close mad in my face triggers abuse from my past. Then they all had recess and all decided it didn't matter they didn't want to hear anything I said. That it was done and already in play.

I was originally told by collin that i I did not have to make people pull in to my property, but since talking to **Cathrine Weihnheart** cheif **at DPP** I did my best to do so and I asked that if people were dropping off at same time to not linger nearby to drive away for 5 minutes then come back. Mostly people pull into my property sometimes on unloading they used public easement in my driveway and slightly on road alot like everyone else how they park on iuiu. When dlnr enforcement pulled into easement parking they left there rear of truck angled in the street at dpp I asked as well to if I did need any further permit for declared home occupation they told me dcca was sufficient

I wrote a letter prior to blnr board meeting thinking id get a chance to read it. These are not fair proceedings with time limits no opportunity to respond to arbitrary false testimonies. exhibit# C.9

I was advised by DLNR that I did not need a cup to do business from my home. Exhibit #C4

I changed it when I was notified my criminal citation had been dismissed because I had assumed not broke any laws. I was under the impression I was legal and everything was ok from my attorney that saw the cease desist letter as well.

It seems the law of impossibility may be in play here. They say I now need a cup when before they said I cant get one then they say I can but come to find out I still can't when inquiring also about law i was sited needing registration.

I stopped doing business after I receive the packet saturday j-1 april 22 2024

This legislation prevents us from operating waterfront recreation programs that help us to care for He'eia State Park," said Kama'Aina Kids President and CEO Dana Vela.

"This program offered eco-friendly recreational access to Kane'ohe Bay for the community in an educational, sustainable, and nonprofit way, with proceeds directly funding the park," Vela addes.

Caroline Cruz lives close to Kaneohe Bay and told Island News, "Sometimes it's nice to be able to paddle or snorkel and be able to rent that kind of stuff, but I do agree it's nice not having this parking lot full of tourists."

Visiting from Chicago, Charles Lahew said, "All I can say is it really works for us, we couldn't bring our kayaks here from the mainland and we would not be able to go kayaking if we couldn't rent here."

I went into DLNR today 3/22/04 trying to seek answers and better understand. I was unable to find answers online. I was thinking it was a sticker system that, I could register at DLNR and get kayaks set up as needed. I also recently received an email back that I did not realize, I got a reply back that it is not applicable to me because I don't hold a commercial use permit.

Yes I also asked Jenna after receiving a cease and desist letter if she said DLNR has no jurisdiction out of the water.

Although I was told I do not need a commercial permit to rent kayaks from my house.

I am unaware what has changed and unaware of what I am in violation of and unaware what I have done wrong. I have not violated any of the laws on the cease and desist letter from October. I am not doing business in the water. I do not advertise Kaneohe bay. I do want to be in compliance in order to do that, I have to understand what it is that I've done wrong which has not been answered.



Aloha,

First and foremost, I would like to thank you for taking the time to consider my late testimony. I am making this statement as a private citizen and resident of the state of Hawaii, on behalf of Ms. Janell Jensen doing business as "Ohana Kayak Rentals." Ms. Jensen was recently the subject of agenda item J.l., during the Board of Land and Natural Resources 26 April 2024 meeting. To my understanding, Ms. Jensen was found to be in violation of *Hawaii Revised Statute 200-39 – Kaneohe Bay Commercial Ocean Use Activities; Permits; Restrictions*, and that the board had unanimously voted in favor of imposing a \$35,000 fine against Ms. Jensen.

My intent in submitting this testimony to the board is to request reconsideration to the extent of the fines being imposed against Ms. Jensen. I find that the \$35,000 fine is disproportionate to the effect of Ms. Jensen's violations. It would be reasonable if she had damaged personal property or had placed the safety of the public at risk. However, in comparison, not even individuals that are convicted of a second DUI offense receive such an exorbitant amount of a fine. I beg the board to reconsider the amount of fines that are being imposed to be commensurate with the violations found.

Furthermore, as a former client of one of Ms. Jensen's past business practices and personal acquaintance, I would like to personally testify that my observations of her character would not suggest someone with outright disregard of the law or public safety.

Lastly, I would like to acknowledge the level of difficulty that the BLNR undertakes in its duties to enhance, protect, conserve, and manage Hawaii's unique and limited natural, cultural, and historic resources. I would also like to thank you again for taking the time to consider my late testimony in opposition to the Board of Land and Natural Resource's decision regarding Ms. Janell Jensen d.b.a. Ohana Kayak Rentals (Subject of agenda item J.-I., BLNR 26 April 2024 meeting).

to respect and protect it adds to the beautiful vitality of the islands. Hawaii shorelines and other spaces are a resource for public use- all of us, not just those with money and connections.

Entrepreneurship should be encouraged by the State of Hawaii and the City and County of Honolulu. Not just because these small business owners are vital to the economy, but also because competition make these services more affordable for both locals and tourist. One of 25 small business owners will more willing to throw in free rental of car racks, life jackets, and snorkel equipment than one big corporate entity (like Kamaaina Kids) that nickle-and-dimes customers, charging extra for each piece of equipment. There should, of course, be discussion of how to protect resources but this is not the way.

This issue is indicative of the rise of some very ugly attitudes of a few entitled, privileged individuals who seem to think that Kaneohe Bay belongs only to them. Under the deceptive guise of "protecting the environment" they refuse to share Hawaii with others, both visitors and locals. Some individuals have gotten violent, keying Janell's vehicle. I am glad HECO are finally getting to the pole removal, and I appreciate your support.

I share your concern about Kamaaina Kids expansion of commercial activity on the Bay through their kayak rentals. I am sure you remember I submitted legislation to require licensing of all commercial activity on the bay, which might have improved enforcement of the K-Bay Master Plan had it passed. i introduced the Senate version of the bill that established a study to update the planning within the NERR, and we passed Legislative Resolution SCR 205 that calls on DLNR to work on getting the proliferation of unpermitted (illegal) commercial activity under control. I have met few people who want more commercial activity on the bay.

Jannell may be a nice person, but her business is driving a lot of people crazy. I attended a meeting a few weeks back with about 20 people in attendance and they are not happy. I regularly get complaints about the kayak rental at Kualoa, and I have had multiple meetings with other area residents who demand action.

DLNR presently chooses to not go after kayak rentals on the bay, provided there are no guided tours. I think that is a bit lazy because rentals intended to be used on the bay is clearly an expansion of commercial activity on the bay, which is against the law.

As far as I can tell, Janell and Kamaaina Kids are doing the same business: individual kayak rentals on the bay. If we are to prevent one, then are we not bound to prevent all such businesses?

I am very interested in all opinions and possible solutions for this growing conflict that affects not just Kaneohe, but the entire state. I welcome this discussion.

Loren Lasher can see the bay from his front lanai. He's an avid kayaker, and began launching complaints when he saw Holokai bringing tourists into the water.

He said Kama'aina Kids overstepped its bounds by considering Holokai Snorkel and Kayak Adventures part of its educational nonprofit venture when he said it is clearly a commercial operation with round-trip transportation from Waikiki.


