We are Friends of Makaiwa Bay, together we enjoy swimming, diving and kayaking in the little bay regularly. We just heard about a request pending before BLNR within the last few days ago.

It is our understanding that DHL MAHI OPC, LLC has requested that BLNR grant them permission to add two additional private moorings to Makaiwa Bay. Other than the brief description on your agenda, we have been unable to find any detailed information as to where these moorings would be placed, what full time watercraft would be moored to them or the potential impact this might have on other existing water activities. There are already two "day moorings" and one private mooring in the immediate area and many residents and locals make use of this small bay for swimming, diving, snorkeling (see attached snorkel guide sign), fishing, kayaking, paddle boarding and surfing.

To better understand where these moorings would be placed, their intended operational use and to alleviate concerns over potential crowding issues we request an operating statement from the DHL MAHI OPC, LLC informing us of the reason, specific location and operational use which require the installation of these two additional private moorings. We feel that more information should be disclosed and the opportunity for community feedback should take place before BLNR grants this request. Please note that we are taking a neutral on stance the issue – we are simply concerned that there is a lack of specific information, consideration of possible impacts on the current use of this small bay, and the opportunity for community feedback to ensure a positive outcome for both DHL MAHI OPC, LLC and the community at large. We humbly request that you defer your final decision until this can occur.
