The Hawaii Cattlemen's Council would like to submit testimony in support of agenda item C2 to issue a revocable permit and immediate management right-of-entry permit to Bud Gibson for grazing purposes in the Waimanalo Forest Reserve.

Mr. Gibson has been stewarding his leases in the Waimanalo area for decades. We all understand that land that is not managed can lead to wildfire and catastrophic consequences. The land neighboring Mr. Gibson's lease in the Waimanalo Forest Reserve should be managed to keep wildfire fuel loads down for the safety of the community. Grazing is an effective tool for this, and this grazing permit will allow for the management of grasses within the forest reserve.

The Hawaii Cattlemen's Council (HCC) is the Statewide umbrella organization comprised of the four county-level Cattlemen's Associations. Our member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State. Ranchers are the stewards of over 750 thousand acres of land in Hawaii, or 20% of the State's total land mass. We represent the interests of Hawaii's cattle producers.
