If Alexander & Baldwin isn't able to fulfill their promise to a foreign company to secure public water, and has to pay back \$62 million by 2026, that is not your problem or the problem of the public.

The BLNR should give the voters of Maui County and the 'Aha Wai o Maui Hikina a fair chance at negotiating for the disposition of Maui Hikina's streams, before launching a contested case hearing over a potential water license to a foreign company. Entering into a contested case will prevent the County from having good faith negotiations with you.

Good Morning, I am Donna Clayton, President of Pukalani Community Association

I am speaking on item D4

The small town of Pukalani is located just above the lands of Mahi Pono – we are neighbors.

For years we have felt safe from fires with the well watered cane fields that were below us and the ditch.

When the cane fields shut down and the land returned to dry brush we were concerned and with good reason as mice and rats greatly increased, deer and pigs destroyed our yards and fire danger was ever present. After the Lahaina and Upcountry fires we moved from concerned to real fear of fire.

Mahi Pono has responded quickly to all of our community requests – installing pig and deer fencing, moving their fencing further downfield, keeping the ditch cleared out and brush along the ditch cut back, creating a larger firebreak and finally our last request after the fires was to mow and plant below Pukalani asap.

Mahi Pono is a good neighbor to Pukalani – they have cleared the land below us and planted some fields already. Pigs and deer are no longer in our yards and the high dry cane scrub below has been cleared.

When Mahi Pono was being considered as a new large landowner and asking for water, people doubted their ability to grow here. But as we learned they are planting and watering using carefully applied water to each plant utilizing computer tech and not wasting water but also successfully growing field after field of beautiful plants of many kinds.

I retired from Maui Land & Pineapple Company and have real awareness of how difficult farming is and how farmers, large or small, survive on being able to count on water. They can't control the weather, the markets, and many other things but knowing they have water they can rely on gives them the security to go forward with the constant repairs and upgrades needed to survive in farming – all farming is tough but this size is formidable. Year to year water concerns don't allow for confidence to move forward.

Mahi Pono has shown they are good stewards of water, good neighbors to surrounding communities, successful growers and they hire local folks in all the numerous types of work required for large operations – field workers, mechanics, scientists, office workers, marketing staff. Just like Maui Land & Pineapple Company they provide interesting work for local folks and a nice lifestyle for their employees. I feel Mahi Pono has been tested and proven worthy of our trust. They support our communities, cover our scrub lands with real crops and provide work for local folks so they can stay on Maui.

I ask for the state to please move forward with a long-term lease agreement so Mahi Pono has the security to move ahead on substantial upgrades to the water system to make it more efficient. They are unable to take on that big expense without the security of a long-term water lease.

I am a scientist who studies water resources and a member of the Board of Water Supply for the County of Maui representing only myself and I **urge you act to transfer the East Maui** watershed leases to the East Maui Regional Water Authority.

Maui's water supply is provided by the Maui Department of Water Supply (MDWS) and a collection of commercial water companies resulting in the narrow, stove-piped, optimization of County and corporate self-interests in providing water for their respective customers. No organization has central responsibility, or accountability, for island-wide or regional water resources across Maui.

Due to this vacuum in leadership, we face avoidable problems ranging from over-pumping of groundwater, diminishing streamflow, lack of maintenance for ancient conveyances and the use of unjustifiable regulatory criteria for permitting.

Consequently, for example, CWRM has had to take exceptional regulatory action in Maui's westside, through designation, to address the same kind of deteriorating water quality issues that occurred in Iao Valley 25 years ago. Yet, paradoxically, and with obvious conflict of interest, it is the County of Maui with responsibility for the Water Use and Development Plan but without authority to oversee compliance.

Now, the East Maui Regional Water Authority offers a major opportunity to improve this situation and enable the joint management, with MDWS, of shared resources for a part of the Island of Maui while building a new generation of capable water managers. This is the first time in more than 150 years that such an opportunity presents itself.

This exemplary and necessary step in the direction of integrated water resource management for the Island of Maui assuredly will put a public trust resource in public hands.

Members of BLNR Chair Chang, my name is Joyclynn Costa. I am a known descendant of the Ko'olau Moku, island of Maui. Decisions made on this item will directly impact my life, my daughters' life, and my mo'opuna lives. It will also injure the spiritual connection my 88 year old father James Kauihou Sagawinit will have to endure if this consideration of taking becomes a reality. We just participated in the Maui Water Plan which is wanting to take surface water to satisfy the insatiable appetite for growth. The charts showed an upward projection for development on Maui while the rainfall chartered a continued pattern of decline. After the Water Commission had done their work it was found the water needed to go back into the streams. After 131 years of dewatering it is still an epidemic of unmeasurable proportions. The village of Nahiku not only suffered from the lack of water but also the blatant disregard for safety and health. While the streams were filled with what we call black water and mosquito larvae, the east end of Maui had an outbreak of Dengue fever that started in Lower Nahiku. Request was made to open the gates and flush out the streams but it fell on deaf ears from both your department and the DOH. Since the decision to restore stream flow there has been witnessed the Makapipi river bone dry only to have the water restored on days of inspection. If the process of restoration has not been completed and our rainfall historically and currently is decreasing it would be irresponsible and cause irreparable harm to both body and mental well-being. I would also point out in the State Water Code 174C (D) this taking will diminish and on days extinguish the source that is a right for kanaka maoli of Nahiku and all of the east waterways. I oppose any more taking. I believe there is a well 7 that is being banked and needs to be calculated for its provisions of current and future corps before any further discussion of taking from the east source. I pray you do not choose to violate and harm my well-being, life, and spirit which is the blood source for the land. Kill the land, you kill the people. That water (blood) will be on your hands.
