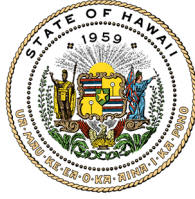

Comments: The Board rejected the final EIS, finding that it did not comply with applicable law and did not adequately disclose the impact of the proposed action, and the following additional findings of deficiencies:

- Ka Pa'a Kai analysis and its relevance to the document;
- Codified consultant log;
- Complete biological opinion;
- Accurate weapon, UXO, uranium inventory acceptable to the Board and staff;
- Complete greenhouse gas emission data inventory;
- Cumulative analysis of such impacts;
- Detailed inventory of disposition and future disposition of iwi kupuna and moepu;
- Clarify whether Section 106 is required or not required by law;
- Justification of why area of influence is narrowed or restricted, and if not, the area should be studied appropriately;
- More serious consideration of Alternative 4;
- Use of lands in conservation district.
