REQUEST:

The Division of Boating and Ocean Recreation ("DOBOR") is seeking authorization from the Board of Land and Natural Resources (Board) to offer the sale of a ten-year concession contract by sealed bid for retail operation of an automated ice machine.

LOCATION:

Portion of Government lands situated at Honokohau Small Boat Harbor, Kealakehe, North Kona, Hawaii, Tax Map Key: (3) 7-4-008:003 (por.).as shown on **Exhibit A**, attached hereto.

AREA:

442 square feet, more or less.

Minimum upset rent of \$470.00 per month or 15% of gross receipt sales, whichever is greater.

CHAPTER 343 – ENVIRONMENTAL ASSESSMENT:

In accordance with Section 11-200.1-15, Hawai'i Administrative Rules (HAR) and the Exemption List for the Department of Land and Natural Resources, reviewed and concurred by the Environmental Council on November 10, 2020, the subject request is exempt from the preparation of an Environmental Assessment pursuant to General Exemption Type 1, "Operations, repairs or maintenance of existing structures, facilities, equipment, or topographical features, involving minor expansion or minor change of use beyond that previously existing," Part 1, Item No. 40, which states, "Leases of State Land involving negligible or no expansion or change of use beyond that previously existing."

REMARKS:

At its meeting on October 28, 2022, under agenda item J-2, the Board approved the issuance of a revocable permit ("RP") to Riddle Works LLC for an ice machine, located at Honokohau Small Boat Harbor, Kealahou, North Kona, Hawaii, Tax Map Key: (3) 7-4-008:003 (por.). Staff recommended the issuance of the RP with the understanding that if the use proved viable, it would ask the Board to convert it to a long-term disposition – in this case a concession. The permittee was advised of this from the beginning and agreed to proceed.

During initial planning it was found that the selected location would not be viable, so Staff found a more suitable location for the ice machine.

At its meeting on February 23, 2024, under agenda item J-8, the Board approved the cancellation of Revocable Permit No. 137 to Riddle Works LLC; request for waiver of requirement for conducting Phase I environmental site assessment upon cancellation of Revocable Permit No. 137; issuance of a new Revocable Permit to Riddle Works LLC for

an ice machine, located at the Honokohau Small Boat Harbor, Kealahou, North Kona, Hawaii, Tax Map Key: (3) 7-4-008:003 (por.) to reflect the new location.

At its meeting on June 28, 2024, under agenda item J-1, staff requested the continuation of revocable permits statewide which includes Riddle Works LLC.

The Board has instructed staff to convert revocable permits to long-term dispositions, where practicable. To this end, DOBOR is requesting the Board's approval for the sale of a ten-year concession contract by sealed bid for retail operation of an automated ice machine purposes at the Honokohau Small Boat Harbor.

RECOMMENDATION:

That the Board of Land and Natural Resources:

1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200.1, Hawai'i Administrative Rules, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
2. Authorize the sale of a ten-year concession contract by sealed bid for retail operation of an automated ice machine purposes under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
 - a. The standard terms and conditions of the most current concession contract as may be amended from time to time;
 - b. Review and approval by the Department of the Attorney General; and
 - c. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.

Honokohau Small Boat Harbor, Hawaii Island

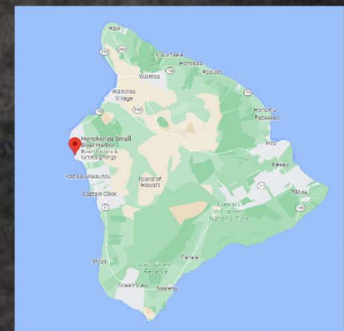


Exhibit A-2

The applicant must ensure there is a sufficient amount of room for vehicles to pull over to the side of the road and not obstruct any flow of traffic.

Staff recommends the Board approve to issuance of a revocable permit to Riddle Works LLC for the use of state lands for the purpose of operating an ice machine. The applicant has not had a lease, permit, easement, or other disposition of State lands terminated within the last five years due to non-compliance with such terms and conditions.



Honokohau Small Boat Harbor

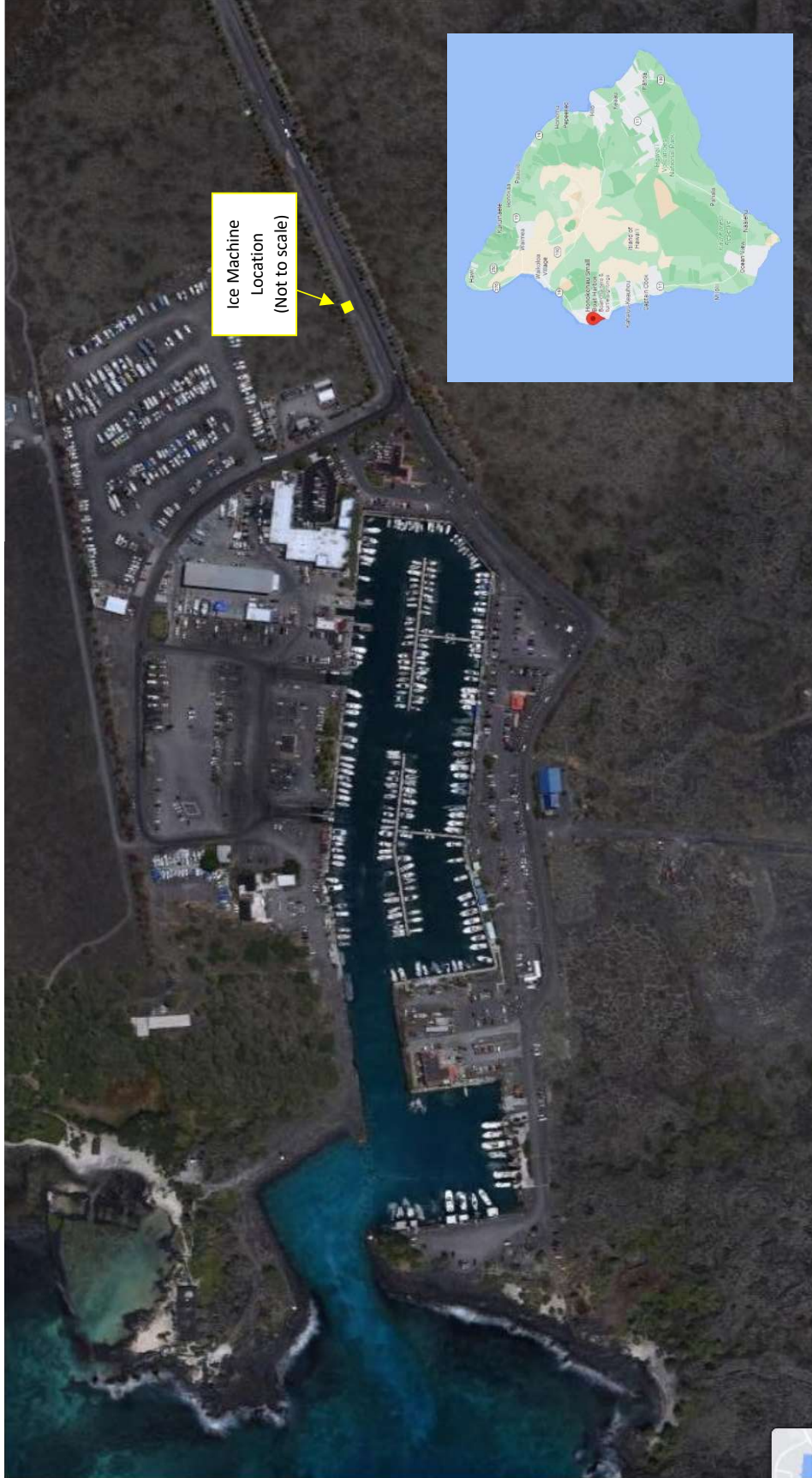


Exhibit A-2



Honokohau Small Boat Harbor, Hawaii Island

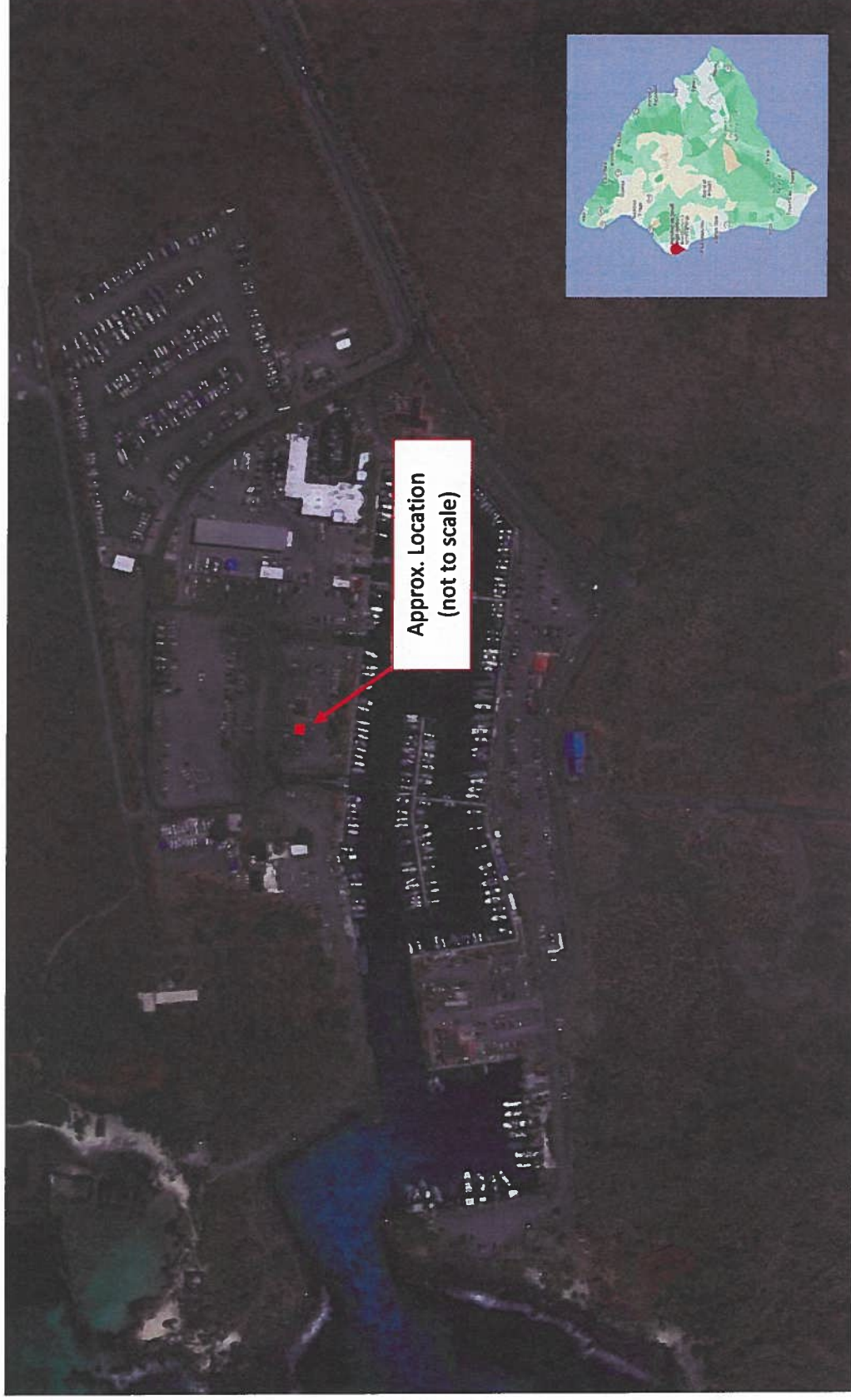

Honokohau Small Boat Harbor, Hawaii Island

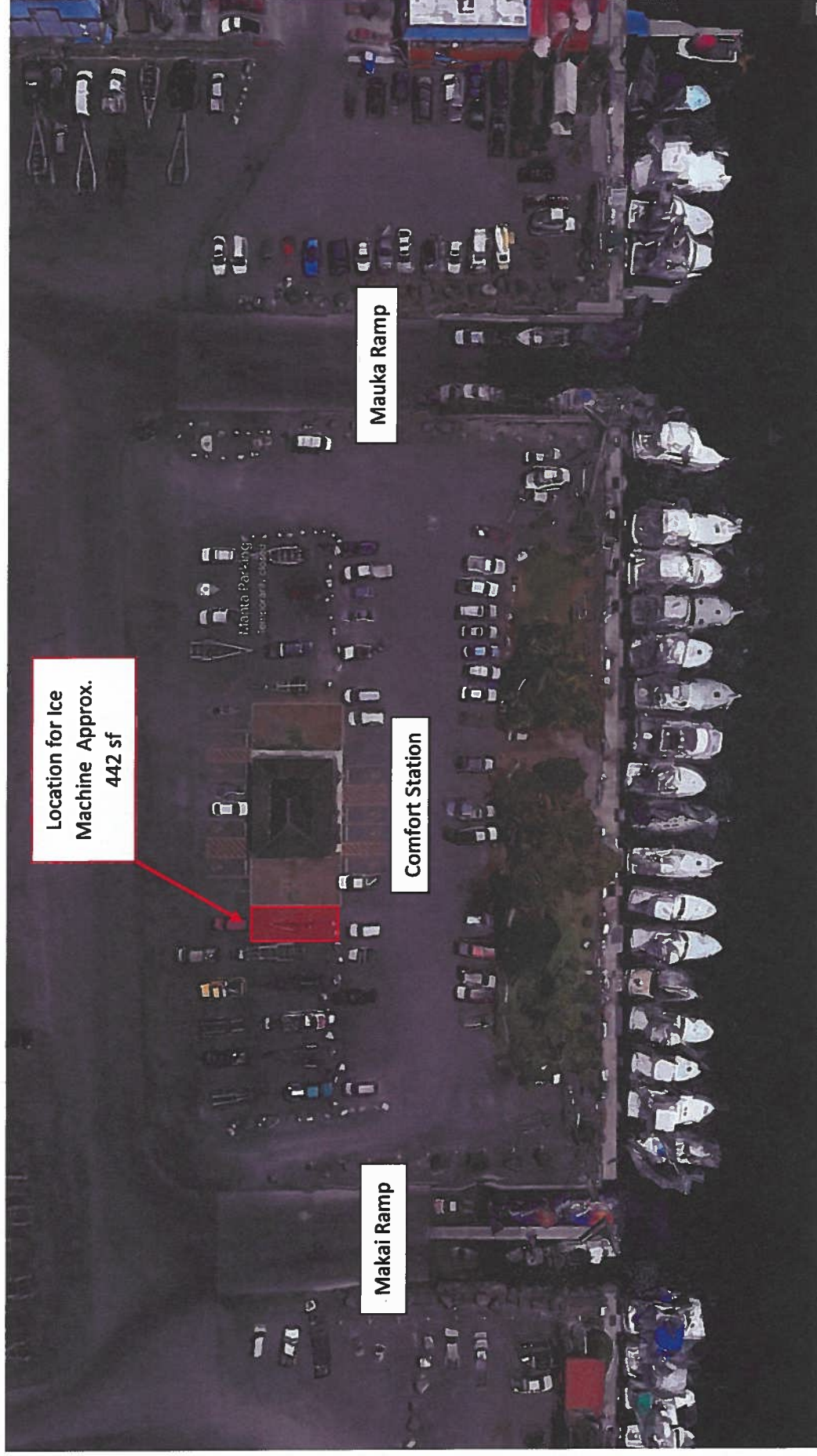

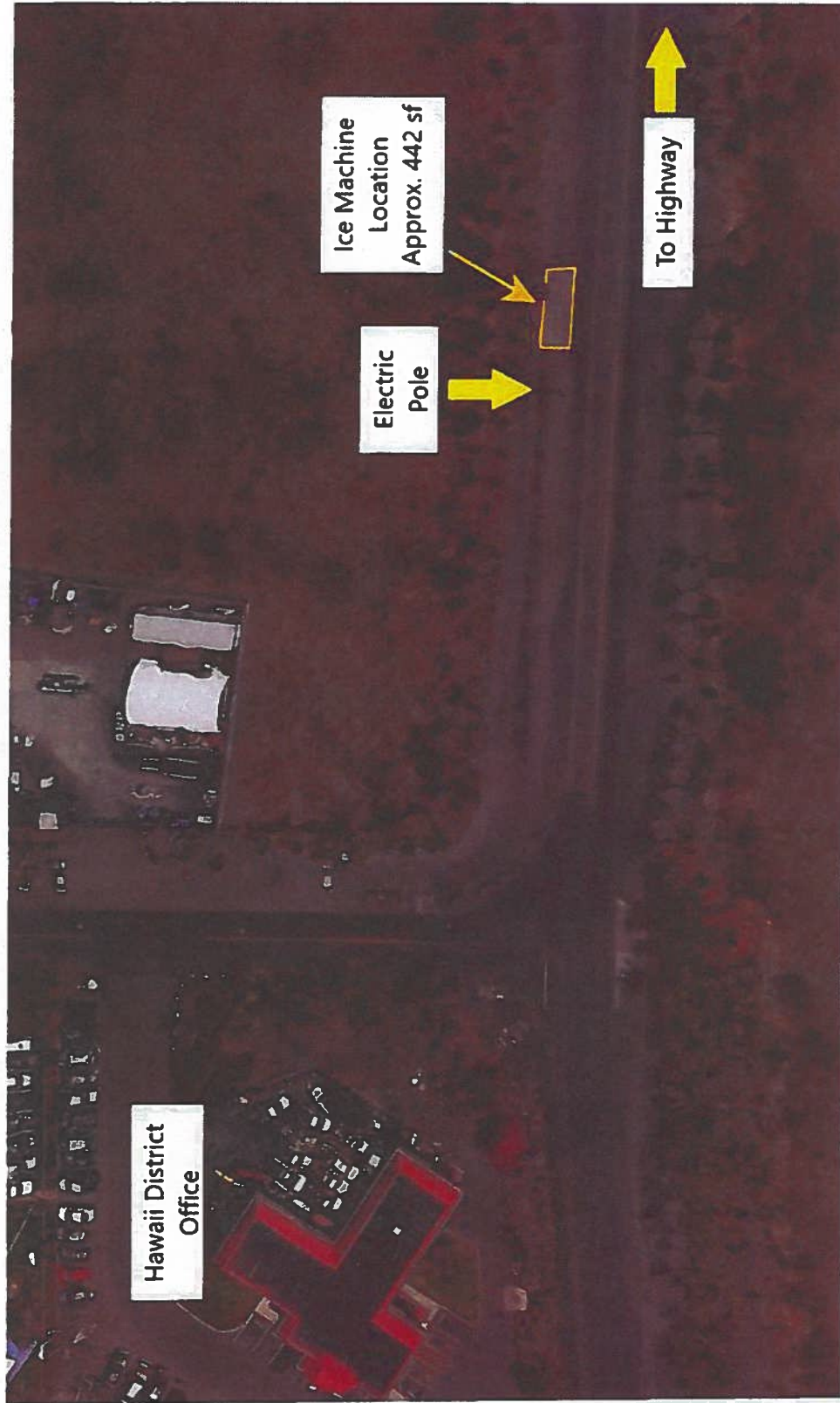
