Declare Project Exempt from Requirements of Chapter 343 Hawai'i Revised Statutes and Title 11, Chapter 200.1, Hawai'i Administrative

Rules.

REQUEST:

The Division of Boating and Ocean Recreation ("DOBOR") is seeking authorization from the Board of Land and Natural Resources (Board) to offer the sale of a ten-year concession contract by sealed bid for the purpose of retail operation of an automated ice machine.

LOCATION:

Portion of Government lands situated at Kahului Boat Ramp, Wailuku, Pūʻali Komohana, Island of Maui, Tax Map Key: (2) 3-7-001-023 (por.), as shown on **Exhibit A**, attached hereto.

AREA:

200 square feet, more or less.

ZONING:

State Land Use District: Conservation, Urban

County of Maui Zoning: Not Zoned (Conservation), R-2 (Urban)

TRUST LAND STATUS:

Section 5(b) lands of the Hawai'i Admission Act DHHL 30% entitlement lands pursuant to the Hawai'i State Constitution: No

CURRENT USE STATUS:

Under Revocable Permit No. 118 for the retail operation of an automated ice machine.

CHARACTER OF USE:

Retail operation of an automated ice machine.

MONTHLY RENTAL:

Minimum upset rent of \$305.00 per month or 15% of gross receipt sales, whichever is greater.

CHAPTER 343 – ENVIRONMENTAL ASSESSMENT:

In accordance with Section 11-200.1-15, Hawai'i Administrative Rules (HAR) and the Exemption List for the Department of Land and Natural Resources, reviewed and concurred by the Environmental Council on November 10, 2020, the subject request is exempt from the preparation of an Environmental Assessment pursuant to General Exemption Type 1, "Operations, repairs or maintenance of existing structures, facilities, equipment, or topographical features, involving minor expansion or minor change of use beyond that previously existing," Part 1, Item No. 40, which states, "Leases of State Land involving negligible or no expansion or change of use beyond that previously existing."

REMARKS:

At its meeting on August 13, 2021, the Board approved the issuance of a Revocable Permit to Island Ice and Water Company LLC, for a retail operation of an automated ice machine, located at the Kahului Boat Ramp, Kahului, Hawaii, Tax Map Key: (2) 3-7-001:023 (por.). The permit has been renewed every year since then with a 3% increase in rent per year.

The Board has instructed staff to convert revocable permits to long-term dispositions, where practicable. To this end, DOBOR is seeking authorization for the sale of a ten-year concession contract by sealed bid to operate a retail operation of an automated ice machine at the Kahului Boat Ramp.

RECOMMENDATION:

That the Board of Land and Natural Resources:

- Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200.1, Hawai'i Administrative Rules, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
- 2. Authorize the sale of a ten-year concession contract by sealed bid for retail operation of an automated ice machine under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
 - a. The standard terms and conditions of the most current concession contract as may be amended from time to time;
 - b. Review and approval by the Department of the Attorney General; and
 - c. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.

Revocable Permit No. 12 issued to Island Ice Company L.L.C. through June 30, 2021.

CHARACTER OF USE:

Occupy and use the Premises for the following specified purposes only: Retail Operation of an Automated Ice Machine.

COMMENCEMENT DATE:

The revocable permits will commence on July 1, 2021, and end on June 30, 2022.

MONTHLY RENTAL:

Two Hundred Seventy Four and 47/100 dollars (\$274.47) per month.

COLLATERAL SECURITY DEPOSIT:

Twice the monthly rental.

CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

In accordance with Section 11-200.1-15, Hawaii Administrative Rules (HAR) and the Exemption List for the Department of Land and Natural Resources, reviewed and concurred in by the Environmental Council on March 3, 2020, the subject request is exempt from the preparation of an Environmental Assessment pursuant to Exemption Class No. 1, Item No. 44, that states, "Permits, licenses, registrations, and rights-of-entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing."

JUSTIFICATION FOR REVOCABLE PERMIT:

The issuance of the revocable permit is temporary in nature, until staff is able to complete an IFB for a concession to sell ice at this location.

REMARKS:

Revocable Permit No.12 was issued to Island Ice Company L.L.C. ("Island Ice") in 2010 for the retail operation of an automated ice machine at the Kahului Boat Ramp. The permit ended June 30, 2021, and staff did not seek to renew it.

Island Ice's owner has formed a new LLC, Island Ice and Water Company LLC, and would like the permit issued in the new entity's name.

Staff requests the Board's approval to issue a revocable permit to Island Ice and Water Company LLC at the same monthly rental of the cancelled one.

RECOMMENDATION:

That the Board of Land and Natural Resources:

- 1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200.1, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
- Authorize the issuance of a Revocable Permit to Island Ice and Water Company LLC, at Kahului Boat Ramp under the terms and conditions cited above, which are by this reference, incorporated herein and further subject to the following:
 - a. The standard terms and conditions of the most current Revocable Permit form, as may be amended from time to time; and
 - b. Review and approval by the Department of the Attorney General.
 - c. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.


