Issuance of Right-of-Entry Permit for Five (5) Days to Oahu Hawaiian Canoe Racing Association Hawaii for the Duke Kahanamoku Men's Long Distance Canoe Race to Take Place on One Day Each Year in August 2025, 2026, 2027, 2028, and 2029, at Waikiki, Honolulu, Oahu, Tax Map Key: (1) 2-3-037: portion of 021.

#### **APPLICANT:**

Oahu Hawaiian Canoe Racing Association Hawaii (OHCRA), a Hawaii 501(c)(3) nonprofit corporation.

#### **LEGAL REFERENCE:**

Section 171-55, Hawaii Revised Statutes (HRS), as amended.

#### LOCATION:

Portion of Government lands of Waikiki, Honolulu, Oahu, identified as tax map key: (1) 2-3-037: portions of 021, as shown on the attached **Exhibit A.**

#### CHARACTER OF USE:

Finish area for Duke Kahanamoku Men's Long Distance Canoe Race.

#### TERM:

From 6:00 AM to 4:00 PM on the following dates: August 17, 2025; August 16, 2026; August 22, 2027; August 20, 2028; and August 19, 2029.

#### RENTAL:

\$300.00 for each year's request (based on 10¢ per square foot).<sup>2</sup>

CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

In accordance with Hawaii Administrative Rules (HAR) §§11-200.1-15 and -16 and the Exemption List for the Department of Land and Natural Resources, reviewed and concurred on by the Environmental Council on November 10, 2020, the subject request is exempt from the preparation of an Environmental Assessment pursuant to General Exemption Type 1, which applies to "[o]perations, repairs or maintenance of existing structures, facilities, equipment, or topographical features,

involving minor expansion or minor change of use beyond that previously existing." Specifically, the subject request is exempt under Part 1, Item 44, which exempts "[p]ermits, licenses, registrations, and rights-of-entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing." The subject request is a de minimis action that is expected to have minimal or no significant effect on the environment and should be declared exempt from the preparation of an environmental assessment.

#### REMARKS:

The Oahu Hawaiian Canoe Racing Association Hawaii (OHCRA) is requesting a right-of-entry permit to conduct beach activities on State-owned lands in conjunction with the annual Duke Kahanamoku Men's Long Distance Canoe Race.

OHCRA is a 501(c)(3) non-profit organization dedicated to perpetuating the sport of Hawaiian Koa canoe racing. OHCRA's principal purposes, as stated on the organization's website, are to:

- Engage in, promote, encourage participation in and provide education and instruction in Hawaiian culture through canoeing and other related activities on a local, national, and international level.
- Encourage, maintain and perpetuate authentic Hawaiian canoe racing and preservation of Hawaiian Koa canoes; and to teach and preserve the art and culture of Hawaiian canoe racing.
- Promote competitive inter-club, inter-island, and international Hawaiian canoe racing.

The Duke Kahanamoku Long Distance Canoe Race has been held annually since August 24, 1968, when it was founded as a tribute to legendary waterman and Olympian, Duke Kahanamoku. Over the years, the racecourse has changed, but it has consistently been located between Kailua Beach and Waikiki. A women's race, which takes place on a separate day and entirely within Kailua Bay, was instituted in 1979. Since 1995, the men's race has launched from Kailua and has followed a 28-mile course that finishes at Duke Kahanamoku Beach near the Hilton Hawaiian Village in Waikiki.

The Duke Kahanamoku men's race will adhere to the same schedule in all years from 2025 through 2029. Set up at the Waikiki finish site will begin at approximately 6:00 AM. The race starts at Kailua Beach at 9:00 AM. Participating crews are expected to complete the race and arrive at the finish line in Waikiki

between 12:00 and 2:00 PM. Once the canoe race is completed, specified areas of the beach will be used for an awards ceremony and closing events. The Applicant states that activities and clean-up of the site will be completed by 4:00 PM.

The Applicant requests that the Board approve a right-of-entry permit for its use of two specified areas of the subject beach that are subject to Land Division shoreline permit requirements. Therefore, this right-of-entry permit request includes the portions of the beach identified on **Exhibit B** as Areas 1 and 3.

Area 1 is located on the sandy beach mauka of the Hilton Pier. This area will contain a  $60^{\circ}$  x  $20^{\circ}$  tent which will house the race finish area, awards ceremony, webcast, and hospitality areas.

Area 3 is located on the sandy beach Ewa of Area 1, near the Hilton helipad and parking area. Area 3 measures approximately 60' by 30' and will be used for canoe landing and de-rigging. Canoes will be moved from Area 3 to the Hilton helipad and parking lot location, discussed below, where they will be loaded onto canoe trailers for orderly departure from the site.

Area 2, as identified on **Exhibit B**, is the Hilton Hawaiian Village Pier, which is currently encumbered by Revocable Permit No. 7566, held by the Hilton Hawaiian Village (HHV) hotel. The in-water race finish line is located adjacent to the pier. Staff has confirmed with the Applicant and representatives of HHV that the Applicant has requested and will be granted access to the pier by HHV as the holder of the revocable permit. Revocable Permit No. 7566 requires a \$1.50 toll fee per paying customer. However, HHV has historically provided use of the pier for this event at no charge to OHCRA and will do the same for the present application. Therefore, staff is of the opinion that HHV will not be required to pay the State for the toll fee.

The area identified as the Parking Lot/ Helipad Area on **Exhibit B** is the Hilton helipad and designated recreational parking area at the Ala Wai Small Boat Harbor, subject to the jurisdiction of the Division of Boating and Ocean Recreation (DOBOR). Therefore, this area is not included in the present right-of-entry application. Staff understands that the Applicant is pursing the applicable permits for use of the Parking Lot/ Helipad Area, as well as a Marine Ocean Water Event permit, through DOBOR.

Staff notes that the Applicant is pursuing permits for the Kailua Beach Park launch site through the City & County of Honolulu's Parks and Recreation Division and that all activities at that site will fall under the jurisdiction of the City & County. Staff has informed the Applicant that it is the Applicant's responsibility to procure all required permits for the Kailua Beach Park launch site.

The Applicant shall not engage in any commercial activity including merchandise sales or the placement of preset, reserved seating under the present shoreline permit application.

The subject request pertains to the same race occurring annually over a five-year period, with the dates described in the TERM section, above. The Board has previously granted five-year permit requests to this Applicant for this event, as well as for the Molokai Hoe and Na Wahine O Ke Kai canoe races. The Applicant has a proven record of compliance with permit terms, maintenance of public shoreline access during its various events, and stewardship of public land. As such, staff has no objections to the grant of a similar five-year permit pursuant to the present application.

The Office of Conservation and Coastal Lands (OCCL) has reviewed a draft of this submittal. OCCL has no objections to the proposed land use and concurs with the recommended Environmental Assessment exemption.

The Applicant has not had a lease, permit, easement, or other disposition of State lands terminated within the past five years due to non-compliance with such terms and conditions.

There are no other pertinent issues or concerns regarding the subject request.

#### **RECOMMENDATION**: That the Board

- 1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200.1, HAR, this activity is a de minimis action that will likely have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
- 2. Authorize the issuance of a right-of-entry permit to Oahu Hawaiian Canoe Racing Association Hawaii covering the subject area for the Duke Kahanamoku Men's Canoe Race under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
  - a. Payment of the rental amount stated above;
  - b. The standard terms and conditions of the most current right-of-entry form, as may be amended from time to time;
  - c. The Applicant shall conduct no sales or other commercial activities in the areas subject to this right-of-entry;
  - d. The Applicant shall maintain lateral public access across the beach

transit corridor for the entire period of the right-of-entry permit; and

e. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.


## TAX MAP KEY: (1) 2-3-037: PORTION OF 21
