## CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

In accordance with Hawaii Administrative Rules (HAR) § 11-200.1-15 and the Exemption List for the Department of Land and Natural Resources reviewed and concurred on by the Environmental Council on November 10, 2020, the subject request is exempt from the preparation of an environmental assessment pursuant to General Exemption Type 1 that states, "Operations, repairs or maintenance of existing structures, facilities, equipment, or topographical features, involving minor expansion or minor change of use beyond that previously existing," and Part 1, Item 44 that states, "Permits, licenses, registrations, and rights-of-entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing.". ## **PUBLIC TRUST ANALYSIS**

The proposed use is temporary and the events are open to the public. Additionally, no commercial activity will occur on the public beach area. Given the limited duration and scope of the events, staff believes that the requested dispositions would not measurably impair the use of the public beach area and is consistent with the public trust.

## **REMARKS**:

Hawaii Beach Volleyball Association (HBVA) is requesting a right-of-entry permit for 5 separate volleyball tournaments. Duke's Kauai Invitational, Kauai Beach Volleyball AAU Fall Festival, Kauai Beach Volleyball College Invitational, Kauai Beach Volleyball BVCA National Qualifier and Kauai Beach Volleyball AAU Christmas Classic all from 7:00 am to 6:00 pm. Setup will begin at 7:00 am and breakdown will be completed by 6:00 pm daily. Two 10' x 10' tents will be set up on adjoining private land for the duration of the permit.

HBVA states that no tents or spectator seating will be placed on the beach/State land by event coordinators. The tents and chairs will be placed on the Royal Sonesta Kaua'i Resort's grounds.

Staff notes that HBVA did not submit its right of entry request until August 14, 2025, making this meeting the earliest opportunity for staff to bring this matter before the Board for decisions making. Therefore, due to the event dates, staff is requesting that the right of entry for the first event be approved on an after the fact basis.

Applicant has not had a lease, permit, easement or other disposition of State lands terminated within the past five years due to non-compliance with such terms and conditions.

The proposed activity is of a similar type and scope of beach activities that routinely has occurred and continues be held on this and other beaches across the State. Such activities have resulted in no known significant impacts, whether immediate or cumulative, to the natural, environmental and/or cultural resources in the area. As such staff believes that the proposed event would involve negligible or no expansion or change in use of the subject area beyond that previously existing.

## RECOMMENDATION: That the Board

- 1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200.1, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
- 2. For the reasons stated herein, find that the requested disposition is consistent with the public trust.
- 3. Authorize after the fact the issuance of a right-of-entry permit to Hawaii Beach Volleyball Association for Duke's Kauai Invitational, on September 12-13, 2025, Kalapaki Beach, Lihue, Kauai at Kalapaki Beach, Lihue, Kauai, Tax Map Key: (4) 3-5-002: seaward of 002.
- 4. Authorize the issuance of four right-of-entry permits to Hawaii Beach Volleyball Association covering the subject area for the Kauai Beach Volleyball AAU Fall Festival, Kauai Beach Volleyball College Invitational, Kauai Beach Volleyball BVCA National Qualifier and Kauai Beach Volleyball AAU Christmas Classic, on the dates and under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
  - A. The standard terms and conditions of the most current right-of-entry permit form, as may be amended from time to time; and
  - B. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.



Cumulative Impact of Planned Successive Actions in Same Place Significant?:

No. The temporary use of the land for beach recreation activities such as volleyball will not result in any significant cumulative impact. The proposed use is similar to uses by the general public that occur on a regular basis.

Action May Have Significant Impact on Particularly Sensitive Environment?:

No. There are no sensitive environmental issues involved with the proposed use of the property. Additionally, the activity is similar in type to other recreational activities that occur on beaches on a regular basis, resulting in no significant impacts.

**Analysis:** 

In the past, permits were issued for similar types of events on the beach in the area, which have resulted in no known significant impacts to the natural and environmental resources in the area. As such, staff believes that the proposed event would involve negligible or no expansion or change in use of the subject area beyond that previously existing.

**Consulted Parties:** 

Office of Conservation and Coastal Lands, Kauai County Public Works Department, and Royal Sonesta Kauai Resort.

**Recommendation:** 

That the Board find this project will probably have minimal or no significant effect on the environment and is presumed to be exempt from the preparation of an environmental assessment.
